#### Item 1.01 Entry into a Material Definitive Agreement.

On October 30, 2006, Uranerz Energy Corporation (the Company) entered into an agreement with George Hartman to use certain geological reports held by Mr. Hartman for the purposes of staking and acquiring potential areas of interest. Under the terms of the agreement, the Company agreed to pay Mr. Hartman the sum of \$0.40 for each measured and indicated pound of uranium staked by the Company and a fee of \$750 for each claim registered with the Bureau of Land Management, based on the use of the geological reports. This fee is payable to Mr. Hartman in shares of common stock of the Company.

In connection with the issuance of the shares, the Company agreed to grant Mr. Hartman registration rights for the resale of such shares and to obtain listing approval and other regulatory approval in connection with the issuance of such shares.

Mr. Hartman is a Director and Officer of Uranerz Energy Corporation.
