Due to a limitation in the filing software, the total number of shares of Common Stock received was 2,651 as reported above in Table I.

- (7) The conversion rate of the Performance-based Restricted Stock was 77.267%. Upon conversion of the RSUs, the Reporting Person received 2,398 shares of Common Stock. Upon conversion of \$6,331 in dividend equivalents, the Reporting person received an additional 253 shares of Common Stock.
