On April 28, 2008, the reporting person continued to be associated with the Issuer, resulting in the vesting and issuance of another 5,250 shares of Common Stock so earned. On April 28, 2009, the reporting person continued to be associated with the Issuer, resulting in the vesting and issuance of another 5,250 shares of Common Stock so earned. On April 27, 2010, the reporting person continued to be associated with the Issuer, resulting in the vesting and issuance of the remaining 5,250 shares of Common Stock so earned.
