Below is a summary of an immediate report by InterCure Ltd. ("InterCure") that was published on the Tel-Aviv Stock Exchange Ltd. according to the Israeli Security Regulations.

Re: Immediate Report

On July 22, 2013, InterCure published an immediate report announcing that they had entered into a blind trust agreement to sell shares of XTL Biopharmaceuticals Ltd. ("XTL") held by InterCure. On November 24, 2013, InterCure published an immediate report announcing that InterCure's board of directors' resolved on November 21, 2013, to instruct the trustee to delay the sale of any more of such shares until further notice.

According to InterCure's immediate report, the resolution was based, among other things, upon InterCure's current cash balances and its estimates regarding future cash flow.

InterCure further announced it will assess, from time to time, its policy regarding the sale of XTL shares held by InterCure.

The statements regarding InterCure's estimated future cash flow may constitute forward-looking information by InterCure, as that term is defined under the Israeli Securities Law – 1968. These estimates may not occur, in part or their entirety, or occur in a materially different manner than projected by InterCure, due to various factors, including such factors as are out of InterCure's control.
