(1) There is no reportable change since the last filing. This is a reiteration of holdings only.

As previously reported, on 01/15/09 the reporting person was granted 26,250 restricted stock units ("RSUs"), 13,125 of which vested on 01/15/10, and 13,125 of which will vest on 01/15/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned in column 9 includes 40.2453 dividend equivalent rights at \$52.18 per RSU credited to the reporting person's account on 01/06/10, and a de minimus adjustment of .4914 due to fractional rounding of the dividend equivalent rights.

The 34.4592 dividend equivalent rights being reported reflect 34.4592 dividend equivalent rights at \$52.18 per RSU credited to the Reporting Person's account on 01/06/10.
