- (1) There is no reportable change since the last filing. This is a reiteration of holdings only.
- (2) Each restricted stock unit represents a contingent right to receive one share of HP common stock.
- (3) As previously reported, on 01/15/09 the reporting person was granted 10,940 restricted stock units ("RSUs"), 5,470 of which vested on 01/15/10, and 5,470 of which will vest on 01/15/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned in column 9 includes 16.7727 dividend equivalent rights at \$52.18 per RSU credited to the reporting person's account on 01/06/10, and a de minimus adjustment of .1853 due to fractional

rounding of the dividend equivalent rights.

- (4) As previously reported, on 12/10/09 the Reporting Person was granted 9,030 restricted stock units ("RSUs"), 4,515 of which will vest on 12/10/10 and 12/10/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 13.8444 dividend equivalent rights being reported reflect 13.8444 dividend equivalent rights at \$52.18 per RSU credited to the Reporting Person's account on 01/06/10.
