- (1) There is no reportable change since the last filing. This is a reiteration of holdings only.

Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 122,224 dividend equivalent rights being reported reflect 22,495 dividend equivalent rights at \$36.20 per RSU credited to the Reporting Person's account on 07/06/11; 34,129 dividend equivalent rights at \$23.86 per RSU credited to the Reporting Person's account on 10/05/11; 30,590 dividend equivalent rights at \$26.62 per RSU credited to the Reporting Person's account on 01/04/12; and 35,009 dividend equivalent rights at \$23.26 per RSU credited to the Reporting Person's account on 04/04/12.
