The Relative Performance Call Warrants Expiring April 17, 2009, which we refer to as the warrants, are cash-settled call warrants linked to the relative performance of the S&P 500<sup>®</sup> Index versus the Russell 2000<sup>®</sup> Index. Upon your exercise of the warrants or the automatic exercise of the warrants, if the S&P 500 has outperformed the Russell 2000 from the pricing date to the applicable exercise date, regardless of whether the S&P 500 has gone up or down in value from its value on the pricing date, you will receive a cash payment with respect to each warrant exercised, which we refer to as the cash settlement value.

The maximum initial offering price for each warrant will be determined on the pricing date and is expected to be between \$6.00 and \$6.50.

The cash settlement value for each warrant will equal the greater of (i) \$0 and (ii) the amount, if any, by which the S&P 500 exercise value is greater than the Russell 2000 exercise value, which is also the strike level for the warrants. The S&P 500 exercise value and the Russell 2000 exercise value will be determined on the applicable valuation date and, in each case, will equal the reference level of the respective index on the applicable valuation date times the multiplier for that index. The S&P 500 multiplier will equal \$75.00 divided by the closing level of the S&P 500 on the pricing date, and the Russell 2000 multiplier will equal \$75.00 divided by the closing level of the Russell 2000 on the pricing date.

The expiration date for the warrants is April 17, 2009. Warrants not previously exercised will be automatically exercised on the expiration date.

The warrants will be exercisable on any trading day beginning on April 1, 2007 and ending on April 14, 2009. We intend to apply to list the warrants on the American Stock Exchange, subject to meeting listing requirements. The proposed symbol on the AMEX for the warrants is expected to be RWP.WS. The CUSIP number for the warrants is 929903128.

For a detailed description of the terms of the warrants, see Summary beginning on page S-1 and Specific Terms of the Warrants beginning on page S-18.

This summary includes questions and answers that highlight selected information from this pricing supplement to help you understand the Relative Performance Call Warrants Expiring April 17, 2009, which we refer to as the warrants. This summary is qualified in its entirety by the more detailed information appearing elsewhere in this pricing supplement and the prospectus and in the documents incorporated herein and therein by reference. You should carefully read this pricing supplement and the prospectus to fully understand the terms of the warrants, the S&P 500® Index and the Russell 2000® Index (which we refer to as the S&P 500 and the Russell 2000, each generally an index, and collectively, the indices), and the tax and other considerations that are important to you in making a decision about whether to invest in the warrants. You should carefully review the section Risk Factors in this pricing supplement, which highlights certain risks associated with an investment in the warrants, to determine whether an investment in the warrants is appropriate for you.

*Unless otherwise mentioned or unless the context requires otherwise, all references in this pricing supplement to Wachovia, we, us and our or similar references mean Wachovia Corporation and its subsidiaries. Unless otherwise mentioned or unless the context requires otherwise, all references to WBNA mean Wachovia Bank, National Association. Wachovia Capital Markets, LLC is an indirect, wholly owned subsidiary of Wachovia Corporation. Wachovia Corporation conducts its investment banking, capital markets and retail brokerage activities through its various broker-dealer, bank and non-bank subsidiaries, including Wachovia Capital Markets, LLC, under the trade name Wachovia Securities. Any reference to Wachovia Securities in this pricing supplement does not, however, refer to Wachovia Securities, LLC, a member of the New York Stock Exchange and the Securities Investor Protection Corporation, to Wachovia Securities Financial Network, LLC, a member of the National Association of Securities Dealers, Inc. and the Securities Investor Protection Corporation, or to broker-dealer affiliates of Wachovia Corporation and Wachovia Capital Markets, LLC.*

**What are the warrants?**

The warrants are relative performance call warrants. In general, a traditional index call warrant entitles its holder, upon exercise, to receive a cash payment, referred to as a cash settlement value, based on the amount by which the value of a reference index on the exercise date exceeds a predetermined level, or strike level. Unlike a traditional index call warrant, a relative performance call warrant is based on the comparative performance of two reference indices. That is, a relative performance call warrant entitles its holder, upon exercise, to receive a cash settlement value based on the amount by which a reference index (the bullish index) on the exercise date has outperformed another index (the bearish index) on the exercise date, as measured from the pricing date of the warrants to the exercise date. The cash settlement value is often referred to as the intrinsic value of the warrants. Because the value of a relative performance call warrant upon exercise is dependent on the outperformance of the bullish index against the bearish index, the level of the bearish index on the exercise date is, in effect, the strike level of the relative performance call warrant.

As with traditional call warrants, the warrants are a wasting asset in that, in the absence of countervailing factors, such as an increase in performance in the bullish index relative to the bearish index, the market value of the warrants will tend to decrease over time and the warrants will have no market value after the time for exercise has expired. Accordingly, an investment in the warrants involves a high degree of risk and is not appropriate for every investor. As such, investors who are considering purchasing the warrants must be able to understand and bear the risk of a speculative investment in the warrants and be experienced with respect to options and option transactions and understand the risks of stock index transactions.

You should be aware that the cash settlement value at any time prior to expiration is typically expected to be less than the warrants market value at that time. The difference between the market value and the cash settlement value, or intrinsic value, will reflect a number of factors, including the time value for the warrants, and the supply and demand for the warrants. At any given time, the time value of the warrants will depend, among other factors, primarily upon the intrinsic value, if any, of the warrants at that given time and the length of the period remaining to the expiration of the warrants. For more details, see Risk Factors. The warrants are a risky investment and may expire worthless.

**What are the terms of the warrants?**

The warrants will be issued by Wachovia Corporation and will expire on April 17, 2009, which we refer to as the expiration date .

The initial public offering price for the warrants will be determined on the pricing date and is expected to be between \$6.00 and \$6.50 per warrant.

The reference indices for the warrants are the S&P 500 and the Russell 2000. Any cash payments you may be entitled to under the warrants will be payable in U.S. dollars.

The warrants will be exercisable at the option of a holder on any trading day during the period beginning on April , 2007 and ending on April 14, 2009. For more details, see Specific Terms of the Warrants Exercise of Warrants .

All warrants not previously exercised will be automatically exercised on the expiration date.

**How do I exercise the warrants?**

To exercise the warrants, you must cause your warrants to be transferred to U.S. Bank, National Association (the paying agent ) on the records of The Depository Trust Company, New York, NY ( DTC , which term, as used herein and in the prospectus, includes any successor depository selected by us) and notify us of your election to exercise the warrants through normal clearing system channels, each prior to 11:00 a.m., New York City time, on any exercise date , which will be any trading day during the period beginning on April , 2007 and ending on April 14, 2009. See Specific Terms of the Warrants Exercise of Warrants and Risk Factors If you fail to comply with the conditions for exercise of your warrants you may not be able to exercise your warrants on the date you wish to exercise them .

The warrants will be issued in book-entry form and held of record by the nominees of DTC. In turn, the outstanding warrants will be recorded on DTC s books in the names of persons that have accounts with DTC, which we refer to as participants . Since the warrants will be held in book-entry form, you may exercise your warrants only by acting through the participant in whose account your warrants are held at DTC. Accordingly, as a beneficial owner of warrants, if you desire to exercise all or any portion of your warrants, you must instruct your broker, who in turn may need to instruct the participant through which you own your interest, to exercise your warrants on your behalf. See Specific Terms of the Warrants Exercise of Warrants and Risk Factors If you fail to comply with the conditions for exercise of your warrants you may not be able to exercise your warrants on the date you wish to exercise them .

To exercise your warrants on any exercise date, you must instruct your broker or other person through which you hold your warrants to take the appropriate steps through normal clearing system channels. Your book-entry interest in the warrants must be transferred to the paying agent on the applicable exercise date as described under Specific Terms of the Warrants Exercise of Warrants .

Different brokerage firms may have different deadlines for accepting instructions from their customers. Accordingly, as a beneficial owner of warrants, you should consult with your broker and other intermediaries, if applicable, for the relevant deadline and other exercise mechanics. If you have not satisfied all of the requirements for the exercise of your warrants by 11:00 a.m., New York City time, on any exercise date, your exercise will effected on the next exercise date.

Except in certain circumstances as described herein, any exercise, once made, is irrevocable.

We may request that Wachovia Capital Markets, LLC ( WCM ), which is one of our broker-dealer subsidiaries, purchase any exercised warrants for the amount of cash that would otherwise have been deliverable or payable by us. WCM s agreement to purchase the exercised warrants will not affect your right to take action against us if WCM fails to purchase your warrants. Any exercised warrants that are subsequently purchased by WCM will remain outstanding.

**What will I receive with respect to the warrants that I exercise (or upon automatic exercise of the warrants)?**

Upon your exercise of the warrants or the automatic exercise of the warrants, if the S&P 500 has outperformed the Russell 2000 from the pricing date to the applicable exercise date, regardless of whether the S&P 500 has gone up or down in value from its value on the pricing date, you will receive, on the applicable cash settlement date, a cash payment with respect to each warrant equal to the cash settlement value.

The cash settlement value equals the greater of (i) \$0 and (ii) the amount, if any, by which the S&P 500 exercise value is greater than the Russell 2000 exercise value. The cash settlement value will be rounded down to the nearest cent.

The S&P 500 exercise value will be determined on the applicable valuation date and will equal the reference level of the S&P 500 on the applicable valuation date times the S&P 500 multiplier.

The Russell 2000 exercise value will be determined on the applicable valuation date and will equal the reference level of the Russell 2000 on the applicable valuation date times the Russell 2000 multiplier.

The reference level for each index means, for any exercise date, the closing level of the index on that date, and, for the expiration date, the special opening quotation for that index on that date.

The special opening quotation means, with respect to each index, the special opening quotation for that index compiled and published by the Chicago Board Options Exchange ( CBOE ) or any successor to the CBOE. The special opening quotation for an index is a special calculation of that index that is compiled from the opening prices of the underlying stocks for that index on that day.

The S&P 500 multiplier is , which equals \$75.00 divided by the closing level of the S&P 500 on the pricing date.

The Russell 2000 multiplier is , which equals \$75.00 divided by the closing level of the Russell 2000 on the pricing date.

The cash settlement date will be three trading days following the valuation date for the warrants.

Except in certain circumstances, the valuation date for a warrant will be:

in the case of exercise on an exercise date, that exercise date; and

in the case of automatic exercise on the expiration date, the expiration date. See Specific Terms of the Warrants Exercise of Warrants Timing of Determination of Cash Settlement Value of Warrants .

The valuation date for an exercised warrant may be postponed upon the occurrence and continuation of certain types of events, which we refer to as a market disruption event (see Specific Terms of the Warrants Market Disruption Event ).

An index calculation day means any day on which the indices or any successor indices (as defined herein) are calculated and published, or any day on which Wachovia Securities, as calculation agent, calculates a level as a substitute for the indices or any successor indices as described under Specific Terms of the Warrants Discontinuation of the Indices; Adjustments to the Indices.

We have included a table illustrating hypothetical cash payments based on a range of hypothetical levels of the relative performance in the section entitled "Specific Terms of the Warrants - Hypothetical Cash Settlement Values on Exercise" in this pricing supplement.

You should be aware that the cash settlement value at any time prior to expiration is typically expected to be less than the warrants' market value at that time. The difference between the market value and the cash settlement value will reflect a number of factors, including the time value for the warrants, and the supply and demand for the warrants. At any given time, the time value of the warrants will depend, among other factors, primarily upon the intrinsic value, if any, of the warrants at that given time and the length of the period remaining to expiration of the warrants. For more details, see "Risk Factors." The warrants are a risky investment and may expire worthless.

**Following your exercise of the warrants (or upon automatic exercise of the warrants), if the S&P 500 exercise value does not exceed the Russell 2000 exercise value, you will not receive any cash payment with respect to each warrant exercised.**

Because the cash settlement value depends on the performance of the S&P 500 relative to the performance of the Russell 2000 (in each case, measured from the pricing date to the applicable valuation date), the cash settlement value will be zero on the applicable valuation date under each of the following scenarios:

the value of the S&P 500 decreases and the value of the Russell 2000 remains the same or increases;

the value of the Russell 2000 increases and the S&P 500 value remains the same or decreases;

the value of the S&P 500 increases, but is offset by a greater increase in the value of the Russell 2000; or

the value of the Russell 2000 decreases, but is offset by a greater decrease in the value of the S&P 500.

### **Hypothetical Examples**

Set forth below are hypothetical examples of the calculation of the cash settlement value. For purposes of these examples, we have assumed the following:

S&P 500 value on the pricing date: 1400

S&P 500 multiplier: 0.05357 (\$75.00 divided by 1400)

Russell 2000 value on the pricing date: 780

Russell 2000 multiplier: 0.09615 (\$75.00 divided by 780)

Initial public offering price per warrant: \$6.25

In each of the examples below, hypothetical reference levels for each of the S&P 500 and the Russell 2000 are provided and, in each case, the cash settlement value is calculated as follows:

greater of (i) \$0 and (ii) S&P 500 exercise value minus Russell 2000 exercise value.

The S&P 500 exercise value minus the Russell 2000 exercise value is calculated as follows:

(S&P 500 reference level × S&P 500 multiplier) - (Russell 2000 reference level × Russell 2000 multiplier).

### **Example 1**

The S&P 500 has increased by 14.00% from the pricing date to the valuation date and the Russell 2000 has increased by 4.00% from the pricing date to the valuation date:

Hypothetical S&P 500 reference level on the valuation date: 1596

Hypothetical Russell 2000 reference level on the valuation date: 811.20

Calculation of cash settlement value:

greater of (i) \$0 and (ii) S&P 500 exercise value *minus* Russell 2000 exercise value:

$$= (1596 \times 0.05357) - (811.20 \times 0.09615)$$

$$= 85.50 - 78.00$$

Cash settlement value per warrant = \$7.50

**In this example, since the positive return in the S&P 500 is greater than the positive return in the Russell 2000 by 10.00%, the cash settlement value is \$7.50, representing a 20.00% return on the initial investment of \$6.25 per warrant.**

**Example 2**

The S&P 500 has increased by 11.50% from the pricing date to the valuation date and the Russell 2000 has decreased by 4.75% from the pricing date to the valuation date:

Hypothetical S&P 500 reference level on the valuation date: 1561

Hypothetical Russell 2000 reference level on the valuation date: 742.95

Calculation of cash settlement value:

(S&P 500 value × S&P 500 multiplier) (Russell 2000 value × Russell 2000 multiplier)

= (1561 × 0.05357) (742.95 × 0.09615)

= 83.63 71.44

Cash settlement value per warrant = \$12.19

**In this example, since the positive return in the S&P 500 exceeds the negative return in the Russell 2000 by 16.00%, the cash settlement value is \$12.19, representing a 95.00% return on the initial investment of \$6.25 per warrant.**

**Example 3**

The S&P 500 has decreased by 2.00% from the pricing date to the valuation date and the Russell 2000 has decreased by 14.50% from the pricing date to the valuation date:

Hypothetical S&P 500 reference level on the valuation date: 1372

Hypothetical Russell 2000 reference level on the valuation date: 666.90

Calculation of cash settlement value:

(S&P 500 value × S&P 500 multiplier) (Russell 2000 value × Russell 2000 multiplier)

= (1372 × 0.05357) (666.90 × 0.09615)

= 73.50 64.13

Cash settlement value per warrant = \$9.38

**In this example, although the return in both the S&P 500 and the Russell 2000 is negative, since the negative return in the Russell 2000 exceeds the negative return in the S&P 500 by 12.50%, the cash settlement value is \$9.38, representing a 50.00% return on the initial investment of \$6.25 per warrant.**

**Example 4**

The S&P 500 has increased by 5.00% from the pricing date to the valuation date and the Russell 2000 has increased by 12.00% from the pricing date to the valuation date:

Hypothetical S&P 500 reference level on the valuation date: 1470

Hypothetical Russell 2000 reference level on the valuation date: 873.60

Calculation of cash settlement value:

$(\text{S\&P 500 value} \times \text{S\&P 500 multiplier}) - (\text{Russell 2000 value} \times \text{Russell 2000 multiplier})$

$= (1470 \times 0.05357) - (873.60 \times 0.09615)$

$= 78.75 - 84.00$

Cash settlement value per warrant = \$0.00

**In this example, even though the return in the S&P 500 is positive, since the positive return in the S&P 500 is less than the positive return in the Russell 2000, the cash settlement value is \$0.00, representing a 100% loss on the initial investment of \$6.25 per warrant.**

**Example 5**

The S&P 500 has decreased by 12.00% from the pricing date to the valuation date and the Russell 2000 has increased by 6.00% from the pricing date to the valuation date:

Hypothetical S&P 500 reference level on valuation date: 1232

Hypothetical Russell 2000 reference level on valuation date: 826.80

Calculation of cash settlement value:

$(\text{S\&P 500 value} \times \text{S\&P 500 multiplier}) - (\text{Russell 2000 value} \times \text{Russell 2000 multiplier})$

$= (1232 \times 0.05357) - (826.80 \times 0.09615)$

$= 66.00 - 79.50$

Cash settlement value per warrant = \$0.00

**In this example, since the return in the S&P 500 is negative and the return in the Russell 2000 is positive, the cash settlement value is \$0.00, representing a 100% loss on the initial investment of \$6.25 per warrant.**

The following table illustrates the cash settlement value for a range of returns in the S&P 500 and the Russell 2000. The figures below are for purposes of illustration only. The actual cash settlement value will depend on the actual index levels on the applicable valuation date, each determined by the calculation agent as described in this pricing supplement.

**Who should consider an investment in the warrants?**

The warrants involve a high degree of risk and are not appropriate for every investor. Investors who are considering purchasing the warrants must have an options-approved account, be able to understand and bear the risk of an investment in the warrants, be experienced with respect to options and option transactions and understand the risks of stock index transactions. Such investors should reach an investment decision only after careful consideration with their advisers of the suitability of the warrants in light of their particular financial circumstances and the information set forth in this pricing supplement and the prospectus. For more detail, see **Risk Factors** in this pricing supplement.

**What will I receive if I sell my warrants prior to the expiration date?**

The market value of the warrants will fluctuate during the term of the warrants. Several factors and their interrelationship will influence the market value of the warrants, including the relative performance of the S&P 500 and the Russell 2000, dividend yields of the component common stocks underlying the S&P 500 and the Russell 2000, the time remaining to expiration of the warrants, interest rates, and the volatility of the S&P 500 and the Russell 2000. Depending on the impact of these factors, you may receive less than your initial investment upon any sale of your warrants before the expiration date of the warrants. For more details, see **Risk Factors**. Many factors affect the market value of the warrants .

You should be aware that the cash settlement value at any time prior to expiration is typically expected to be less than the warrants' market value at that time. The difference between the market value and the cash settlement value will reflect a number of factors, including the time value for the warrants, and the supply and demand for the warrants. At any given time, the time value of the warrants will depend, among other factors, primarily upon the intrinsic value, if any, of the warrants at that given time and the length of the period remaining to expiration of the warrants. For more details, see **Risk Factors**. The warrants are a risky investment and may expire worthless .

**Are there events that may affect my ability to exercise the warrants or the cash payment to which I may be entitled?**

In addition to the conditions to early exercise described above, the exercise of your warrants may be affected by certain events which we refer to as a market disruption event , including the following:

a relevant exchange or any related exchange fails to open for trading during its regular trading session,

a trading disruption , if the calculation agent determines it is material, at any time during the one-hour period that ends at the close of trading for a relevant exchange or related exchange,

an exchange disruption , if the calculation agent determines it is material, at any time during the one-hour period that ends at the close of trading for a relevant exchange or related exchange, or

an early closure ,

(each as defined under Specific Terms of the Warrants Timing of Determination of Cash Settlement Value of Warrants and Market Disruption Event ); *provided* that such events will not be deemed a market disruption event if the calculation agent determines in its sole discretion that any such event has not materially interfered with our ability to unwind or adjust all or a material portion of our hedge position with respect to the warrants.

These events may result in the postponement of the applicable valuation date of the warrants, and any such postponement could adversely affect the cash settlement value of the warrants. See Specific Terms of the Warrants Market Disruption Event for a detailed description of, and the consequences of, such events.

### **What about taxes?**

The U.S. federal income tax consequences of your investment in the warrants are uncertain. In the opinion of our special tax counsel, Davis Polk & Wardwell, although there is no authority directly on point, the warrants should be treated as nonequity options that are subject to the special mark-to-market rules under Section 1256 of the Internal Revenue Code. Under the mark-to-market rules, you are required to recognize gain or loss in each taxable year equal to the difference between the fair market value of your warrants on the last trading day of each taxable year (as determined by the warrants trading price) and your tax basis in the warrants you hold. Under the mark-to-market rules, your tax basis in your warrants will equal the amount you paid for your warrants plus or minus the net gain or loss recognized by you under the mark-to-market rules in respect of your warrants in prior taxable years. As a result of the application of this mark-to-market rule, you may incur U.S. federal income tax liability on an annual basis in respect of an increase in the value of the warrants without the receipt of cash attributable to your warrants. Upon the sale, exercise (whether at your option or automatically) or expiration of a warrant, you will recognize gain or loss equal to the difference between the amount realized, if any, and your tax basis in your warrant. Under the mark-to-market rules, any gain or loss with respect to your warrants (either annually or on a sale, exercise or expiration of the warrants) will be 60% long-term capital gain or loss and 40% short-term capital gain or loss. For a further discussion, see Certain U.S. Federal Income Tax Considerations beginning on page 33.

Because there is no authority that specifically addresses the tax treatment of the warrants, it is possible that the warrants could be treated differently for U.S. federal income tax purposes. For example, a warrant could be treated as a derivative contract with respect to the relative performance of the indices that is not subject to the mark-to-market rules under Section 1256. For a further discussion of the tax consequences of this alternative treatment, see Certain U.S. Federal Income Tax Considerations Alternative Characterization on page S-34.

### **Who publishes the relevant indices and what do the indices measure?**

The S&P 500 is published by Standard & Poor's, a division of The McGraw-Hill Companies, Inc., and is intended to indicate the pattern of common stock price movement, focusing on the large capitalization sector of the market. Beginning on March 18, 2005, Standard & Poor's shifted from a market capitalization-weighted formula to a half float-adjusted formula, and as of September 16, 2005, Standard & Poor's shifted to a full float-adjusted formula, which affects each company's weight in the S&P 500. The goal of this change was to reflect only those shares that are available to investors, not all of a company's outstanding shares.

The Russell 2000 is published by Frank Russell Company and measures the composite price performance of stocks of 2,000 companies domiciled in the United States and its territories. The Russell 2000 is designed to track the performance of the small capitalization segment of the U.S. equity market. All 2,000 stocks are traded on the New York Stock Exchange or the American Stock Exchange, or are listed on the Nasdaq Global Market, and form a part of the Russell 3000® Index. As a capitalization-weighted index, the Russell 2000 reflects changes in the capitalization, or market value, of the Russell 2000 component stocks relative to the capitalization on a base date.

The S&P 500 and the Russell 2000 are determined, calculated and maintained by Standard & Poor's and Frank Russell Company, respectively (the index sponsors). The index sponsors are not involved in the offer of the warrants and have no obligation to consider your interests as a holder of the warrants.

You should be aware that an investment in the warrants does not entitle you to any ownership interest in the stocks of the companies included in the indices. For a detailed discussion of each index, see "The Indices" beginning on 25.

If an index sponsor (or any third party publisher acceptable to Wachovia Securities, as calculation agent under the warrants (the calculation agent)) discontinues publication of its respective index, or any successor index (as defined under "Specific Terms of the Warrants" "Discontinuation of the Indices; Adjustments to the Indices"), the cash settlement value will be determined by the calculation agent based on a substitute level for the relevant index or its successor index calculated by the calculation agent in accordance with the procedures last used to calculate the level of the relevant index or its successor index, as applicable, before the discontinuation, but using only those stocks that composed the relevant index or the successor index, as applicable, before that discontinuation. See "Specific Terms of the Warrants" "Discontinuation of the Indices; Adjustments to the Indices".

### **How have the relevant indices performed historically? How can I find current quotes for them?**

You can find a table with the high, low and closing levels of the indices during each calendar quarter from calendar year 2003 to the present in the sections entitled "The Indices" "Historical Closing Levels of S&P 500" and "Historical Closing Levels of the Russell 2000" in this pricing supplement. We obtained the historical information from Bloomberg Financial Markets without independent verification. You should not take past performance of the indices as an indication of how the indices will perform in the future.

The index quotation symbols on Bloomberg Financial Markets are SPY for the S&P 500 and RTY for the Russell 2000.

The following graph depicts the rolling two-year performance of the S&P 500 compared to the Russell 2000, from December 31, 1981, to December 29, 2006 and is provided for illustrative purposes only. For each date within that period, the graph shows the relative performance of the S&P 500 versus the Russell 2000 over the preceding two years. For example, the date on the graph of December 1999 represents the relative performance of the S&P 500 versus the Russell 2000 for the period beginning January 1, 1998 to December 31, 1999. In this two-year period, the S&P 500 outperformed the Russell 2000 by 35.90%. Similarly, the date on the graph of December 2004 represents the relative performance of the S&P 500 versus the Russell 2000 for the period beginning January 1, 2003 to December 31, 2004. In this two-year period, the S&P 500 underperformed the Russell 2000 by 32.34%. The two-year period is used for illustrative purposes to demonstrate the variability in the rolling returns of the indices for a period of time comparable to the term of the warrants; the relative performance of the indices measured over different periods, e.g., 6 months or one year, would yield different results. Any historical upward or downward trend in the level of the indices during any period depicted in the graph is not any indication that the levels of either or both of the indices are more or less likely to increase or decrease at any time or over any period during the term of the warrants.

### **Will the warrants be listed on a stock exchange?**

We have applied to list the warrants on the American Stock Exchange (the AMEX), subject to meeting listing requirements. The proposed trading symbol for the warrants on the AMEX is RWP.WS. We cannot predict whether or when the AMEX will approve our application or whether this offering will satisfy the listing criteria of the AMEX. If the warrants are not accepted for listing on the AMEX, or if the warrants are accepted for listing on the AMEX but subsequently delisted from, or permanently suspended from trading on, the AMEX, the warrants will not be listed or displayed on any other securities exchange, the Nasdaq Stock Market or any electronic communications network. In such a case, it is possible that no active trading market for the warrants will exist. If the warrants are accepted for listing on the AMEX, we make no representation that the warrants will remain listed for the entire term of the warrants. You should be aware that even if the warrants are listed on the AMEX, a liquid trading market will not necessarily develop for the warrants. You should review the sections entitled Risk Factors. There may not be an active trading market for the warrants in this pricing supplement.

We have requested that the AMEX publish the indicative cash settlement value of the warrants under the symbol . The AMEX in no way sponsors, endorses or is otherwise involved in the warrants and disclaims any liability to any party for any inaccuracy in the data on which the indicative cash settlement value is based, for any mistakes, errors or omissions in the calculation and/or dissemination of the indicative cash settlement value, or for the manner in which it is applied in connection with the warrants.

### **Are there any risks associated with my investment?**

**RISK FACTORS**

*An investment in the warrants involves a high degree of risk. Prospective purchasers of the warrants should recognize that their warrants may expire worthless and should be prepared to sustain a total loss of the purchase price of their warrants. Prospective purchasers of the warrants should be experienced with respect to options and options transactions, should understand the risks of transactions in equity-indexed instruments and should reach an investment decision only after careful consideration, with their advisers, of the suitability of the warrants in light of their particular financial circumstances, taking into consideration the information set forth in this pricing supplement and in the prospectus. The AMEX requires that the warrants be sold only to investors with options-approved accounts and requires its members and member organizations and their registered employees to make suitability determinations before recommending transactions in the warrants.*

**The warrants are a risky investment and may expire worthless**

The owner of a warrant will receive a cash payment upon exercise (including automatic exercise) only if the warrant has a cash settlement value greater than zero at that time. The cash settlement value of a warrant will be greater than zero only if the S&P 500 exercise value is greater than the Russell 2000 exercise value, which will occur if the S&P 500 has outperformed the Russell 2000, regardless of direction, from the pricing date to the applicable valuation date. The valuation date for an exercised warrant may be postponed upon the occurrence or continuation of certain types of events, which we refer to as market disruption events (see Specific Terms of the Warrants Market Disruption Event ).

The relative values of the S&P 500 exercise value and the Russell 2000 exercise value will determine whether the warrants have a cash settlement value greater than zero on any particular valuation date. The warrants are at-the-money as of the date of this pricing supplement and will be in-the-money on any particular day only if the S&P 500 exercise value is greater than the Russell 2000 exercise value on that day. Only an S&P 500 exercise value that is greater than the Russell 2000 exercise value will result in a positive cash settlement value, whereas an S&P 500 exercise value that is equal to or less than the Russell 2000 exercise value will result in cash settlement value of zero. Potential profit or loss upon exercise (including automatic exercise) of a warrant will be a function of the cash settlement value of that warrant, the purchase price of that warrant and any related transaction costs.

In particular, the cash settlement value will be zero if, from the pricing date to the applicable valuation date,

the value of the S&P 500 decreases and the value of the Russell 2000 remains the same or increases;

the value of the Russell 2000 increases and the value of the S&P 500 remains the same or decreases;

the value of the S&P 500 increases, but is offset by a greater increase in the value of the Russell 2000; or

the value of the Russell 2000 decreases, but is offset by a greater decrease in the value of S&P 500.

Upon exercise of the warrants (including automatic exercise), if the S&P 500 exercise value for the applicable valuation date is equal to or less than the Russell 200 exercise value for the applicable valuation date, you will not receive any cash payment with respect to each warrant exercised.

The cash settlement value at any time prior to expiration is typically expected to be less than the warrants market value at that time. The difference between the market value and the cash settlement value will reflect a number of factors, including the time value for the warrants, and the supply and demand for the warrants. The time value of the warrants will depend, among other factors, primarily upon the intrinsic value, if any, of the warrants at that given time and the length of the period remaining to expiration of the warrants.

Investment decisions relating to index warrants and other similar warrants require the investor to take a view on the direction of movements in an underlying index as well as on the magnitude and timing of those movements. Relative performance warrants may change substantially in value, or lose all of their value, with relatively small movements in the underlying indices. Moreover, the warrants are a wasting asset in that, in the absence of countervailing factors, such as an increase in performance in the bullish index relative to the bearish index, the market value of the warrants will tend to decrease over time and the warrants will have no market value after the time for exercise has expired. Accordingly, the warrants involve a high degree of risk and are not appropriate for every investor. As such, investors who are considering purchasing the warrants must be able to understand and bear the risk of a speculative investment in the warrants and be experienced with respect to options and option transactions and understand the risks of stock index transactions. Such investors should reach an investment decision only after careful consideration, with their advisers, of the suitability of the warrants in light of their particular financial circumstances and the information set forth in this pricing supplement and in the prospectus.

### **The warrants are suitable only for sophisticated investors with options-approved accounts**

The AMEX requires that the warrants be sold only to investors with options-approved accounts. In addition, the AMEX requires that its members and member organizations and their registered employees make certain suitability determinations before recommending transactions in warrants. Before making any investment in the warrants, it is important that a prospective investor become informed about and understand the nature of the warrants in general, the specific terms of the warrants and the nature of the S&P 500 and the Russell 2000. An investor should understand the consequences of liquidating that investor's investment in a warrant by exercising it as opposed to selling it. It is especially important for an investor to be familiar with the procedures governing the exercise of the warrants, since the cash settlement value of the warrants will fluctuate over the life of the warrants and a failure to properly exercise a warrant prior to its expiration could result in the loss of the opportunity to realize a cash settlement value that is higher than the cash settlement value that might otherwise be realized on the expiration date. To properly exercise warrants, an investor must know when warrants are exercisable and how to exercise them.

### **The warrants are not standardized options issued by the Options Clearing Corporation**

The warrants are not standardized stock index options of the type issued by the Options Clearing Corporation (the OCC), a clearing agency regulated by the Securities and Exchange Commission (the SEC). For example, unlike purchasers of OCC standardized options who have the credit benefits of guarantees and margin and collateral deposits by OCC clearing members to protect the OCC from a clearing member's failure, purchasers of the warrants must look solely to Wachovia Corporation for performance of its obligations to pay the cash settlement value, if any, upon the exercise of the warrants. The warrants are unsecured contractual obligations of Wachovia Corporation and will rank equally with Wachovia Corporation's other unsecured contractual obligations and with its unsecured and unsubordinated debt. In addition, the secondary market for the warrants, if any, is not expected to be as liquid as the market for OCC standardized options.

### **Many factors affect the market value of the warrants**

The market value of the warrants will be affected by factors that interrelate in complex ways. It is important for you to understand that the effect of one factor may offset the increase in the market value of the warrants caused by another factor and that the effect of one factor may compound the decrease in the market value of the warrants caused by another factor. For example, a change in the volatility of the S&P 500 or the Russell 2000 may offset some or all of any increase in the market value of the warrants attributable to another factor, such as an increase in the level of the S&P 500. We expect that the market value of the warrants will depend substantially on the then current values of the S&P 500 and the Russell 2000, and, in particular, whether the S&P 500 exercise value is greater than the Russell 2000 exercise value. We believe that other factors that may also influence the value of the warrants include:

the volatility (frequency and magnitude of changes in the level) of the S&P 500 and the Russell 2000 and, in particular, market expectations regarding the volatility of the S&P 500 and the Russell 2000,

the expected correlation between changes in value of the S&P 500 and the Russell 2000,

the time remaining to expiration,

interest rates in the U.S.,

the dividend yields of the common stocks included in the S&P 500 and the Russell 2000,

our creditworthiness, as represented by our credit ratings or as otherwise perceived in the market,

changes that affect the S&P 500 or the Russell 2000, such as additions, deletions or substitutions, and

geopolitical, economic, financial, political, regulatory or judicial events as well as other conditions may affect the common stocks included in the S&P 500 and the Russell 2000.

As discussed above, the cash settlement value at any time prior to expiration is typically expected to be less than the warrants' market value at that time. If you wish to dispose of your warrants, you should consider whether it is preferable at such time to sell your warrants or to exercise your warrants.

### **Valuation dates may be postponed, which may reduce the cash settlement value**

Any downward movement in the relative performance amount between the time a warrant holder exercises its warrants and the time the spot index values are determined with respect to that exercise (which period will be at least the period between 11:00 a.m., New York City time on the exercise date and the time that the closing levels of the indices on that date are calculated and, in the case of a postponed valuation date following a market disruption event, may be substantially longer) will result in that warrant holder receiving a cash settlement value that is less than the cash settlement value anticipated by that warrant holder based on the relative performance amount most recently reported prior to exercise.

If the calculation agent determines that a valuation date occurs on a day that is a disrupted day (as defined under *Specific Terms of the Warrants Timing of Determination of Cash Settlement Value of Warrants* ), then the valuation date for that warrant will be postponed to the next succeeding index calculation day that is not a disrupted day; *provided* that, if the valuation date is postponed by eight trading days but that eighth trading day following the original valuation date is a disrupted day, then that eighth trading day will nevertheless be the valuation date, and the calculation agent will determine the relevant spot index value on that eighth trading day in accordance with the formula and method for calculating the value of the relevant index or any successor index, as the case may be, last in effect prior to the commencement of the market disruption event, using the closing price or special opening quotation (or, if trading in the relevant stocks has been materially suspended or materially limited, its good faith estimate of the closing price or special opening quotation that would have prevailed but for such suspension or limitation) on such trading day of each stock most recently underlying the relevant index or any successor index, as the case may be.

### **The price of the warrants will exceed that of similar options**

The initial offering price of the warrants will be in excess of the price that a large, institutional investor in options might pay for a comparable option in a private transaction.

### **Historical levels of the S&P 500 and the Russell 2000 should not be taken as an indication of the future levels of the S&P 500 and the Russell 2000 during the term of the warrants**

The trading prices of the stocks underlying the S&P 500 and the Russell 2000 (the *underlying stocks* ) will determine the level of the S&P 500 and the Russell 2000 at any given time. The underlying stocks have performed differently in the past than how they are performing now and are expected to perform differently in the future. As a result, it is impossible to predict whether the levels of the S&P 500 and the Russell 2000 will

rise or fall. Trading prices of the underlying stocks will be influenced by complex and interrelated political, economic, financial and other factors that can affect the issuers of the underlying stocks. Therefore, historical levels of the S&P 500 and the Russell 2000 should not be taken as indications of the future levels of the S&P 500 and the Russell 2000 during the term of the warrants.

### **Discontinuation of publication of the S&P 500 or the Russell 2000 could adversely affect the value of the warrants**

If publication of the S&P 500 or the Russell 2000 is discontinued, the calculation agent may select a successor index, or calculate a substitute level comparable to the S&P 500 or the Russell 2000, as a substitute for the relevant index. See Specific Terms of the Warrants Discontinuation of the Indices; Adjustments to the Indices .

Notwithstanding these alternative arrangements, discontinuation of the publication of the S&P 500, the Russell 2000 or any successor index would be expected to adversely affect the market value of, liquidity of and trading in the warrants.

### **The return on the warrants will not reflect the return on the stocks underlying the S&P 500 and the Russell 2000, and you will have no shareholder rights or rights to receive any stock**

The index sponsors calculate the levels of their respective indices by reference to the prices of the common stocks included in the indices without taking account of the value of dividends paid on those stocks. As a result, the return on the warrants will not reflect the return you would realize if you actually owned (in the case of the S&P 500) or sold short (in the case of the Russell 2000) the stocks included in the indices and received (or paid) the dividends paid on those stocks. In addition, because investing in the warrants is not equivalent to investing in the S&P 500 and the Russell 2000 or the underlying stocks, neither you nor any other holder or owner of the warrants will have any voting rights, any right to receive dividends or other distributions or any other rights with respect to the underlying stocks. If exercised, the cash settlement value, if any, will be paid only in cash, and you will have no rights to receive delivery of any underlying stocks or any dividends.

### **Adjustments to the S&P 500 and the Russell 2000 could adversely affect the value of the warrants**

The policies of the index sponsors concerning additions, deletions and substitutions of the stocks underlying their respective indices and the manner in which the index sponsors take account of certain changes affecting the underlying stocks may affect the value of their respective indices. The policies of the index sponsors with respect to the calculation of their respective indices could also affect the value of the indices. The index sponsors may discontinue or suspend calculation or dissemination of their respective indices or materially alter the methodology by which they calculate their respective indices. Any such actions could affect the value of the warrants. See Specific Terms of the Warrants Discontinuance of the Indices; Adjustments to the Indices and The Indices .

### **Wachovia and its affiliates have no affiliation with the index sponsors and are not responsible for their public disclosure of information**

Wachovia and its affiliates are not affiliated with the index sponsors in any way (except for licensing arrangements discussed below under The Indices ) and have no ability to control or predict their actions, including any errors in or discontinuation of disclosure regarding their methods or policies relating to the calculation of the component indices. If the component index sponsors discontinue or suspend the calculation of a component index, it may become difficult to determine the market value of the securities or the maturity payment amount. The calculation agent may designate a successor index selected in its sole discretion. If the calculation agent determines in its sole discretion that no successor index comparable to the component index exists, the amount you receive at maturity will be determined by the calculation agent in its sole discretion. See Specific Terms of the Warrants Market Disruption Event on page 22 and Specific Terms of the Warrants Discontinuation of the Indices; Adjustments to the Indices on page 21. The index sponsors are not involved in the offer of the warrants in any way and have no obligation to consider your interest as an owner of warrants in taking any actions that might affect the value of your securities.

Each security is an unsecured obligation of Wachovia only and is not an obligation of the index sponsors. None of the money you pay for your warrants will go to the index sponsors. Since the index sponsors are not involved in the offering of the warrants in any way, they have no obligation to consider your interest as an owner of warrants in taking any actions that might affect the value of your warrants. The index sponsors may take actions that will adversely affect the market value of the warrants.

Neither we nor any of our affiliates assumes any responsibility for the adequacy or accuracy of the information about the indices or the index sponsors contained in this pricing supplement. You, as an investor in the warrants, should make your own investigation into the indices and the index sponsors.

### **There may not be an active trading market for the warrants**

It is not possible to predict how the warrants will trade in the secondary market or whether the market will be liquid or illiquid. If the warrants are subsequently delisted from, or permanently suspended from trading on, the AMEX, the warrants may not be listed or displayed on any other securities exchange, the Nasdaq Stock Market or any electronic communications network, in which case it is possible that no active trading market for the warrants will exist. If the warrants are not subsequently listed or quoted on another organized securities market in the United States within five trading days of the effective date of any such delisting or trading suspension, warrants not previously exercised will be deemed automatically exercised on that fifth trading day. We will not voluntarily cause any such delisting or trading suspension.

It is not possible to predict whether a secondary market for the warrants will develop. If there is a secondary market, it may not provide significant liquidity and we expect that transaction costs in any secondary market would be high. As a result, the difference between bid and asked prices for your warrants in any secondary market could be substantial. If you sell your warrants prior to the expiration date, you may have to do so at a discount from the initial public offering price, and, as a result, you may suffer substantial losses.

Wachovia Capital Markets, LLC and other broker-dealer affiliates of Wachovia currently intend to make a market for the warrants, although they are not required to do so and may stop any such market-making activities at any time. As market makers, trading of the warrants may cause Wachovia Capital Markets, LLC or any other broker-dealer affiliates of Wachovia to have long or short positions in the warrants. The supply and demand for the warrants, including inventory positions of market makers, may affect the secondary market for the warrants. To the extent warrants are exercised, the number of warrants outstanding will decrease, resulting in a decrease in the liquidity of the warrants. In addition, during the life of the warrants, Wachovia Capital Markets, LLC or its affiliates may from time to time purchase and exercise the warrants, resulting in a decrease in the liquidity of the warrants.

### **Trading and other transactions by us and our affiliates in securities linked to the stocks underlying the S&P 500 and the Russell 2000 may impair the value of the warrants**

We or one or more of our affiliates may hedge our obligations under the securities by (i) purchasing or selling some or all of the underlying stocks; options or futures on the S&P 500 and the Russell 2000, successor indices or the underlying stocks; or other instruments linked to the S&P 500 and the Russell 2000, any successor indices or the underlying stocks, (ii) adjusting the hedge by, among other things, purchasing or selling any of the foregoing, at any time and from time to time, and (iii) unwinding the hedge by selling any of the foregoing, perhaps on or before any applicable valuation date. Any of these hedging activities may adversely affect the value of the S&P 500 and the Russell 2000 or any successor indices directly or indirectly by affecting the prices of the underlying stocks and therefore the market value of your warrants and the cash settlement value. It is possible that we or one or more of our affiliates could receive substantial returns with respect to these hedging activities while the value of the warrants declines.

We may also issue other securities or financial or derivative instruments with returns linked to changes in the value of the S&P 500 and the Russell 2000, any successor indices or one or more of the underlying stocks. By introducing competing products into the marketplace in this manner, we could adversely affect the market value of your warrants and the cash settlement value. ### **The inclusion of commissions and projected profits from hedging in the original issue price is likely to adversely affect secondary market prices**

Assuming no change in market conditions or any other relevant factors, the price, if any, at which we our affiliates are willing to purchase the warrants in secondary market transactions will likely be lower than the initial public offering price of the warrants and, in particular, the maximum initial offering price of the warrants, since the initial public offering price included, and secondary market prices are likely to exclude, commissions paid with respect to the warrants, as well as some or all of the projected profit included in the cost of hedging our obligations under the warrants. In addition, any such prices may differ from values determined by pricing models used by Wachovia, as a result of dealer discounts, mark-ups or other transactions.

### **Additional potential conflicts of interest could arise**

Our subsidiary, Wachovia Securities, is our agent for purposes of determining the spot S&P 500 value, the spot Russell 2000 value and the cash settlement value, and other related matters such as determining whether a market disruption event has occurred or is continuing on a valuation date for the warrants, determining whether the spot S&P 500 value or the spot Russell 2000 value will be calculated with reference to a successor index or substitute level for the relevant index, or calculating any substitute level for the S&P 500 or the Russell 2000, each as described herein. Under certain circumstances, Wachovia Securities' role as our subsidiary and its responsibilities as calculation agent for the warrants could give rise to conflicts of interest. These conflicts could occur, for instance, in connection with its determination as to whether the spot index values can be calculated on a particular trading day, or in connection with judgments that it would be required to make in the event of a discontinuation of one or more of the indices. See the sections entitled *Specific Terms of the Warrants Market Disruption Event* on page 22 and *Specific Terms of the Warrants Discontinuation of the Indices; Adjustments to the Indices* on page 21. Wachovia Securities is required to carry out its duties as calculation agent in good faith and using its reasonable judgment.

**PRICING**

The initial public offering price for the warrants is not higher than the price recommended by Oppenheimer & Co. Inc., as qualified independent underwriter. Among the factors considered in determining the initial public offering price for the warrants were the closing prices of the S&P 500 and the Russell 2000 on the pricing date, information based on options pricing methods and models used for pricing similar transactions, and market prices. The initial public offering price includes, and secondary market prices are likely to exclude, commissions paid with respect to the warrants, as well as some or all of the projected profit included in the cost of hedging our obligations under the warrants.

**SPECIFIC TERMS OF THE WARRANTS**

*Please note that in this section entitled **Specific Terms of the Warrants**, references to **holders** mean those who own securities registered in their own names, on the books that we or the trustee maintain for this purpose, and not indirect holders who own beneficial interests in securities registered in street name or in securities issued in book-entry form through The Depository Trust Company. Please review the special considerations that apply to indirect holders in the accompanying prospectus, under **Legal Ownership**.*

The securities are part of a series of warrants, entitled **Warrants**, that we may issue under the warrant indenture from time to time as described in the accompanying prospectus. The securities are also **Indexed Securities** as described in the accompanying prospectus.

This pricing supplement summarizes specific financial and other terms that apply to the warrants. Terms that apply generally to all Warrants are described in **Description of the Warrants We May Offer** in the accompanying prospectus. The terms described here supplement those described in the accompanying prospectus and, if the terms described there are inconsistent with those described here, the terms described here are controlling.

We describe the terms of the warrants in more detail below.

**General**

The aggregate number of warrants to be issued is .

A warrant will not entitle or require a warrantholder to purchase or take delivery from us of any shares of any of the underlying stocks or any other securities. The warrants will not entitle the warrantholders to any of the rights of holders of any of the underlying stocks or any other securities. We are under no obligation to, nor will we, sell or deliver to any warrantholder any shares of any of the underlying stocks or any other securities in connection with the exercise of any warrants. Following exercise of a warrant, we will make only a U.S. dollar cash payment in an amount equal to the cash settlement value, if any, of that warrant. Warrantholders will not receive any interest on any cash settlement value.

**Cash Settlement Value**

Each warrant entitles the warrantholder to receive, upon exercise (including automatic exercise), the cash settlement value of that warrant on the applicable cash settlement date. The cash settlement value equals the greater of (i) \$0 and (ii) the amount, if any, by which the S&P 500 exercise value is greater than the Russell 2000 exercise value. The cash settlement value will be rounded down to the nearest cent.

The **S&P 500 exercise value** will be determined on the applicable valuation date and will equal the reference level of the S&P 500 on the applicable valuation date times the S&P 500 multiplier.

The **Russell 2000 exercise value** will be determined on the applicable valuation date and will equal the reference level of the Russell 2000 on the applicable valuation date times the Russell 2000 multiplier.

The **reference level** for each index means, for any exercise date, the closing level of the index on that date, and, for the expiration date, the special opening quotation for that index on that date.

The **special opening quotation** means, with respect to each index, the special opening quotation for that index compiled and published by the CBOE or any successor to the CBOE. The special opening quotation for an index is a special calculation of that index that is compiled from the opening prices of the underlying stocks for that index on that day.

The **S&P 500 multiplier** is , which equals \$75.00 divided by the closing level of the S&P 500 on the pricing date.

The Russell 2000 multiplier is , which equals \$75.00 divided by the closing level of the Russell 2000 on the pricing date.

### **Exercise of Warrants**

The warrants will be exercisable at the option of a holder on any trading day during the period beginning on April , 2007 and ending on April 14, 2009, subject to postponement as described under Timing of Determination of Cash Settlement Value of Warrants , and will expire on April 17, 2009 (the expiration date ). All warrants outstanding on the expiration date will be automatically exercised on the expiration date.

You may exercise warrants by causing:

such warrants to be transferred free to the paying agent on the records of DTC in accordance with DTC s Deposit/Withdrawal at Custodian procedures; and

a notice of exercise to be received by the paying agent from DTC pursuant to normal clearing system procedures, prior to 11:00 a.m., New York City time, on any trading day during the period beginning on April , 2007 and ending on April 14, 2009 (each such date, an exercise date ).

To ensure that the warrants and related notice will be transferred to the paying agent before 11:00 a.m., New York City time, on a given exercise date, a holder of a beneficial interest in a warrant may need to give exercise instructions to its broker or other intermediary substantially earlier than 11:00 a.m., New York City time, on that day. Different brokerage firms may have different deadlines for accepting and implementing exercise instructions from their customers. Therefore, investors holding beneficial interests in the warrants should consult with their brokers and other intermediaries, if applicable, as to applicable deadlines and other exercise mechanics. If all conditions necessary to exercise warrants are not satisfied prior to 11:00 a.m., New York City time on any exercise date, the exercise will be effected on the next exercise date.

Not later than 5:00 p.m., New York City time, on the applicable valuation date (or, if such valuation date is not a trading day, on the trading day next succeeding that valuation date), the calculation agent shall determine the cash settlement value for an exercised warrant (including upon automatic exercise) based on the spot index values on such valuation date and notify the paying agent of that cash settlement value. The calculation agent will not be responsible for good faith errors or omissions in determining or disseminating information regarding the spot index values or determining the cash settlement value for a warrant.

### **Timing of Determination of Cash Settlement Value of Warrants**

The valuation date for a warrant will be:

in the case of exercise on an exercise date that exercise date, or if that exercise date is not an index calculation day, the index calculation day immediately following that exercise date; and

in the case of automatic exercise on the expiration date, the expiration date, or if expiration is not an index calculation day, the index calculation day immediately following the expiration date, *provided, however*, that if the calculation agent determines that such index calculation day occurs on a day that is a disrupted day, then the valuation date will be postponed until the next succeeding index calculation day that is not a disrupted day; *provided* that in no event will the valuation date be postponed by more than eight trading days. If the valuation date is postponed by eight trading days but that eighth trading day following the original valuation date is a disrupted day, then that eighth trading day will nevertheless be the valuation date, and the calculation agent will determine the relevant spot index value on that eighth trading day in accordance with the formula and method for calculating the value of the relevant index or any successor index, as the case may be, last in effect prior to the commencement of the market disruption event, using the closing price (or, if trading in the relevant securities has been materially suspended or materially limited, its good faith estimate of the closing price that would have prevailed but for such suspension or limitation) on such trading day of each stock most recently underlying the relevant index or any successor index, as the case may be.

An **index calculation day** means any day on which the indices or any successor indices (as defined herein) are calculated and published, or any day on which Wachovia Securities, as calculation agent, calculates a level as a substitute for the indices or any successor indices as described under **Discontinuation of the Indices; Adjustments to the Indices**.

A **disrupted day** means any trading day on which a relevant exchange or related exchange fails to open for trading during its regular trading session or on which a market disruption event (as defined below) has occurred with respect to the S&P 500, the Russell 2000 or any successor index.

A **trading day** means any day on which each exchange and related exchange is scheduled to be open for its respective trading sessions.

An **exchange** means, with respect to either the S&P 500 or the Russell 2000, the primary organized exchange or quotation system for trading any stocks included in the relevant index or any successor index and any successor to any exchange or quotation system or any substitute exchange or quotation system to which trading in any stocks underlying the relevant index or any successor index has temporarily relocated (*provided* that the calculation agent has determined that there is comparable liquidity relative to the stocks underlying the relevant index or any successor index on the substitute exchange or quotation system as on the original exchange).

A **related exchange** means, with respect to either the S&P 500 or the Russell 2000, each exchange or quotation system on which futures or options contracts relating to the relevant index or any successor index are traded, any successor to such exchange or quotation system or any substitute exchange or quotation system to which trading in the futures or options contracts relating to the relevant index or any successor index has temporarily relocated (*provided* that the calculation agent has determined that there is comparable liquidity relative to the futures or options contracts relating to the relevant index or any successor index on the temporary substitute exchange or quotation system as on the original related exchange).

The S&P 500 and the Russell 2000 are compiled and published by their respective index sponsors continually during each index calculation day based on the most recent official closing prices of each of the underlying stocks as reported by the relevant exchange. The special opening quotation is compiled and published by the CBOE.

Wachovia Securities, our subsidiary, will serve as the calculation agent. All determinations made by the calculation agent will be at the sole discretion of the calculation agent and, absent a determination of a manifest error, will be conclusive for all purposes and binding on Wachovia and the holders and beneficial owners of the warrants. Wachovia may at any time change the calculation agent without notice to holders of warrants.

U.S. Bank National Association will serve as the U.S. registrar and the domestic paying agent.

## **Settlement**

The **cash settlement date** in respect of any exercise of warrants or the automatic exercise of the warrants on the expiration date will be three trading days following the applicable valuation date. Following each exercise of warrants (including upon automatic exercise), we will be required to make available to the paying agent, no later than 3:00 p.m., New York City time, on the cash settlement date, same day funds in an amount sufficient to pay the aggregate cash settlement value of the validly exercised warrants or automatically exercised warrants, as the case may be. If we have made those funds available to the paying agent by that time, the paying agent will be responsible for making a payment to DTC on such cash settlement date in an amount equal to the aggregate cash settlement value of those warrants. DTC will be responsible for disbursing such

payment to each appropriate participant and that participant will be responsible for disbursing those payments to the beneficial owners of warrants that it represents and to each brokerage firm for which it acts as agent. Each such brokerage firm will be responsible for disbursing payments to the beneficial owners of warrants it represents.

**Discontinuation of the Indices; Adjustments to the Indices**

If an index sponsor discontinues publication of its respective index but another entity not affiliated with the calculation agent and acceptable to the calculation agent (a third party publisher) begins publishing that index, then for any date thereafter that index as published by such third party publisher will be used for all purposes going forward, including for the purposes of calculating the relevant spot index value and the cash settlement value as described above under Cash Settlement Value and determining whether a market disruption event exists.

If an index sponsor or any third party publisher discontinues publication of its respective index and that index sponsor or a third party publisher publishes a successor or substitute index that the calculation agent determines, in its sole discretion, to be comparable to that index (a successor index), then, upon the calculation agent's notification of any such determination to us and the trustee, the successor index will be used as a substitute for the relevant index for all purposes going forward, including for the purposes of calculating the relevant spot index value and the cash settlement value as described above under Cash Settlement Value and determining whether a market disruption event exists as described below under Market Disruption Event, even if the index sponsor or a third party publisher elects to begin republishing the relevant index, unless the calculation agent in its sole discretion decides to use such republished index. Upon any selection by the calculation agent of a successor index, we shall cause notice to be given to holders of the warrants.

If an index sponsor or a third party publisher discontinues publication of its respective index or any successor index, as applicable, and the calculation agent determines that no other successor index is available at that time, then on each trading day until the earlier to occur of:

the valuation date in connection with the automatic exercise of the warrants; or

a determination by the calculation agent that a successor index is available, the calculation agent will calculate a substitute level for the relevant index or the successor index in accordance with the procedures last used to calculate the level of the relevant index or the successor index, as applicable, before such discontinuation but using only those stocks that composed the relevant index or the successor index, as applicable, prior to the discontinuation. If the calculation agent calculates a level as a substitute for the relevant index or any successor index as described above, such level will be used as a substitute for the relevant index or the successor index for all purposes going forward, including for the purposes of calculating the relevant spot index value and the cash settlement value as described above under Cash Settlement Value and determining whether a market disruption event exists, even if the index sponsor or a third party publisher elects to begin republishing the relevant index or any successor index, as applicable, unless the calculation agent in its sole discretion decides to use such republished index or successor index. The calculation agent will cause notice of each level to be published not less often than once each month in *The Wall Street Journal* or another newspaper of general circulation in New York City, and arrange for information with respect to these levels to be made available by telephone.

Notwithstanding these alternative arrangements, discontinuation of the publication of either index or any successor index would be expected to adversely affect the market value of, liquidity of and trading in the warrants.

If at any time the formula for, or method of calculating, the level of either index or the level of any successor index changes in any material respect, or if either index or such successor index is in any other way modified so that the relevant index or the successor index does not, in the opinion of the calculation agent, fairly represent the level of the relevant index or the successor index had those changes or modifications not been made, then, from and after that time, the calculation agent shall, at the close of business in The City of New York, NY on each valuation date that the closing level of the relevant index or the successor index is to be

calculated (or at the opening of business on the valuation date when the special opening quotation of the relevant index or the successor index is to be calculated), make any adjustments as, in the good faith judgment of the calculation agent, may be necessary in order to arrive at a calculation of a level of a stock index comparable to the relevant index or the successor index, as the case may be, as if those changes or modifications had not been made, and calculate the closing level (or, if applicable, the special opening quotation) with reference to the relevant index or the successor index, as so adjusted. For example, if the method of calculating the S&P 500 or a successor index is modified and has a dilutive or concentrative effect on the level of the S&P 500 or successor index, e.g., due to a split, then the calculation agent shall adjust the S&P 500 or successor index in order to arrive at a level of the S&P 500 or successor index as if it had not been modified, e.g., as if a split had not occurred.

Neither we nor the calculation agent will have any responsibility for good faith errors or omissions in calculating or disseminating information regarding either index or any successor index, or as to adjustments or calculations by the calculation agent (as provided above) in order to arrive at the level of the relevant index or any successor index.

## **Market Disruption Event**

A market disruption event with respect to the S&P 500, the Russell 2000 or any successor index, as determined by the calculation agent in its sole discretion, means (i) a relevant exchange or any related exchange fails to open for trading during its regular trading session or (ii) the occurrence or existence of any of the following events:

a trading disruption, if the calculation agent determines it is material, at any time during the one-hour period that ends at the close of trading for a relevant exchange or related exchange,

an exchange disruption, if the calculation agent determines it is material, at any time during the one-hour period that ends at the close of trading for a relevant exchange or related exchange, or

an early closure,

*provided* that such events will not be deemed a market disruption event if the calculation agent determines in its sole discretion that any such event has not materially interfered with the ability of us or our affiliates to unwind or adjust all or a material portion of our hedge position with respect to the warrants.

The following events will not be a market disruption event:

a limitation on the hours or number of days of trading on a relevant exchange or any related exchange, but only if the limitation results from an announced change in the regular business hours of the relevant market; or

a decision to permanently discontinue trading in the option or futures contracts relating to the relevant index or any successor index or any of the underlying stocks included in the relevant index or any successor index.

For the purposes of determining whether a market disruption event with respect to the S&P 500, the Russell 2000 or any successor index exists at any time, if a market disruption event occurs in respect of a stock included in the relevant index or any successor index at any time, then the relevant percentage contribution of that stock to the level of the relevant index or any successor index shall be based on a comparison of (i) the portion of the level of the relevant index or any successor index attributable to that stock and (ii) the overall level of the relevant index or any successor index, in each case immediately before the occurrence of the market disruption event.

A trading disruption means, with respect to either the S&P 500 or the Russell 2000, any suspension of or limitation imposed on trading by the relevant exchange or related exchange or otherwise, whether by reason of movements in price exceeding limits permitted by the relevant exchange or related exchange or otherwise, (i) relating to stocks that compose 20 percent or more of the level of the relevant index or any successor index or (ii) in options contracts or futures contracts relating to the relevant index or any successor index on any relevant related exchange.

An **exchange disruption** means, with respect to either the S&P 500 or the Russell 2000, any event (other than a scheduled early closure) that disrupts or impairs (as determined by the calculation agent in its sole discretion) the ability of market participants in general to (i) effect transactions in or obtain market values on any relevant exchange or related exchange in stocks that compose 20 percent or more of the level of the relevant index or any successor index or (ii) effect transactions in options contracts or futures contracts relating to the relevant index or any successor index on any relevant related exchange.

An **early closure** means, with respect to either the S&P 500 or the Russell 2000, the closure on any exchange business day of any relevant exchange relating to stocks that compose 20 percent or more of the level of the relevant index or any successor index or any related exchange prior to its normally scheduled closing time unless the earlier closing time is announced by that exchange or related exchange at least one hour prior to the earlier of (i) the actual closing time for the regular trading session on the exchange or related exchange on that exchange business day and (ii) the submission deadline for orders to be entered into the relevant exchange system for execution at the close of trading on that exchange business day.

An **exchange business day** means any trading day on which each exchange and related exchange is open for business during its regular trading session, notwithstanding any exchange or related exchange closing prior to its scheduled weekday closing time, without regard to after hours or other trading outside its regular trading session hours.

Certain market disruption events may be events that would tend to decrease the level of the indices and any successor indices and accordingly decrease the cash settlement value for the warrants following the occurrence of any such market disruption event. However, as a result of any postponed exercise as described above, warrant holders would not receive such cash settlement value, but would receive instead a cash settlement value determined as of a later date. In any such case, any immediate impact of the related market disruption event on the relevant index or any successor index may have been negated by interim market and other developments and, as a result of any such postponement, the cash settlement value actually received by warrant holders may be substantially different than the otherwise applicable cash settlement value if the valuation of the warrants had not been postponed.

## **Form of Warrants**

Upon issuance, the warrants will be represented by fully registered global warrants deposited with, or on behalf of DTC, as depositary, and registered in the name of a nominee of DTC. Accordingly, we will recognize only DTC's nominee as the holder of the warrants.

Except in certain limited circumstances described in the accompanying prospectus under **Global Securities**, and except in the event of certain bankruptcy or insolvency events involving us, ownership of the warrants in certificated form will not be available to investors.

## **Listing**

We have applied to list the warrants on the AMEX, subject to meeting listing requirements. The proposed trading symbol for the warrants on the AMEX is **RWP.WS**. We cannot predict whether or when the AMEX will approve our application or whether this offering will satisfy the listing criteria of the AMEX. If the warrants are not accepted for listing on the AMEX, or if the warrants are accepted for listing on the AMEX but subsequently delisted from, or permanently suspended from trading on, the AMEX, the warrants will not be listed or displayed on any other securities exchange, the Nasdaq Stock Market or any electronic communications network. In such a case, it is possible that no active trading market for the warrants will exist. If the warrants are accepted for listing on the AMEX, we make no representation that the warrants will remain listed for the entire term of the warrants.

## **Delisting of Warrants**

In addition to the exercise events specified above under **Exercise of Warrants**, if, prior to the expiration date, the warrants are delisted from, or permanently suspended from trading on (within the meaning of the

Securities Exchange Act of 1934) the AMEX, and, subsequent to such delisting or trading suspension the warrants are not listed or quoted on another organized securities market in the United States within five trading days of the effective date of such delisting or trading suspension, warrants not previously exercised will be deemed automatically exercised on that fifth trading day (such day, the delisting automatic exercise date ). We will not voluntarily cause any such delisting or trading suspension.

In such event, for each warrant not previously exercised, you will receive the greater of (i) the cash settlement value of such automatically exercised warrants, if any, (calculated as if such delisting automatic exercise date were the expiration date) and (ii) the market value of the warrants on the valuation date, as determined by the calculation agent as if the warrants had not been required to be automatically exercised. The cash settlement date for such automatically exercised warrants will be the fifth trading day after the valuation date. We will notify warrant holders as soon as practicable of any such delisting or trading suspension.

We have obtained all information regarding the S&P 500<sup>®</sup> Index (the S&P 500 ) contained in this pricing supplement, including its make-up, method of calculation and changes in its components, from publicly available information. That information reflects the policies of, and is subject to change by, Standard & Poor's, a division of The McGraw-Hill Companies, Inc. Standard & Poor's has no obligation to continue to publish, and may discontinue publication of, the S&P 500. We do not assume any responsibility for the accuracy or completeness of such information. Standard & Poor's, S&P 500, Standard & Poor's 500 and 500 are trademarks of The McGraw-Hill Companies, Inc. and have been licensed by WBNA, its subsidiaries and affiliates.

The S&P 500 is determined, comprised and calculated by Standard & Poor's without regard to the warrants. The S&P 500 is intended to indicate the pattern of common stock price movement, focusing on the large capitalization sector of the market. Beginning on March 18, 2005, Standard & Poor's shifted from a market capitalization-weighted formula to a half float-adjusted formula, and as of September 16, 2005, Standard & Poor's shifted to a full float-adjusted formula, as described in further detail below. With a float-adjusted index, the share counts used in calculating the S&P 500 will reflect only those shares that are available to investors, not all of a company's outstanding shares. Float adjustment excludes shares that are closely held by other publicly traded companies, control groups or government agencies. Moreover, treasury stock, stock options, restricted shares, equity participation units, warrants, preferred stock, convertible stock, and rights are not part of the float.

As of December 31, 2006, 422 companies or 85.6% of the S&P 500 traded on the New York Stock Exchange and 78 companies or 14.4% of the S&P 500 traded on The Nasdaq Stock Market. As of December 31, 2006, the aggregate market value of the 500 companies included in the S&P 500 represented approximately 74% of the aggregate market value of stocks included in the Standard & Poor's Stock Guide Database of domestic common stocks traded in the United States, excluding American depositary receipts and shares of real estate investment trusts, limited partnerships and mutual funds. Standard & Poor's chooses companies for inclusion in the S&P 500 with the aim of achieving a distribution by broad industry groupings that approximates the distribution of these groupings in the common stock population of the New York Stock Exchange, which Standard & Poor's uses as an assumed model for the composition of the total market. Relevant criteria employed by Standard & Poor's include the viability of the particular company, the extent to which that company represents the industry group to which it is assigned, the extent to which the market price of that company's common stock is generally responsive to changes in the affairs of the respective industry and the market value and trading activity of the common stock of that company. Ten main groups of companies compose the S&P 500 with the number of companies as of March 16, 2007 included in each group indicated in parentheses: consumer discretionary (89), consumer staples (38), energy (33), financials (88), health care (55), industrials (52), information technology (75), materials (29), telecommunication services (9) and utilities (32). Standard & Poor's may from time to time, in its sole discretion, add companies to, or delete companies from, the S&P 500 to achieve the objectives stated above.

*The level of the S&P 500 at any time does not reflect the payment of dividends on the stocks included in the S&P 500 (each, an S&P 500 component stock). Because of this factor, the return on the warrants will not be the same as the return you would receive if you were to purchase these stocks and hold them for a period equal to the term of the offered warrants.*

**Computation of the S&P 500**

Standard & Poor's currently uses a full float-adjusted formula to compute the S&P 500 as of a particular time. Specifically, the float-adjusted S&P 500 is equal to the quotient of (i) the sum of the products of (x) the price of each S&P 500 component stock, (y) the total shares outstanding of each S&P 500 component stock and (z) the investable weight factor, and (ii) the index divisor. The investable weight factor equals the quotient of the available float shares of an S&P 500 component stock and the total shares outstanding of that S&P 500 component stock. In turn, the available float shares equals the total shares outstanding less shares that are closely held by other publicly traded companies, control groups or government agencies, where the shares held by the individuals in those aforementioned groups exceeds 10% of the outstanding shares. ### **Computation of the Russell 2000**

As a capitalization-weighted index, the Russell 2000 reflects changes in the capitalization, or market value, of the Russell 2000 component stocks relative to their capitalization on a base date. The current Russell 2000 value is calculated by adding the market values of the Russell 2000 component stocks, which are derived by multiplying the price of each stock by the number of available shares, to arrive at the total market capitalization of the 2,000 stocks. The total market capitalization is then divided by a divisor, which represents the adjusted capitalization of the Russell 2000 on the base date of December 31, 1986. **Exceptions** There may be corporate events, like mergers or acquisitions, that result in the lack of current market price for the deleted stock and in such an instance the latest primary exchange closing price available will be used.

**Rule for Additions** The only additions between reconstitution dates are as a result of spin-offs. Spin-off companies are added to the parent company's index and capitalization tier of membership, if the spin-off is large enough. **Table of Contents****CERTAIN U.S. FEDERAL INCOME TAX CONSIDERATIONS**

*The following summary is based on the advice of Davis Polk & Wardwell, our special tax counsel, and is a general discussion of the principal potential U.S. federal income tax consequences to initial holders of the warrants that purchase the warrants at the offering price and that will hold the warrants as capital assets within the meaning of Section 1221 of the Internal Revenue Code (the Code). This summary is based on the Code, existing and proposed Treasury regulations, revenue rulings, administrative interpretations and judicial decisions, all as currently in effect and all of which are subject to change, possibly with retroactive effect. This summary does not address all aspects of the U.S. federal income tax laws that may be relevant to you in light of your individual circumstances or if you are a holder subject to special treatment under the U.S. federal income tax laws (e.g., certain financial institutions, tax-exempt organizations, dealers and certain traders in securities, partnerships or other entities classified as partnerships for U.S. federal income tax purposes, persons holding a warrant as part of a hedging transaction, straddle, synthetic security, conversion transaction or other integrated transaction, U.S. Holders (as defined below) whose functional currency is not the U.S. dollar, regulated investment companies, real estate investment trusts, persons subject to the alternative minimum tax, or Non-U.S. Holders for whom income or gain in respect of the warrants is effectively connected with the conduct of a trade or business in the United States). As the law applicable to the U.S. federal income taxation of the warrants is technical and complex, the discussion below necessarily represents only a general summary. Moreover, the discussion below does not address the effect of any applicable state, local or foreign tax laws.*

In the opinion of Davis Polk & Wardwell, although there is no authority directly on point, the warrants should be treated as a nonequity options that are subject to the special mark-to-market rules under Section 1256 of the Code. Except as otherwise noted below under Alternative Characterization, this discussion assumes that the warrants will be so treated. This discussion also assumes that the warrants are listed on the AMEX and will not be delisted. You should consult your tax advisor about investing in the warrants if they are not listed on the AMEX or are subsequently delisted because the tax consequences could differ significantly from those described herein.

*No statutory, judicial or administrative authority directly discusses how the warrants should be treated for U.S. federal income tax purposes. As a result, the U.S. federal income tax consequences of your investment in the warrants are uncertain, and no assurance can be given that the Internal Revenue Service (the IRS) or a court will agree with the characterization described herein. Accordingly, we urge you to consult your tax advisor in determining the tax consequences of an investment in the warrants, including the application of state, local or other tax laws and the possible effects of changes in federal or other tax laws.*

**U.S. Holders.** This section only applies to you if you are a U.S. Holder. As used herein, the term U.S. Holder means, for U.S. federal income tax purposes, a beneficial owner of a warrant that is (i) a citizen or resident of the United States, (ii) a corporation created or organized under the laws of the United States or any political subdivision thereof or (iii) an estate or trust the income of which is subject to U.S. federal income taxation regardless of its source. The term U.S. Holder also includes certain former citizens and residents of the United States.

Under the mark-to-market rules, you are required to recognize gain or loss in each taxable year equal to the difference between the fair market value of your warrants on the last trading day of each taxable year (as determined by the warrants trading price) and your tax basis in the warrants you hold. Your tax basis in your warrants will equal the amount you paid for your warrants plus or minus the net gain or loss recognized by you under the mark-to-market rules in respect of your warrants in prior taxable years. As a result of the application of this mark-to-market rule, you may incur U.S. federal income tax liability on an annual basis in respect of an increase in the value of the warrants without the receipt of cash attributable thereto.

Upon the sale, exercise (whether at your option or automatically) or expiration of a warrant, you will recognize gain or loss equal to the difference between the amount realized, if any, and your tax basis in the warrant.

Any gain or loss with respect to the warrants (either as a result of an annual marking-to-market or on a sale, exercise or expiration of the warrants) will be 60% long-term capital gain or loss and 40% short-term capital gain or loss. Long-term capital gain of a noncorporate U.S. Holder is generally taxed at a maximum rate of 15%. The deductibility of capital losses is subject to limitations.

*Alternative Characterization.* Because there is no authority that specifically addresses the tax treatment of the warrants, it is possible that the warrants could be treated differently for U.S. federal income tax purposes, in which case the tax consequences of your investment in the warrants could differ significantly from the treatment described above. For example, it is possible that a warrant could be treated as a derivative contract with respect to the relative performance of the indices that is not subject to the mark-to-market rules under Section 1256 of the Code. If the warrants are so treated, you generally should recognize capital gain or loss upon the sale, exercise or expiration of your warrants in an amount equal to the difference between the amount you receive at such time and your tax basis in the warrants. In general, your tax basis in your warrants would be equal to the price you paid for them. Such capital gain or loss would be long-term capital gain or loss if you held your warrants for more than one year and, otherwise, would be short-term capital gain or loss. As discussed above, long-term capital gain of a noncorporate U.S. Holder is subject to preferential rates.

A Non-U.S. Holder does not include an individual who is present in the United States for 183 days or more in the taxable year in which the warrants are exercised or sold and who is not otherwise a resident of the United States for U.S. federal income tax purposes. Such an individual is urged to consult his or her own tax advisor regarding the U.S. federal income tax consequences of investing in the warrants.

If the warrants are treated as discussed above and you are a Non-U.S. Holder, you will not be subject to U.S. withholding tax with respect to payments on your warrants, but you may be subject to generally applicable information reporting and backup withholding requirements with respect to payments on your warrants, as described below, unless you comply with certain certification and identification requirements as to your foreign status.

*Information Reporting and Backup Withholding.* Information returns may be filed with the IRS in connection with amounts received in respect of the warrants, unless you are exempt from information reporting. You may be subject to U.S. backup withholding on these amounts if you fail to provide your taxpayer identification number to the appropriate paying agent and comply with certain certification procedures or otherwise establish an exemption from backup withholding. The amount of any backup withholding from a payment on your warrants will be allowed as a credit against your U.S. federal income tax liability and may entitle you to a refund, provided that the required information is furnished to the IRS.

**EMPLOYEE RETIREMENT INCOME SECURITY ACT**

A fiduciary of a pension, profit-sharing or other employee benefit plan (a plan) subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA), should consider the fiduciary standards of ERISA in the context of the plan's particular circumstances before authorizing an investment in the warrants. Accordingly, among other factors, the fiduciary should consider whether the investment would satisfy the prudence and diversification requirements of ERISA and would be consistent with the documents and instruments governing the plan, and whether the investment would involve a prohibited transaction under Section 406 of ERISA or Section 4975 of the Internal Revenue Code (the Code).

A violation of these prohibited transaction rules may result in civil penalties or other liabilities under ERISA and/or an excise tax under Section 4975 of the Code for those persons, unless exemptive relief is available under an applicable statutory, regulatory or administrative exemption. Certain employee benefit plans and arrangements including those that are governmental plans (as defined in section 3(32) of ERISA), certain church plans (as defined in Section 3(33) of ERISA) and foreign plans (as described in Section 4(b)(4) of ERISA) (non-ERISA arrangements) are not subject to the requirements of ERISA or Section 4975 of the Code but may be subject to similar provisions under applicable federal, state, local, foreign or other regulations, rules or laws (similar laws).

The acquisition and exercise of the warrants by a plan with respect to which Wachovia, Wachovia Securities or certain of our affiliates is or becomes a party in interest may constitute or result in a prohibited transaction under ERISA or Section 4975 of the Code, unless those warrants are acquired and exercised pursuant to and in accordance with an applicable exemption. Section 408(b)(17) of the Code provides an exemption for the purchase and sale of securities where neither Wachovia nor any of its affiliates have or exercise any discretionary authority or control or render any investment advice with respect to the assets of the plan involved in the transaction and the plan pays no more than adequate consideration in connection with the transaction (the service provider exemption). Moreover, the United States Department of Labor has issued five prohibited transaction class exemptions, or PTCEs, that may provide exemptive relief if required for direct or indirect prohibited transactions that may arise from the purchase, holding or exercise of the warrants. These exemptions are:

PTCE 84-14, an exemption for certain transactions determined or effected by independent qualified professional asset managers;

PTCE 90-1, an exemption for certain transactions involving insurance company pooled separate accounts;

PTCE 91-38, an exemption for certain transactions involving bank collective investment funds;

PTCE 95-60, an exemption for transactions involving certain insurance company general accounts; and

PTCE 96-23, an exemption for plan asset transactions managed by in-house asset managers.

The warrants may not be purchased, held or exercised by (1) any plan, (2) any entity whose underlying assets include plan assets by reason of any plan's investment in the entity (a plan asset entity) or (3) any person investing plan assets of any plan, unless in each case the purchaser or holder is eligible for the exemptive relief available under one or more of the PTCEs listed above, the service provider exemption or another applicable similar exemption. Any purchaser or holder of the warrants or any interest in the warrants will be deemed to have represented by its purchase, holding and exercise of the warrants that it either (1) is not a plan or a plan asset entity and is not purchasing or exercising those warrants on behalf of or with plan assets of any plan or plan asset entity or (2) with respect to the purchase, holding and exercise, is eligible for the exemptive relief available under any of the PTCEs listed above, the service provider exemption or another

applicable exemption. In addition, any purchaser or holder of the warrants or any interest in the warrants which is a non-ERISA arrangement will be deemed to have represented by its purchase, holding and exercise of the warrants that its purchase, holding and exercise will not violate the provisions of any similar law.

Due to the complexity of these rules and the penalties that may be imposed upon persons involved in non-exempt prohibited transactions, it is important that fiduciaries or other persons considering purchasing the warrants on behalf of or with plan assets of any plan, plan asset entity or non-ERISA arrangement consult with their counsel regarding the availability of exemptive relief under any of the PTCs listed above, the service provider exemption or any other applicable exemption, or the potential consequences of any purchase, holding or exercise under similar laws, as applicable.

If you are an insurance company or the fiduciary of a pension plan or an employee benefit plan, and propose to invest in the warrants, you should consult your legal counsel.

Clearstream, as named in the applicable supplements. Each sale of a security in book-entry form will settle in immediately available funds through the depository, unless otherwise stated in the applicable supplements. We will issue securities only in registered form unless the applicable supplements state otherwise.

**Payment Currencies**

Amounts payable in respect of the securities, including the purchase price, will be payable in U.S. dollars unless the applicable supplements state otherwise.

**Listing**

If any securities are to be listed or quoted on a securities exchange or quotation system, the applicable supplements will say so.

**Use of Proceeds**

We intend to use the proceeds of the offerings of securities for general corporate purposes.

**RISK FACTORS**

**Our Credit Ratings May Not Reflect All Risks of An Investment in the Securities**

The credit ratings of our medium-term note program may not reflect the potential impact of all risks related to structure and other factors on any trading market for, or trading value of, your notes. The warrants are contractual obligations of Wachovia Corporation and will rank equally with our other unsecured and unsubordinated debt and contractual obligations. In addition, real or anticipated changes in our credit ratings will generally effect any trading market for, or trading value of, your notes and your warrants.

**Risks Relating to Indexed Securities**

We use the term *indexed securities* to mean securities whose value is linked to an underlying property or index. Indexed securities may present a high level of risk, and those who invest in indexed securities may lose their entire investment. In addition, the treatment of indexed securities for U.S. federal income tax purposes is often unclear due to the absence of any authority specifically addressing the issues presented by any particular indexed security. Thus, if you propose to invest in indexed securities, you should independently evaluate the federal income tax consequences of purchasing an indexed security that apply in your particular circumstances. You should also read *United States Taxation* for a discussion of U.S. tax matters.

***Investors in Indexed Securities Could Lose Their Investment***

The amount of principal and/or interest payable on an indexed note, the cash value or physical settlement value of a physically settled note and the cash value or physical settlement value of an indexed warrant will be determined by reference to the performance, price, level or value of one or more securities, currencies, commodities or other properties, any other financial, economic or other measure or instrument, including the occurrence or non-occurrence of any event or circumstance, and/or one or more indices or baskets of any of these items. We refer to each of these as an *index*. The direction and magnitude of the change in the price, value or level of the relevant index will determine the amount of principal and/or interest payable on an indexed note, the cash value or physical settlement value of a physically settled note and the cash value or physical settlement value of an indexed warrant. The terms of a particular indexed note may or may not include a guaranteed return of a percentage of the face amount at maturity or a minimum interest rate. An indexed warrant generally will not provide for any guaranteed minimum settlement value and may expire worthless. Thus, if you purchase an indexed security, you may lose all or a portion of the principal or other amount you invest and may receive no return on your investment.

***The Issuer of a Security or Currency That Serves as an Index Could Take Actions That May Adversely Affect an Indexed Security***

The issuer of a security that serves as an index or part of an index for an indexed security will have no involvement in the offer and sale of the indexed security and no obligations to the holder of the indexed security. The issuer may take actions, such as a merger or sale of assets, without regard to the interests of the holder. Any of these actions could adversely affect the value of a security indexed to that security or to an index of which that security is a component.

If the index for an indexed security includes a non-U.S. dollar currency or other asset denominated in a non-U.S. dollar currency, the government that issues that currency will also have no involvement in the offer and sale of the indexed security and no obligations to the holder of the indexed security. That government may take actions that could adversely affect the value of the security. See *Risks Relating to Securities Denominated or Payable in or Linked to a Non-U.S. Dollar Currency* below for more information about these kinds of government actions.

### ***An Indexed Security May Be Linked to a Volatile Index, Which Could Hurt Your Investment***

Some indices are highly volatile, which means that their value may change significantly, up or down, over a short period of time. The amount of principal or interest that can be expected to become payable on an indexed security or the expected settlement value of an indexed warrant may vary substantially from time to time. Because the amounts payable with respect to an indexed security are generally calculated based on the value or level of the relevant index on a specified date or over a limited period of time, volatility in the index increases the risk that the return on the indexed security may be adversely affected by a fluctuation in the level of the relevant index.

The volatility of an index may be affected by political or economic events, including governmental actions, or by the activities of participants in the relevant markets. Any of these events or activities could adversely affect the value of an indexed security.

### ***An Index to Which a Security Is Linked Could Be Changed or Become Unavailable***

Some indices compiled by us or our affiliates or third parties may consist of or refer to several or many different securities, commodities or currencies or other instruments or measures. The compiler of such an index typically reserves the right to alter the composition of the index and the manner in which the value or level of the index is calculated. An alteration may result in a decrease in the value of or return on an indexed security that is linked to the index. The indices for our indexed securities may include published indices of this kind or customized indices developed by us or our affiliates in connection with particular issues of indexed securities.

A published index may become unavailable, or a customized index may become impossible to calculate in the normal manner, due to events such as war, natural disasters, cessation of publication of the index or a suspension or disruption of trading in one or more securities, commodities or currencies or other instruments or measures on which the index is based. If an index becomes unavailable or impossible to calculate in the normal manner, the terms of a particular indexed security may allow us to delay determining the amount payable as principal or interest on an indexed note or the settlement value of an indexed warrant, or we may use an alternative method to determine the value of the unavailable index. Alternative methods of valuation are generally intended to produce a value similar to the value resulting from reference to the relevant index. However, it is unlikely that any alternative method of valuation we use will produce a value identical to the value that the actual index would produce. If we use an alternative method of valuation for a security linked to an index of this kind, the value of the security, or the rate of return on it, may be lower than it otherwise would be.

Some indexed securities are linked to indices that are not commonly used or that have been developed only recently. The lack of a trading history may make it difficult to anticipate the volatility or other risks associated with an indexed security of this kind. In addition, trading in these indices or their underlying stocks, commodities or currencies or other instruments or measures, or options or futures contracts on these stocks, commodities or currencies or other instruments or measures, may be limited, which could increase their volatility and decrease the value of the related indexed securities or the rates of return on them.

### ***We May Engage in Hedging Activities that Could Adversely Affect an Indexed Security***

In order to hedge an exposure on a particular indexed security, we may, directly or through our affiliates, enter into transactions involving the securities, commodities or currencies or other instruments or measures that underlie the index for that security, or derivative instruments, such as swaps, options or futures, on the index or any of its component items. By engaging in transactions of this kind, we could adversely affect the value of an indexed security. It is possible that we could achieve substantial returns from our hedging transactions while the value of the indexed security may decline.

### ***Information About Indices May Not Be Indicative of Future Performance***

If we issue an indexed security, we may include historical information about the relevant index in the applicable supplements. Any information about indices that we may provide will be furnished as a matter of information only, and you should not regard the information as indicative of the range of, or trends in, fluctuations in the relevant index that may occur in the future.

### ***We May Have Conflicts of Interest Regarding an Indexed Security***

Wachovia Securities and our other affiliates may have conflicts of interest with respect to some indexed securities. Wachovia Securities and our other affiliates may engage in trading, including trading for hedging purposes, for their proprietary accounts or for other accounts under their management, in indexed securities and in the securities, commodities or currencies or other instruments or measures on which the index is based or in other derivative instruments related to the index or its component items. These trading activities could adversely affect the value of indexed securities. We and our affiliates may also issue or underwrite securities or derivative instruments that are linked to the same index as one or more indexed securities. By introducing competing products into the marketplace in this manner, we could adversely affect the value of an indexed security.

Wachovia Bank, National Association, Wachovia Securities or another of our affiliates may serve as calculation agent for the indexed securities and may have considerable discretion in calculating the amounts payable in respect of the securities. To the extent that Wachovia Bank, National Association, Wachovia Securities or another of our affiliates calculates or compiles a particular index, it may also have considerable discretion in performing the calculation or compilation of the index. Exercising discretion in this manner could adversely affect the value of an indexed security based on the index or the rate of return on the security.

### **Risks Relating to Securities Denominated or Payable in or Linked to a Non-U.S. Dollar Currency**

If you intend to invest in a non-U.S. dollar security e.g., a security whose principal and/or interest is payable in a currency other than U.S. dollars or that may be settled by delivery of or reference to a non-U.S. dollar currency or property denominated in or otherwise linked to a non-U.S. dollar currency you should consult your own financial and legal advisors as to the currency risks entailed by your investment. Securities of this kind may not be an appropriate investment for investors who are unsophisticated with respect to non-U.S. dollar currency transactions.

### ***An Investment in a Non-U.S. Dollar Security Involves Currency-Related Risks***

An investment in a non-U.S. dollar security entails significant risks that are not associated with a similar investment in a security that is payable solely in U.S. dollars and where settlement value is not otherwise based on a non-U.S. dollar currency. These risks include the possibility of significant changes in rates of exchange between the U.S. dollar and the various non-U.S. dollar currencies or composite currencies and the possibility of the imposition or modification of foreign exchange controls or other conditions by either the United States or non-U.S. governments. These risks generally depend on factors over which we have no control, such as economic and political events and the supply of and demand for the relevant currencies in the global markets.

### ***Changes in Currency Exchange Rates Can Be Volatile and Unpredictable***

Rates of exchange between the U.S. dollar and many other currencies have been highly volatile, and this volatility may continue and perhaps spread to other currencies in the future. Fluctuations in currency exchange rates could adversely affect an investment in a security denominated in, or whose value is otherwise linked to, a specified currency other than U.S. dollars. Depreciation of the specified currency against the U.S. dollar could result in a decrease in the U.S. dollar-equivalent value of payments on the security, including the principal payable at maturity or settlement value payable upon exercise. That in turn could cause the market

value of the security to fall. Depreciation of the specified currency against the U.S. dollar could result in a loss to the investor on a U.S. dollar basis.

***Government Policy Can Adversely Affect Currency Exchange Rates and an Investment in a Non-U.S. Dollar Security***

Currency exchange rates can either float or be fixed by sovereign governments. From time to time, governments use a variety of techniques, such as intervention by a country's central bank or imposition of regulatory controls or taxes, to affect the exchange rate of their currencies. Governments may also issue a new currency to replace an existing currency or alter the exchange rate or exchange characteristics by devaluation or revaluation of a currency. Thus, a special risk in purchasing non-U.S. dollar securities is that their yields or payouts could be significantly and unpredictably affected by governmental actions. Even in the absence of governmental action directly affecting currency exchange rates, political or economic developments in the country issuing the specified currency for a non-U.S. dollar security or elsewhere could lead to significant and sudden changes in the exchange rate between the U.S. dollar and the specified currency. These changes could affect the value of the security as participants in the global currency markets move to buy or sell the specified currency or U.S. dollars in reaction to these developments.

Governments have imposed from time to time and may in the future impose exchange controls or other conditions, including taxes, with respect to the exchange or transfer of a specified currency that could affect exchange rates as well as the availability of a specified currency for a security at its maturity or on any other payment date. In addition, the ability of a holder to move currency freely out of the country in which payment in the currency is received or to convert the currency at a freely determined market rate could be limited by governmental actions.

***Non-U.S. Dollar Securities May Permit Us to Make Payments in U.S. Dollars or Delay Payment If We Are Unable to Obtain the Specified Currency***

Securities payable in a currency other than U.S. dollars may provide that, if the other currency is subject to convertibility, transferability, market disruption or other conditions affecting its availability at or about the time when a payment on the securities comes due because of circumstances beyond our control, we will be entitled to make the payment in U.S. dollars or delay making the payment. These circumstances could include the imposition of exchange controls or our inability to obtain the other currency because of a disruption in the currency markets. If we made payment in U.S. dollars, the exchange rate we would use would be determined in the manner described below under Description of Notes We May Offer or Description of the Warrants We May Offer under the subheading Payment Mechanics How We Will Make Payments Due in Other Currencies When the Specified Currency Is Not Available. A determination of this kind may be based on limited information and would involve significant discretion on the part of our foreign exchange agent. As a result, the value of the payment in U.S. dollars an investor would receive on the payment date may be less than the value of the payment the investor would have received in the other currency if it had been available, or may be zero. In addition, a government may impose extraordinary taxes on transfers of a currency. If that happens we will be entitled to deduct these taxes from any payment on Securities payable in that currency.

***We Will Not Adjust Non-U.S. Dollar Securities to Compensate for Changes in Currency Exchange Rates***

Except as described above, we will not make any adjustment or change in the terms of a non-U.S. dollar security in the event of any change in exchange rates for the relevant currency, whether in the event of any devaluation, revaluation or imposition of exchange or other regulatory controls or taxes or in the event of other developments affecting that currency, the U.S. dollar or any other currency. Consequently, investors in non-U.S. dollar Securities will bear the risk that their investment may be adversely affected by these types of events.

***In a Lawsuit for Payment on a Non-U.S. Dollar Security, an Investor May Bear Currency Exchange Risk***

Our notes and warrants will be governed by New York law. Under Section 27 of the New York Judiciary Law, a state court in the State of New York rendering a judgment on a security denominated in a currency

other than U.S. dollars would be required to render the judgment in the specified currency; however, the judgment would be converted into U.S. dollars at the exchange rate prevailing on the date of entry of the judgment. Consequently, in a lawsuit for payment on a security denominated in a currency other than U.S. dollars, investors would bear currency exchange risk until judgment is entered, which could be a long time.

In courts outside of New York, investors may not be able to obtain judgment in a specified currency other than U.S. dollars. For example, a judgment for money in an action based on a non-U.S. dollar security in many other U.S. federal or state courts ordinarily would be enforced in the United States only in U.S. dollars. The date used to determine the rate of conversion of the currency in which any particular security is denominated into U.S. dollars will depend upon various factors, including which court renders the judgment.

***Information About Exchange Rates May Not Be Indicative of Future Performance***

If we issue a non-U.S. dollar security, we may include in the applicable supplements a currency supplement that provides information about historical exchange rates for the relevant non-U.S. dollar currency or currencies. Any information about exchange rates that we may provide will be furnished as a matter of information only, and you should not regard the information as indicative of the range of, or trends in, fluctuations in currency exchange rates that may occur in the future. That rate will likely differ from the exchange rate used under the terms that apply to a particular security.

**WACHOVIA CORPORATION**

Wachovia was incorporated under the laws of North Carolina in 1967 and is registered as a financial holding company and a bank holding company under the Bank Holding Company Act. Prior to our merger in September 2001 with the former Wachovia Corporation, Wachovia's name was First Union Corporation. Wachovia provides a wide range of commercial and retail banking and trust services through full-service banking offices in Alabama, California, Connecticut, Delaware, Florida, Georgia, Maryland, New Jersey, New York, North Carolina, Pennsylvania, South Carolina, Tennessee, Texas, Virginia and Washington, D.C. Wachovia also provides various other financial services, including asset and wealth management, mortgage banking, credit card, investment banking, investment advisory, home equity lending, asset-based lending, leasing, insurance, international and securities brokerage services through its subsidiaries.

Wachovia's principal executive offices are located at One Wachovia Center, Charlotte, North Carolina 28288-0013, and our telephone number is (704) 374-6565.

Since the 1985 Supreme Court decision upholding regional interstate banking legislation, Wachovia has concentrated its efforts on building a large, diversified financial services organization, primarily doing business in the eastern region of the United States. Since November 1985, Wachovia has completed over 100 banking-related acquisitions.

Wachovia continually evaluates its operations and organizational structures to ensure they are closely aligned with its goal of maximizing performance in core business lines. When consistent with overall business strategy, Wachovia may consider the disposition of certain assets, branches, subsidiaries or lines of business. While acquisitions are no longer a primary business activity, Wachovia continues to explore routinely acquisition opportunities, particularly in areas that would complement core business lines, and frequently conducts due diligence activities in connection with possible acquisitions. As a result, acquisition discussions and, in some cases, negotiations frequently take place and future acquisitions involving cash, debt or equity securities can be expected.

Wachovia is a separate and distinct legal entity from its banking and other subsidiaries. Dividends received from our subsidiaries are our principal source of funds to pay dividends on our common and preferred stock and debt service on our debt. Various federal and state statutes and regulations limit the amount of dividends that our banking and other subsidiaries may pay to us without regulatory approval.

**USE OF PROCEEDS**

Wachovia currently intends to use the net proceeds from the sale of any security for general corporate purposes, which may include:

reducing debt;

investments at the holding company level;

investing in, or extending credit to, our operating subsidiaries;

acquisitions;

stock repurchases; and

other purposes as mentioned in any pricing supplement.

Pending such use, we may temporarily invest the net proceeds. The precise amounts and timing of the application of proceeds will depend upon our funding requirements and the availability of other funds. Except as mentioned in any pricing supplement, specific allocations of the proceeds to such purposes will not have been made at the date of that pricing supplement.

Based upon our historical and anticipated future growth and our financial needs, we may engage in additional financings of a character and amount that we determine as the need arises.

**REGULATORY CONSIDERATIONS**

As a financial holding company and a bank holding company under the Bank Holding Company Act, the Federal Reserve Board regulates, supervises and examines Wachovia. For a discussion of the material elements of the regulatory framework applicable to financial holding companies, bank holding companies and their subsidiaries and specific information relevant to Wachovia, please refer to Wachovia's annual report on Form 10-K for the fiscal year ended December 31, 2006, and any subsequent reports we file with the SEC, which are incorporated by reference in this prospectus. This regulatory framework is intended primarily for the protection of depositors and the federal deposit insurance funds and not for the protection of security holders. As a result of this regulatory framework, Wachovia's earnings are affected by actions of the Federal Reserve Board, the Office of Comptroller of the Currency, that regulates our banking subsidiaries, the Federal Deposit Insurance Corporation, that insures the deposits of our banking subsidiaries within certain limits, and the SEC, that regulates the activities of certain subsidiaries engaged in the securities business.

Wachovia's earnings are also affected by general economic conditions, our management policies and legislative action.

In addition, there are numerous governmental requirements and regulations that affect our business activities. A change in applicable statutes, regulations or regulatory policy may have a material effect on Wachovia's business.

Depository institutions, like Wachovia's bank subsidiaries, are also affected by various federal laws, including those relating to consumer protection and similar matters. Wachovia also has other financial services subsidiaries regulated, supervised and examined by the Federal Reserve Board, as well as other relevant state and federal regulatory agencies and self-regulatory organizations. Wachovia's non-bank subsidiaries may be subject to other laws and regulations of the federal government or the various states in which they are authorized to do business.

**DESCRIPTION OF THE NOTES WE MAY OFFER**

*The following information outlines some of the provisions of the indentures and the notes. This information may not be complete in all respects, and is qualified entirely by reference to the indenture under which the notes are issued. These indentures are incorporated by reference as exhibits to the registration statement of which this prospectus is a part. This information relates to certain terms and conditions that generally apply to the notes. The specific terms of any series of notes will be described in the applicable supplements. As you read this section, please remember that the specific terms of your note as described in the applicable supplements will supplement and, if applicable, may modify or replace the general terms described in this section. If the applicable supplements are inconsistent with this prospectus, the supplements will control with regard to your note. Thus, the statements we make in this section may not apply to your note.*

**General**

Senior notes will be issued under an indenture, dated as of April 1, 1983, as amended and supplemented, between Wachovia and The Bank of New York (as successor in interest to JPMorgan Chase Bank, National Association), as trustee. Subordinated notes will be issued under an indenture, dated as of March 15, 1986, as amended and supplemented, between Wachovia and The Bank of New York (as successor in interest to J.P. Morgan Trust Company, National Association), as trustee. Each of the senior and the subordinated notes constitutes a single series of debt securities of Wachovia issued under the senior and the subordinated indenture, respectively. The provisions of each indenture allow us not only to issue debt securities with terms different from those of debt securities previously issued under that indenture, but also to reopen a previously issued series of debt securities and issue additional debt securities of that series. The term debt securities, as used in this prospectus, refers to all debt securities, including the notes, issued and issuable from time to time under the relevant indenture. The indentures are subject to, and governed by, the Trust Indenture Act of 1939, as amended. These indentures are more fully described below in this section. Whenever we refer to specific provisions or defined terms in one or both of the indentures, those provisions or defined terms are incorporated in this prospectus by reference. Section references used in this discussion are references to the relevant indenture. Capitalized terms which are not otherwise defined shall have the meaning given to them in the relevant indenture.

The notes will be Wachovia's direct, unsecured obligations. The notes will not be deposits or other bank obligations and will not be FDIC insured.

The notes are being offered on a continuous basis by Wachovia through one or more underwriters, as described under Plan of Distribution. The indentures do not limit the aggregate principal amount of senior or subordinated notes that we may issue. We may, from time to time, without the consent of the holders of the notes, provide for the issuance of notes or other debt securities under the indentures. Each note issued under this prospectus will mature nine months or more from its date of issue, as selected by the purchaser and agreed to by Wachovia and may be subject to redemption or repayment before its stated maturity. Notes may be issued at significant discounts from their principal amount due on the stated maturity (or on any prior date on which the principal or an installment of principal of a note becomes due and payable, whether by the declaration of acceleration, call for redemption at the option of Wachovia, repayment at the option of the holder or otherwise), and some notes may not bear interest. Wachovia may from time to time, without the consent of the existing holders of the relevant notes, create and issue further notes having the same terms and conditions as such notes in all respects, except for the issue date, issue price and, if applicable, the first payment of interest thereon. Additional notes issued in this manner will be consolidated with, and will form a single series with, the previously outstanding notes.

Unless we specify otherwise in the applicable supplements, currency amounts in this prospectus are expressed in United States dollars. Unless we specify otherwise in any note and the applicable supplements, the notes will be denominated in U.S. dollars and payments of principal, premium, if any, and any interest on

the notes will be made in U.S. dollars. If any note is to be denominated other than exclusively in U.S. dollars, or if the principal of, premium, if any, or any interest on the note is to be paid in one or more currencies (or currency units or in amounts determined by reference to an index or indices) other than that in which that note is denominated, additional information (including authorized denominations and related exchange rate information) will be provided in the relevant pricing supplement. Unless we specify otherwise in any pricing supplement, notes denominated in U.S. dollars will be issued in denominations of \$1,000 or any integral multiple of \$1,000.

Interest rates that we offer on the notes may differ depending upon, among other factors, the aggregate principal amount of notes purchased in any single transaction. Notes with different variable terms other than interest rates may also be offered concurrently to different investors. We may change interest rates or formulas and other terms of notes from time to time, but no change of terms will affect any note we have previously issued or as to which we have accepted an offer to purchase.

Each note will be issued as a book-entry note in fully registered form without coupons. Each note issued in book-entry form will be represented by a global note that we deposit with and register in the name of a financial institution or its nominee that we select. The financial institution that we select for this purpose is called the depository. Unless we specify otherwise in the applicable pricing supplement, The Depository Trust Company, New York, New York, will be the depository for all notes in global form. Except as discussed below under [Global Notes](#), owners of beneficial interests in book-entry notes will not be entitled to physical delivery of notes in certificated form. We will make payments of principal of, and premium, if any, and interest, if any, on the notes through the applicable trustee to the depository for the notes. See [Global Notes](#).

The indentures do not limit the aggregate principal amount of debt securities or of any particular series of debt securities which may be issued under the indentures and provide that these debt securities may be issued at various times in one or more series, in each case with the same or various maturities, at par or at a discount. (*Section 301*) The indentures provide that there may be more than one trustee under the indentures with respect to different series of debt securities. At December 31, 2006, \$25.1 billion aggregate principal amount of senior debt securities was outstanding under the senior indenture. The senior trustee is trustee for such series. At December 31, 2006, \$113.5 billion aggregate principal amount of subordinated debt securities was outstanding under the subordinated indenture. The subordinated trustee is trustee for such series.

The indentures do not limit the amount of other debt that Wachovia may issue and do not contain financial or similar restrictive covenants. At December 31, 2006, Wachovia had an aggregate of \$37.0 billion of short-term senior indebtedness outstanding which consisted primarily of commercial paper and other borrowed money. Wachovia expects from time to time to incur additional senior indebtedness and Other Financial Obligations (as defined below). The indentures do not prohibit or limit additional senior indebtedness or Other Financial Obligations.

Because Wachovia is a holding company and a legal entity separate and distinct from its subsidiaries, Wachovia's rights to participate in any distribution of assets of any subsidiary upon its liquidation, reorganization or otherwise, and the ability of the holders of notes to benefit indirectly from such distribution, would be subject to prior creditors' claims, except to the extent that Wachovia itself may be a creditor of that subsidiary with recognized claims. Claims on Wachovia's subsidiary banks by creditors other than Wachovia include long-term debt and substantial obligations with respect to deposit liabilities and federal funds purchased, securities sold under repurchase agreements, other short-term borrowings and various other financial obligations. The indentures do not contain any covenants designed to afford holders of notes protection in the event of a highly leveraged transaction involving Wachovia. Accordingly, Wachovia's obligations under the notes will be effectively subordinated to all existing and future indebtedness and liabilities of Wachovia's subsidiaries, including liabilities under bank products issued by Wachovia's banking subsidiaries, and an investor in notes should look only to Wachovia's assets for payment thereunder.

### **Legal Ownership**

#### ***Street Name and Other Indirect Holders***

Investors who hold their notes in accounts at banks or brokers will generally not be recognized by us as legal holders of notes. This is called holding in street name. Instead, we would recognize only the bank or broker, or the financial institution the bank or broker uses to hold its notes. These intermediary banks, brokers and other financial institutions pass along principal, interest and other payments on the notes, either because they agree to do so in their customer agreements or because they are legally required to do so. If you hold your notes in street name, you should check with your own institution to find out:

how it handles note payments and notices;

whether it imposes fees or charges;

how it would handle voting if it were ever required;

whether and how you can instruct it to send you notes registered in your own name so you can be a direct holder as described below; and

how it would pursue rights under the notes if there were a default or other event triggering the need for holders to act to protect their interests.

#### ***Direct Holders***

Our obligations, as well as the obligations of the trustee and those of any third parties employed by us or the trustee, under the notes run only to persons who are registered as holders of notes. As noted above, we do not have obligations to you if you hold in street name or other indirect means, either because you choose to hold your notes in that manner or because the notes are issued in the form of global securities as described below. For example, once we make payment to the registered holder we have no further responsibility for the payment even if that holder is legally required to pass the payment along to you as a street name customer but does not do so.

#### ***Global Notes***

A global note is a special type of indirectly held security, as described above under *Street Name and Other Indirect Holders* . If we choose to issue notes in the form of global notes, the ultimate beneficial owners of global notes can only be indirect holders. We require that the global note be registered in the name of a financial institution we select.

We also require that the notes included in the global note not be transferred to the name of any other direct holder except in the special circumstances described in the section *Global Securities* . The financial institution that acts as the sole direct holder of the global note is called the depository. Any person wishing to own a global note must do so indirectly by virtue of an account with a broker, bank or other financial institution that in turn has an account with the depository. The applicable supplements indicate whether your series of notes will be issued only in the form of global notes.

Further details of legal ownership are discussed in the section *Global Securities* below.

*In the remainder of this description you or holder means direct holders and not street name or other indirect holders of notes. Indirect holders should read the previous subsection titled *Street Name and Other Indirect Holders* .*

**Types of Notes**

We may issue the four types of notes described below. A note may have elements of each of the four types of notes described below. For example, a note may bear interest at a fixed rate for some periods and at a

floating rate in others. Similarly, a note may provide for a payment of principal at maturity linked to an index and bear interest at a fixed or floating rate:

**Fixed Rate Notes.** A note of this type will bear interest at a fixed rate described in the applicable pricing supplement. This type includes zero-coupon notes, which bear no interest and are instead issued at a price lower than the principal amount.

**Floating Rate Notes.** A note of this type will bear interest at rates that are determined by reference to an interest rate formula. In some cases, the rates may also be adjusted by adding or subtracting a spread or multiplying by a spread multiplier and may be subject to a minimum rate or a maximum rate. The various interest rate formulas and these other features are described below in Interest Rates Floating Rate Notes . If your note is a floating rate note, the formula and any adjustments that apply to the interest rate will be specified in the applicable supplements.

**Indexed Notes.** A note of this type provides that the principal amount payable at its maturity, and/or the amount of interest payable on an interest payment date, will be determined by reference to:

one or more securities;

one or more currencies;

one or more commodities;

any other financial, economic or other measures or instruments, including the occurrence or non-occurrence of any event or circumstance; and/or

one or more indices or baskets of any of these items.

If you are a holder of an indexed note, you may receive a principal amount at maturity that is greater than or less than the face amount of your note depending upon the formula used to determine the amount payable and the value of the applicable property or index at maturity. That value may fluctuate over time. If you purchase an indexed note the applicable supplements will include information about the relevant property or index and about how amounts that are to become payable will be determined by reference to that property or index. Before you purchase any indexed note, you should read carefully the section entitled Risk Factors Risks Relating to Indexed Securities above and the discussion of risks in the applicable supplements.

**Exchangeable Notes.** We may issue notes, which we refer to as exchangeable notes, that are exchangeable, at our option or the option of the holder, into securities of an issuer other than Wachovia or into other property. The exchangeable notes may or may not bear interest or be issued with original issue discount or at a premium. The general terms of the exchangeable notes are described below.

**Optionally Exchangeable Notes.** The holder of an optionally exchangeable note may, during a period, or at specific times, exchange the note for the underlying property at a specified rate of exchange. If specified in the applicable supplements, we will have the option to redeem the optionally exchangeable note prior to maturity. If the holder of an optionally exchangeable note does not elect to exchange the note prior to maturity or any redemption date, the holder will receive the principal amount of the note plus any accrued interest at maturity or upon redemption.

**Mandatorily Exchangeable Notes.** At maturity, the holder of a mandatorily exchangeable note must exchange the note for the underlying property at a specified rate of exchange, and, therefore, depending upon the value of the underlying property at maturity, the holder of a

mandatorily exchangeable note may receive less than the principal amount of the note at maturity. If so indicated in the applicable supplements, the specified rate at which a mandatorily exchangeable note may be exchanged may vary depending on the value of the underlying property so that, upon exchange, the holder participates in a percentage, which may be less than, equal to, or greater than 100% of the change in value of the underlying property. Mandatorily exchangeable notes may include notes where we have the right, but not the obligation, to require holders of notes to exchange their notes for the underlying property.

***Payments upon Exchange.*** The applicable supplements will specify if upon exchange, at maturity or otherwise, the holder of an exchangeable note may receive, at the specified exchange rate, either the underlying property or the cash value of the underlying property. The underlying property may be the securities of either U.S. or foreign entities or both. The exchangeable notes may or may not provide for protection against fluctuations in the exchange rate between the currency in which that note is denominated and the currency or currencies in which the market prices of the underlying security or securities are quoted. Exchangeable notes may have other terms, which will be specified in the applicable supplements.

***Special Requirements for Exchange of Global Securities.*** If an optionally exchangeable note is represented by a global security, the depositary's nominee will be the holder of that note and therefore will be the only entity that can exercise a right to exchange. In order to ensure that the depositary's nominee will timely exercise a right to exchange a particular note or any portion of a particular note, the beneficial owner of the note must instruct the broker or other direct or indirect participant through which it holds an interest in that note to notify the depositary of its desire to exercise a right to exchange. Different firms have different deadlines for accepting instructions from their customers. Each beneficial owner should consult the broker or other participant through which it holds an interest in a note in order to ascertain the deadline for ensuring that timely notice will be delivered to the depositary.

***Payments upon Acceleration of Maturity or upon Tax Redemption.*** If the principal amount payable at maturity of any exchangeable note is declared due and payable prior to maturity, the amount payable on:

an optionally exchangeable note will equal the face amount of the note plus accrued interest, if any, to but excluding the date of payment, except that if a holder has exchanged an optionally exchangeable note prior to the date of declaration or tax redemption without having received the amount due upon exchange, the amount payable will be an amount of cash equal to the amount due upon exchange and will not include any accrued but unpaid interest; and

a mandatorily exchangeable note will equal an amount determined as if the date of declaration or tax redemption were the maturity date plus accrued interest, if any, to but excluding the date of payment.

### **Original Issue Discount Notes**

A fixed rate note, a floating rate note or an indexed note may be an original issue discount note. A note of this type is issued at a price lower than its principal amount and provides that, upon redemption or acceleration of its maturity, an amount less than its principal amount will be payable. An original issue discount note may be a zero coupon note. A note issued at a discount to its principal may, for U.S. federal income tax purposes, be considered an original issue discount note, regardless of the amount payable upon redemption or acceleration of maturity. See United States Taxation below for a brief description of the U.S. federal income tax consequences of owning an original issue discount note.

### **Information in the Supplements**

The applicable supplements will describe one or more of the following terms of your note:

whether it is a senior note or a subordinated note;

any limit on the total principal amount of the notes of the same series or class;

the stated maturity;

the specified currency or currencies for principal and interest, if not U.S. dollars;

the price at which we originally issue your note, expressed as a percentage of the principal amount, and the original issue date;

whether your note is a fixed rate note, a floating rate note, an indexed note or an exchangeable note;

if your note is a fixed rate note, the yearly rate at which your note will bear interest, if any, and the interest payment dates;

if your note is a floating rate note, the interest rate basis, which may be one of the nine interest rate bases described in [Interest Rates Floating Rate Notes](#) below; any applicable index currency or maturity, spread or spread multiplier or initial, maximum or minimum rate; and the interest reset, determination, calculation and payment dates, the day count used to calculate interest payments for any period; and the calculation agent, all of which we describe under [Interest Rates Floating Rate Notes](#) below;

if your note is an indexed note, the principal amount, if any, we will pay you at maturity, the amount of interest, if any, we will pay you on an interest payment date or the formula we will use to calculate these amounts, if any, and whether your note will be exchangeable for or payable in cash, securities of an issuer other than Wachovia or other property;

if your note is an exchangeable note, the securities or property for which the notes may be exchanged, whether the notes are exchangeable at your option or at Wachovia's option, and the other items described in [Exchangeable Notes](#) above;

if your note is an original issue discount note, the yield to maturity;

if applicable, the circumstances under which your note may be redeemed at our option before the stated maturity, including any redemption commencement date, redemption price(s) and redemption period(s);

if applicable, the circumstances under which you may demand repayment of your note before the stated maturity, including any repayment commencement date, repayment price(s) and repayment period(s);

the authorized denominations, if other than \$1,000 and integral multiples of \$1,000;

any special United States federal income tax consequences of the purchase, ownership or disposition of a particular issuance of notes;

the use of proceeds, if materially different than those discussed in this prospectus; and

any other terms of your note, which could be different from those described in this prospectus.

***Market-Making Transactions.*** If you purchase your note in a market-making transaction, you will receive information about the price you pay and your trade and settlement dates in a separate confirmation of sale. A market-making transaction is one in which Wachovia Securities or another of our affiliates resells a note that it has previously acquired from another holder. A market-making transaction in a particular note occurs after the original issuance and sale of the note.

**Redemption at the Option of Wachovia; No Sinking Fund**

If an initial redemption date is specified in the applicable pricing supplement, we may redeem the particular notes prior to their stated maturity date at our option on any date on or after that initial redemption date in whole or from time to time in part in increments of \$1,000 or any other integral multiple of an authorized denomination specified in the applicable pricing supplement (provided that any remaining principal amount thereof shall be at least \$1,000 or other minimum authorized denomination applicable thereto), at the applicable redemption price (as defined below), together with unpaid interest accrued thereon to the date of redemption. We must give written notice to registered holders of the

particular notes to be redeemed at our option not more than 60 nor less than 30 calendar days prior to the date of redemption. Redemption price , with respect to a note, means an amount equal to the initial redemption percentage specified in the applicable supplement (as adjusted by the annual redemption percentage reduction, if applicable) multiplied by the unpaid principal amount thereof to be redeemed. The initial redemption percentage, if any, applicable to a note shall decline at each anniversary of the initial redemption date by an

amount equal to the applicable annual redemption percentage reduction, if any, until the redemption price is equal to 100% of the unpaid principal amount thereof to be redeemed.

The notes will not be subject to, or entitled to the benefit of, any sinking fund.

### **Repayment at the Option of the Holder**

If one or more optional repayment dates are specified in the applicable pricing supplement, registered holders of the particular notes may require us to repay those notes prior to their stated maturity date on any optional repayment date in whole or from time to time in part in increments of \$1,000 or any other integral multiple of an authorized denomination specified in the applicable pricing supplement (provided that any remaining principal amount thereof shall be at least \$1,000 or other minimum authorized denomination applicable thereto), at a repayment price equal to 100% of the unpaid principal amount thereof to be repaid, together with unpaid interest accrued thereon to the date of repayment. A registered holder's exercise of the repayment option will be irrevocable.

For any note to be repaid, the applicable trustee must receive, at its corporate trust office in the Borough of Manhattan, The City of New York, not more than 60 nor less than 30 calendar days prior to the date of repayment, the particular notes to be repaid and, in the case of a book-entry note, repayment instructions from the applicable beneficial owner (as defined below) to the depository and forwarded by the depository.

Only the depository may exercise the repayment option in respect of global notes representing book-entry notes. Accordingly, beneficial owners of global notes that desire to have all or any portion of the book-entry notes represented thereby repaid must instruct the participant (as defined below) through which they own their interest to direct the depository to exercise the repayment option on their behalf by forwarding the repayment instructions to the applicable trustee as aforesaid. In order to ensure that these instructions are received by the applicable trustee on a particular day, the applicable beneficial owner must so instruct the participant through which it owns its interest before that participant's deadline for accepting instructions for that day. Different firms may have different deadlines for accepting instructions from their customers. Accordingly, beneficial owners should consult their participants for the respective deadlines. All instructions given to participants from beneficial owners of global notes relating to the option to elect repayment shall be irrevocable. In addition, at the time repayment instructions are given, each beneficial owner shall cause the participant through which it owns its interest to transfer the beneficial owner's interest in the global note representing the related book-entry notes, on the depository's records, to the applicable trustee. See Global Notes.

If applicable, we will comply with the requirements of Section 14(e) of the Securities Exchange Act of 1934, as amended (the Exchange Act), and the rules promulgated thereunder, and any other securities laws or regulations in connection with any repayment of notes at the option of the registered holders thereof.

We may at any time purchase notes at any price or prices in the open market or otherwise. Notes so purchased by us may, at our discretion, be held, resold or surrendered to the applicable trustee for cancellation.

### **Interest**

Each interest-bearing note will bear interest from its date of issue at the rate per annum, in the case of a fixed rate note, or pursuant to the interest rate formula, in the case of a floating rate note, in each case as specified in the applicable pricing supplement, until the principal thereof is paid. We will make interest payments in respect of fixed rate notes and floating rate notes in an amount equal to the interest accrued from and including the immediately preceding interest payment date in respect of which interest has been paid or from and including the date of issue, if no interest has been paid, to but excluding the applicable interest payment date or the maturity date, as the case may be (each, an interest period).

Interest on fixed rate notes and floating rate notes will be payable in arrears on each interest payment date and on the maturity date. The first payment of interest on any note originally issued between a regular record date and the related interest payment date will be made on the interest payment date immediately following the next succeeding record date to the registered holder on the next succeeding record date. The regular record date shall be the fifteenth calendar day, whether or not a business day, immediately preceding the related interest payment date. Business Day is defined below under Interest Rates Special Rate Calculation Terms. For the purpose of determining the holder at the close of business on a regular record date when business is not being conducted, the close of business will mean 5:00 P.M., New York City time, on that day.

### **Interest Rates**

This subsection describes the different kinds of interest rates that may apply to your note, if it bears interest.

#### ***Fixed Rate Notes***

Your pricing supplement will specify the interest payment dates for a fixed rate note as well as the maturity date. Interest on fixed rate notes will be computed on the basis of a 360-day year of twelve 30-day months or such other day count fraction set forth in the applicable supplement.

If any interest payment date or the maturity date of a fixed rate note falls on a day that is not a business day, we will make the required payment of principal, premium, if any, and/or interest on the next succeeding business day, and no additional interest will accrue in respect of the payment made on that next succeeding business day.

#### ***Floating Rate Notes***

*In this subsection, we use several specialized terms relating to the manner in which floating interest rates are calculated. These terms appear in bold, italicized type the first time they appear, and we define these terms in Special Rate Calculation Terms at the end of this subsection.*

The following will apply to floating rate notes.

***Interest Rate Basis.*** We currently expect to issue floating rate notes that bear interest at rates based on one or more of the following interest rate bases:

commercial paper rate;

prime rate;

LIBOR;

EURIBOR;

treasury rate;

CMT rate;



CD rate;

consumer price index ( CPI ) rate; and/or

federal funds rate.

We describe each of the interest rate bases in further detail below in this subsection. If you purchase a floating rate note, the applicable supplements will specify the interest rate basis that applies to your note.

**Calculation of Interest.** Calculations relating to floating rate notes will be made by the calculation agent, an institution that we appoint as our agent for this purpose. That institution may include any affiliate

of ours, such as Wachovia Securities or Wachovia Bank, National Association. If other than Wachovia Securities or Wachovia Bank, National Association, the applicable supplements for a particular floating rate note will name the institution that we have appointed to act as the calculation agent for that note as of its original issue date. We may appoint a different institution to serve as calculation agent from time to time after the original issue date of the note without your consent and without notifying you of the change.

For each floating rate note, the calculation agent will determine, on no later than the corresponding interest calculation date or on the interest determination date, as described below, the interest rate that takes effect on each interest reset date. In addition, the calculation agent will calculate the amount of interest that has accrued during each interest period i.e., the period from and including the original issue date, or the last date to which interest has been paid or made available for payment, to but excluding the payment date. For each interest period, the calculation agent will calculate the amount of accrued interest by multiplying the face or other specified amount of the floating rate note by an accrued interest factor for the interest period. This factor will equal the sum of the interest factors calculated for each day during the interest period. The interest factor for each day will be expressed as a decimal and will be calculated by dividing the interest rate, also expressed as a decimal, applicable to that day by 360 or by the actual number of days in the year, as specified in the applicable supplements.

Upon the request of the holder of any floating rate note, the calculation agent will provide for that note the interest rate then in effect and, if determinable, the interest rate that will become effective on the next interest reset date. The calculation agent's determination of any interest rate, and its calculation of the amount of interest for any interest period, will be final and binding in the absence of manifest error.

All percentages resulting from any calculation relating to a note will be rounded upward or downward, as appropriate, to the next higher or lower one hundred-thousandth of a percentage point, e.g., 9.876541% (or .09876541) being rounded down to 9.87654% (or .0987654) and 9.876545% (or .09876545) being rounded up to 9.87655% (or .0987655). All amounts used in or resulting from any calculation relating to a floating rate note will be rounded upward or downward, as appropriate, to the nearest cent, in the case of U.S. dollars, or to the nearest corresponding hundredth of a unit, in the case of a currency other than U.S. dollars, with one-half cent or one-half of a corresponding hundredth of a unit or more being rounded upward.

In determining the interest rate basis that applies to a floating rate note during a particular interest period, the calculation agent may obtain rate quotes from various banks or dealers active in the relevant market, as discussed below. Those reference banks and dealers may include the calculation agent itself and its affiliates, as well as any agent participating in the distribution of the relevant floating rate notes and its affiliates, and they may include affiliates of Wachovia.

**Initial Interest Rate.** For any floating rate note, the interest rate in effect from the original issue date to the first interest reset date will be the initial interest rate. We will specify the initial interest rate or the manner in which it is determined in the applicable supplements.

**Spread or Spread Multiplier.** In some cases, the interest rate basis for a floating rate note may be adjusted:

by adding or subtracting a specified number of basis points, called the spread, with one basis point being 0.01%; or

by multiplying the interest rate basis by a specified percentage, called the spread multiplier.

If you purchase a floating rate note, the applicable supplements will indicate whether a spread or spread multiplier will apply to your note and, if so, the amount of the spread or spread multiplier.

**Maximum and Minimum Rates.** The actual interest rate, after being adjusted by the spread or spread multiplier, may also be subject to either or both of the following limits:

a maximum rate i.e., a specified upper limit that the actual interest rate in effect at any time may not exceed; and/or

a minimum rate i.e., a specified lower limit that the actual interest rate in effect at any time may not fall below.

If you purchase a floating rate note, the applicable supplements will indicate whether a maximum rate and/or minimum rate will apply to your note and, if so, what those rates are.

Whether or not a maximum rate applies, the interest rate on a floating rate note will in no event be higher than the maximum rate permitted by New York law, as it may be modified by U.S. law of general application. Under current New York law, the maximum rate of interest, with some exceptions, for any loan in an amount less than \$250,000 is 16% and for any loan in the amount of \$250,000 or more but less than \$2,500,000 is 25% per year on a simple interest basis. These limits do not apply to loans of \$2,500,000 or more.

The rest of this subsection describes how the interest rate and the interest payment dates will be determined, and how interest will be calculated, on a floating rate note.

**Interest Reset Dates.** The rate of interest on a floating rate note will be reset, by the calculation agent described below, daily, weekly, monthly, quarterly, semi-annually or annually. The date on which the interest rate resets and the reset rate becomes effective is called the interest reset date. Except as otherwise specified in the applicable supplement, the interest reset date will be as follows:

for floating rate notes that reset daily, each *business day*;

for floating rate notes that reset weekly and are not treasury rate notes, the Wednesday of each week;

for treasury rate notes that reset weekly, the Tuesday of each week;

for floating rate notes that reset monthly, the third Wednesday of each month;

for floating rate notes that reset quarterly, the third Wednesday of March, June, September and December of each year;

for floating rate notes that reset semi-annually, the third Wednesday of each of two months of each year as indicated in the applicable supplements; and

for floating rate notes that reset annually, the third Wednesday of one month of each year as indicated in the applicable supplements. For a floating rate note, the interest rate in effect on any particular day will be the interest rate determined with respect to the latest interest reset date that occurs on or before that day. There are several exceptions, however, to the reset provisions described above.

The interest rate in effect from the original issue date to the first interest reset date will be the initial interest rate.

If any interest reset date for a floating rate note would otherwise be a day that is not a business day, the interest reset date will be postponed to the next day that is a business day. For a LIBOR or EURIBOR note, however, if that business day is in the next succeeding calendar month, the

interest reset date will be the immediately preceding business day.

**Interest Determination Dates.** The interest rate that takes effect on an interest reset date will be determined by the calculation agent by reference to a particular date called an interest determination date. Except as otherwise indicated in the relevant pricing supplement:

for commercial paper rate, federal funds rate and prime rate notes, the interest determination date relating to a particular interest reset date will be the business day preceding the interest reset date;

for CD rate, CPI rate, and CMT rate notes, the interest determination date relating to a particular interest reset date will be the second business day preceding the interest reset date;

for LIBOR notes, the interest determination date relating to a particular interest reset date will be the second *London business day* preceding the interest reset date, unless the *index currency* is pounds sterling, in which case the interest determination date will be the interest reset date. We refer to an interest determination date for a LIBOR note as a LIBOR interest determination date;

for EURIBOR notes, the interest determination date relating to a particular interest reset date will be the second *euro business day* preceding the interest reset date. We refer to an interest determination date for a EURIBOR note as a EURIBOR interest determination date; and

for treasury rate notes, the interest determination date relating to a particular interest reset date, which we refer to as a treasury interest determination date, will be the day of the week in which the interest reset date falls on which treasury bills i.e., direct obligations of the U.S. government would normally be auctioned. Treasury bills are usually sold at auction on the Monday of each week, unless that day is a legal holiday, in which case the auction is usually held on the following Tuesday, except that the auction may be held on the preceding Friday. If as the result of a legal holiday an auction is held on the preceding Friday, that Friday will be the treasury interest determination date relating to the interest reset date occurring in the next succeeding week.

The interest determination date pertaining to a floating rate note, the interest rate of which is determined with reference to two or more interest rate bases, will be the latest business day which is at least two business days before the related interest reset date for the applicable floating rate note on which each interest rate basis is determinable.

**Interest Calculation Dates.** As described above, the interest rate that takes effect on a particular interest reset date will be determined by reference to the corresponding interest determination date. Except for LIBOR notes and EURIBOR notes, however, the determination of the rate will actually be made on a day no later than the corresponding interest calculation date. The interest calculation date will be the earlier of the following:

the tenth calendar day after the interest determination date or, if that tenth calendar day is not a business day, the next succeeding business day; and

the business day immediately preceding the interest payment date or the maturity date, whichever is the day on which the next payment of interest will be due.

The calculation agent need not wait until the relevant interest calculation date to determine the interest rate if the rate information it needs to make the determination is available from the relevant sources sooner.

**Interest Payment Dates.** The interest payment dates for a floating rate note will depend on when the interest rate is reset and, unless we specify otherwise in the applicable supplements, will be as follows:

for floating rate notes that reset daily, weekly or monthly, the third Wednesday of each month or the third Wednesday of March, June, September and December of each year, as specified in the applicable supplement;

for floating rate notes that reset quarterly, the third Wednesday of March, June, September and December of each year;

for floating rate notes that reset semi-annually, the third Wednesday of the two months of each year specified in the applicable supplement; or

for floating rate notes that reset annually, the third Wednesday of the month specified in the applicable supplement.

Regardless of these rules, if a note is originally issued after the regular record date and before the date that would otherwise be the first interest payment date, the first interest payment date will be the date that would otherwise be the second interest payment date.

In addition, the following special provision will apply to a floating rate note with regard to any interest payment date other than one that falls on the maturity. If the interest payment date would otherwise fall on a day that is not a business day, then the interest payment date will be the next day that is a business day. However, if the floating rate note is a LIBOR note or a EURIBOR note and the next business day falls in the next calendar month, then the interest payment date will be advanced to the next preceding day that is a business day. If the maturity date of a floating rate note falls on a day that is not a business day, we will make the required payment of principal, premium, if any, and interest on the next succeeding business day, and no additional interest will accrue in respect of the payment made on that next succeeding business day.

**Calculation Agent.** We have initially appointed Wachovia Capital Markets, LLC as our calculation agent for the notes. See Calculation of Interest above for details regarding the role of the calculation agent.

### **Commercial Paper Rate Notes**

If you purchase a commercial paper rate note, your note will bear interest at an interest rate equal to the commercial paper rate and adjusted by the spread or spread multiplier, if any, indicated in your pricing supplement.

The commercial paper rate will be the **money market yield** of the rate, for the relevant interest determination date, for commercial paper having the **index maturity** indicated in your pricing supplement, as published in **H.15(519)** under the heading Commercial Paper Nonfinancial . If the commercial paper rate cannot be determined as described above, the following procedures will apply.

If the rate described above does not appear in H.15(519) at 3:00 P.M., New York City time, on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from that source at that time, then the commercial paper rate will be the rate, for the relevant interest determination date, for commercial paper having the index maturity specified in your pricing supplement, as published in **H.15 daily update** or any other recognized electronic source used for displaying that rate, under the heading Commercial Paper Nonfinancial .

If the rate described above does not appear in H.15(519), H.15 daily update or another recognized electronic source at 3:00 P.M., New York City time, on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from one of those sources at that time, the commercial paper rate will be the money market yield of the arithmetic mean of the following offered rates for U.S. dollar commercial paper that has the relevant index maturity and is placed for an industrial issuer whose bond rating is AA , or the equivalent, from a nationally recognized rating agency: the rates offered as of 11:00 A.M., New York City time, on the relevant interest determination date, by three leading U.S. dollar commercial paper dealers in New York City selected by the calculation agent.

If fewer than three dealers selected by the calculation agent are quoting as described above, the commercial paper rate for the new interest period will be the commercial paper rate in effect for the prior interest period. If the initial interest rate has been in effect for the prior interest period, however, it will remain in effect for the new interest period.

### ***Prime Rate Notes***

If you purchase a prime rate note, your note will bear interest at an interest rate equal to the prime rate and adjusted by the spread or spread multiplier, if any, indicated in your pricing supplement.

The prime rate will be the rate, for the relevant interest determination date, published in H.15(519) under the heading **Bank Prime Loan**. If the prime rate cannot be determined as described above, the following procedures will apply.

If the rate described above does not appear in H.15(519) at 3:00 P.M., New York City time, on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from that source at that time, then the prime rate will be the rate, for the relevant interest determination date, as published in H.15 daily update or another recognized electronic source used for the purpose of displaying that rate, under the heading **Bank Prime Loan**.

If the rate described above does not appear in H.15(519), H.15 daily update or another recognized electronic source at 3:00 P.M., New York City time, on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from one of those sources at that time, then the prime rate will be the arithmetic mean of the following rates as they appear on the **Reuters screen US PRIME 1 page**: the rate of interest publicly announced by each bank appearing on that page as that bank's prime rate or base lending rate, as of 11:00 A.M., New York City time, on the relevant interest determination date.

If fewer than four of these rates appear on the Reuters screen US PRIME 1 page, the prime rate will be the arithmetic mean of the prime rates or base lending rates, as of the close of business on the relevant interest determination date, of three major banks in New York City selected by the calculation agent. For this purpose, the calculation agent will use rates quoted on the basis of the actual number of days in the year divided by a 360-day year.

If fewer than three banks selected by the calculation agent are quoting as described above, the prime rate for the new interest period will be the prime rate in effect for the prior interest period. If the initial interest rate has been in effect for the prior interest period, however, it will remain in effect for the new interest period.

### ***LIBOR Notes***

If you purchase a LIBOR note, your note will bear interest at an interest rate equal to LIBOR, which will be the London interbank offered rate for deposits in U.S. dollars or any other index currency, as noted in the applicable supplement. In addition, when LIBOR is the interest rate basis the applicable LIBOR rate will be adjusted by the spread or spread multiplier, if any, indicated in the applicable supplement. LIBOR will be determined in the following manner:

LIBOR will be either:

the offered rate appearing on the **Reuters screen LIBOR01 page**; or

the arithmetic mean of the offered rates appearing on the **Reuters screen LIBO page** unless that page by its terms cites only one rate, in which case that rate;

in either case, as of 11:00 A.M., London time, on the relevant LIBOR interest determination date, for deposits of the relevant index currency having the relevant index maturity beginning on the relevant interest reset date. The applicable supplement will indicate the index currency, the index maturity and the reference page that apply to your LIBOR note. If no reference page is mentioned in the applicable supplement, Reuters screen LIBOR01 page will apply to your LIBOR note.



If Reuters screen LIBOR01 page applies and the rate described above does not appear on that page, or if Reuters screen LIBO page applies and fewer than two of the rates described above appears on that page or no rate appears on any page on which only one rate normally appears,

then LIBOR will be determined on the basis of the rates, at approximately 11:00 A.M., London time, on the relevant LIBOR interest determination date, at which deposits of the following kind are offered to prime banks in the London interbank market by four major banks in that market selected by the calculation agent: deposits of the index currency having the relevant index maturity, beginning on the relevant interest reset date, and in a *representative amount*. The calculation agent will request the principal London office of each of these banks to provide a quotation of its rate. If at least two quotations are provided, LIBOR for the relevant LIBOR interest determination date will be the arithmetic mean of the quotations.

If fewer than two quotations are provided as described above, LIBOR for the relevant LIBOR interest determination date will be the arithmetic mean of the rates for loans of the following kind to leading European banks quoted, at approximately 11:00 A.M., in the principal financial center for the country of the index currency, on that LIBOR interest determination date, by three major banks in that financial center selected by the calculation agent: loans of the index currency having the relevant index maturity, beginning on the relevant interest reset date, and in a representative amount.

If fewer than three banks selected by the calculation agent are quoting as described above, LIBOR for the new interest period will be LIBOR in effect for the prior interest period. If the initial interest rate has been in effect for the prior interest period, however, it will remain in effect for the new interest period.

***EURIBOR Notes***

If you purchase a EURIBOR note, your note will bear interest at an interest rate equal to the interest rate for deposits in euro, designated as EURIBOR and sponsored jointly by the European Banking Federation and ACI the Financial Market Association, or any company established by the joint sponsors for purposes of compiling and publishing that rate. In addition, when EURIBOR is the interest rate basis the EURIBOR base rate will be adjusted by the spread or spread multiplier, if any, specified in the applicable supplement. EURIBOR will be determined in the following manner:

EURIBOR will be the offered rate for deposits in euros having the index maturity specified in the applicable supplement, beginning on the second *euro business day* after the relevant EURIBOR interest determination date, as that rate appears on Reuters screen EURIBOR01 page as of 11:00 A.M., Brussels time, on the relevant EURIBOR interest determination date.

If the rate described above does not appear on Reuters screen EURIBOR01 page, EURIBOR will be determined on the basis of the rates, at approximately 11:00 A.M., Brussels time, on the relevant EURIBOR interest determination date, at which deposits of the following kind are offered to prime banks in the *euro-zone* interbank market by the principal euro-zone office of each of four major banks in that market selected by the calculation agent: euro deposits having the relevant index maturity, beginning on the relevant interest reset date, and in a representative amount. The calculation agent will request the principal euro-zone office of each of these banks to provide a quotation of its rate. If at least two quotations are provided, EURIBOR for the relevant EURIBOR interest determination date will be the arithmetic mean of the quotations.

If fewer than two quotations are provided as described above, EURIBOR for the relevant EURIBOR interest determination date will be the arithmetic mean of the rates for loans of the following kind to leading euro-zone banks quoted, at approximately 11:00 A.M., Brussels time on that EURIBOR interest determination date, by three major banks in the euro-zone selected by the calculation agent: loans of euros having the relevant index maturity, beginning on the relevant interest reset date, and in a representative amount.

If fewer than three banks selected by the calculation agent are quoting as described above, EURIBOR for the new interest period will be EURIBOR in effect for the prior interest period. If

the initial interest rate has been in effect for the prior interest period, however, it will remain in effect for the new interest period.

***Treasury Rate Notes***

If you purchase a treasury rate note, your note will bear interest at an interest rate equal to the treasury rate and adjusted by the spread or spread multiplier, if any, indicated in the applicable supplement.

The treasury rate will be the rate for the auction, on the relevant treasury interest determination date, of treasury bills having the index maturity specified in your pricing supplement, as that rate appears on ***Reuters Screen USAUCTION10 or USAUCTION11 page*** under the heading Investment Rate . If the treasury rate cannot be determined in this manner, the following procedures will apply.

If the rate described above does not appear on either page at 3:00 P.M., New York City time, on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from that source at that time, the treasury rate will be the ***bond equivalent yield*** of the rate, for the relevant interest determination date, for the type of treasury bill described above, as published in H.15 daily update, or another recognized electronic source used for displaying that rate, under the heading U.S. Government Securities/Treasury Bills/Auction High .

If the rate described in the prior paragraph does not appear in H.15 daily update or another recognized electronic source at 3:00 P.M., New York City time, on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from one of those sources at that time, the treasury rate will be the bond equivalent yield of the auction rate, for the relevant treasury interest determination date and for treasury bills of the kind described above, as announced by the U.S. Department of the Treasury.

If the auction rate described in the prior paragraph is not announced by 3:00 P.M., New York City time on the relevant interest calculation date, or if no such auction is held for the relevant week, then the treasury rate will be the bond equivalent yield of the rate for the relevant treasury interest determination date and for treasury bills having a remaining maturity closest to the specified index maturity, as published in H.15(519) under the heading U.S. Government Securities /Treasury Bills/Secondary Market .

If the rate described in the prior paragraph does not appear in H.15(519) at 3:00 P.M., New York City time on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from one of those sources at that time, then the treasury rate will be the rate for the relevant treasury interest determination date and for treasury bills having a remaining maturity closest to the specified index maturity, as published in H.15 daily update, or another recognized electronic source used for displaying that rate, under the heading U.S. Government Securities/Treasury Bills/Secondary Market .

If the rate described in the prior paragraph does not appear in H.15 daily update or another recognized electronic source at 3:00 P.M., New York City time on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from one of those sources at that time, the treasury rate will be the bond equivalent yield of the arithmetic mean of the following secondary market bid rates for the issue of treasury bills with a remaining maturity closest to the specified index maturity: the rates bid as of approximately 3:30 P.M., New York City time on the relevant treasury interest determination date by three primary U.S. government securities dealers in New York City selected by the calculation agent.

If fewer than three dealers selected by the calculation agent are quoting as described in the prior paragraph, the treasury rate in effect for the new interest period will be the treasury rate in effect for the prior interest period. If the initial interest rate has been in effect for the prior interest period, however, it will remain in effect for the new interest period.

### ***CD Rate Notes***

If you purchase a CD rate note, your note will bear interest at an interest rate equal to the CD rate and adjusted by the spread or spread multiplier, if any, indicated in the applicable supplement.

The CD rate will be the rate, on the relevant interest determination date, for negotiable U.S. dollar certificates of deposit having the index maturity specified in the applicable supplement, as published in H.15(519) under the heading **CDs (Secondary Market)**. If the CD rate cannot be determined in this manner, the following procedures will apply.

If the rate described above does not appear in H.15(519) at 3:00 P.M., New York City time on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from that source at that time, then the CD rate will be the rate for the relevant interest determination date described above as published in H.15 daily update, or another recognized electronic source used for displaying that rate, under the heading **CDs (Secondary Market)**.

If the rate described above does not appear in H.15(519), H.15 daily update or another recognized electronic source at 3:00 P.M., New York City time on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from one of those sources at that time, the CD rate will be the arithmetic mean of the following secondary market offered rates for negotiable U.S. dollar certificates of deposit of major U.S. money market banks with a remaining maturity closest to the specified index maturity, and in a representative amount: the rates offered as of 10:00 A.M., New York City time on the relevant interest determination date by three leading nonbank dealers in negotiable U.S. dollar certificates of deposit in New York City, as selected by the calculation agent.

If fewer than three dealers selected by the calculation agent are quoting as described above, the CD rate in effect for the new interest period will be the CD rate in effect for the prior interest period. If the initial interest rate has been in effect for the prior interest period, however, it will remain in effect for the new interest period.

### ***CMT Rate Notes***

If you purchase a CMT rate note, your note will bear interest at an interest rate equal to the CMT rate and adjusted by the spread or spread multiplier, if any, indicated in the applicable supplement.

The CMT rate will be the following rate displayed on the designated ***CMT Reuters page*** under the heading **... Treasury Constant Maturities ...** Federal Reserve Board Release H.15 Mondays Approximately 3:45 P.M., under the column for the ***designated CMT index maturity***:

if the designated CMT Reuters page is Reuters screen FRBCMT page, the rate for the relevant interest determination date; or

if the designated CMT Reuters page is Reuters screen FEDCMT page, the weekly or monthly average, as specified in your pricing supplement, for the week that ends immediately before the week in which the relevant interest determination date falls, or for the month that ends immediately before the month in which the relevant interest determination date falls, as applicable.

If the CMT rate cannot be determined in this manner, the following procedures will apply.

If the applicable rate described above is not displayed on the relevant designated CMT Reuters page at 3:00 P.M., New York City time on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from that source at that time, then the CMT rate will be the applicable treasury constant maturity rate described above i.e., for the designated CMT index maturity and for either the relevant interest determination date or the weekly or monthly average, as applicable as published in H.15(519).

If the applicable rate described above does not appear in H.15(519) at 3:00 P.M., New York City time on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from one of those sources at that time, then the CMT rate will be the treasury constant maturity rate, or other U.S. treasury rate, for the designated CMT index maturity and with reference to the relevant interest determination date, that:

is published by the Board of Governors of the Federal Reserve System, or the U.S. Department of the Treasury; *and*

is determined by the calculation agent to be comparable to the applicable rate formerly displayed on the designated CMT Reuters page and published in H.15(519).

If the rate described in the prior paragraph does not appear at 3:00 P.M., New York City time on the relevant interest calculation date, unless the calculation is made earlier and the rate is available from one of those sources at that time, then the CMT rate will be the yield to maturity of the arithmetic mean of the following secondary market bid rates for the most recently issued treasury notes having an original maturity of approximately the designated CMT index maturity and a remaining term to maturity of not less than the designated CMT index maturity *minus* one year, and in a representative amount: the bid rates, as of approximately 3:30 P.M., New York City time on the relevant interest determination date of three primary U.S. government securities dealers in New York City selected by the calculation agent. In selecting these bid rates, the calculation agent will request quotations from five of these primary dealers and will disregard the highest quotation or, if there is equality, one of the highest and the lowest quotation or, if there is equality, one of the lowest. Treasury notes are direct, non-callable, fixed rate obligations of the U.S. government.

If the calculation agent is unable to obtain three quotations of the kind described in the prior paragraph, the CMT rate will be the yield to maturity of the arithmetic mean of the following secondary market bid rates for treasury notes with an original maturity longer than the designated CMT index maturity, with a remaining term to maturity closest to the designated CMT index maturity and in a representative amount: the bid rates, as of approximately 3:30 P.M., New York City time on the relevant interest determination date of three primary U.S. government securities dealers in New York City selected by the calculation agent. In selecting these bid rates, the calculation agent will request quotations from five of these primary dealers and will disregard the highest quotation or, if there is equality, one of the highest and the lowest quotation or, if there is equality, one of the lowest. If two treasury notes with an original maturity longer than the designated CMT index maturity have remaining terms to maturity that are equally close to the designated CMT index maturity, the calculation agent will obtain quotations for the treasury note with the shorter remaining term to maturity.

If fewer than five but more than two of these primary dealers are quoting as described in the prior paragraph, then the CMT rate for the relevant interest determination date will be based on the arithmetic mean of the bid rates so obtained, and neither the highest nor the lowest of those quotations will be disregarded.

If two or fewer primary dealers selected by the calculation agent are quoting as described above, the CMT rate in effect for the new interest period will be the CMT rate in effect for the prior interest period. If the initial interest rate has been in effect for the prior interest period, however, it will remain in effect for the new interest period.

***CPI Rate Notes***

If you purchase a CPI rate note, your note will bear interest at an interest rate equal to the CPI rate and adjusted by the spread or spread multiplier, if any, indicated in the applicable supplement.

Except as otherwise specified in the applicable pricing supplement, the CPI rate will be the rate, determined as of the relevant interest determination date, expressed as a percentage and calculated in accordance with the following formula:

$$\text{CPI rate} = \frac{(C - P)}{P} \times 100$$

where

**C** means the CPI (as defined below) applicable for the calendar month which is two months preceding the month of the relevant interest determination date;

**P** means the CPI applicable for the calendar month which is twelve months immediately preceding the calendar month for which C is determined; and

**CPI** means the non-seasonally adjusted U.S. City Average All Items Consumer Price Index for All Urban Consumers, published monthly by the Bureau of Labor Statistics of the U.S. Department of Labor. For reference purposes only, the CPI is available on Bloomberg page CPURNSA or any successor service. In the event of an inconsistency between the CPI published on Bloomberg page CPURNSA and the CPI published by the Bureau of Labor Statistics, the CPI shall be the CPI published by the Bureau of Labor Statistics.

**Federal Funds Rate Notes**

If you purchase a federal funds rate note, your note will bear interest at an interest rate equal to the federal funds rate and adjusted by the spread or spread multiplier, if any, indicated in the applicable supplement.

The federal funds rate will be the rate for U.S. dollar federal funds on the relevant interest determination date, as published in H.15 (519) under the heading "EFFECTIVE", as that rate is displayed on *Reuters screen FEDFUNDS1 page*. If the federal funds rate cannot be determined in this manner, the following procedures will apply.

If the rate described above is not displayed on Reuters screen FEDFUNDS1 page at 3:00 P.M., New York City time on the relevant interest calculation date unless the calculation is made earlier and the rate is available from that source at that time, then the federal funds rate for the relevant interest determination date will be the rate described above as published in H.15 daily update, or another recognized electronic source used for displaying that rate, under the heading "Federal Funds (Effective)".

If the rate described above is not displayed on Reuters screen FEDFUNDS1 page and does not appear in H.15(519), H.15 daily update or another recognized electronic source at 3:00 P.M., New York City time on the relevant interest calculation date unless the calculation is made earlier and the rate is available from one of those sources at that time, the federal funds rate will be the arithmetic mean of the rates for the last transaction in overnight, U.S. dollar federal funds arranged, before 9:00 A.M., New York City time on the relevant interest determination date by three leading brokers of U.S. dollar federal funds transactions in New York City selected by the calculation agent.

If fewer than three brokers selected by the calculation agent are quoting as described above, the federal funds rate in effect for the new interest period will be the federal funds rate in effect for the prior interest period. If the initial interest rate has been in effect for the prior interest period, however, it will remain in effect for the new interest period.

If fewer than five but more than two of these primary dealers are quoting as described in the prior paragraph, then the CMT rate for the relevant interest determination date will be based on the arithmetic mean of the offered rates so obtained, and neither the highest nor the lowest of those quotations will be disregarded.

In this subsection entitled Interest Rates, we use several terms that have special meanings relevant to calculating floating interest rates. We define these terms as follows:

The term **bond equivalent yield** means a yield expressed as a percentage and calculated in accordance with the following formula:

$$\text{bond equivalent yield} = \frac{D \times N}{360 - (D \times M)} \times 100$$

where

D means the annual rate for treasury bills quoted on a bank discount basis and expressed as a decimal;

N means 365 or 366, as the case may be; and

M means the actual number of days in the applicable interest reset period.

The term **business day** means, for any note, a day that meets all the following applicable requirements:

for all notes, is a Monday, Tuesday, Wednesday, Thursday or Friday that is not a day on which banking institutions in New York City generally are authorized or obligated by law, regulation or executive order to close;

if the note is a LIBOR note, is also a London business day;

if the note has a specified currency other than U.S. dollars or euros, is also a day on which banking institutions are not authorized or obligated by law, regulation or executive order to close in the principal financial center of the country issuing the specified currency; and

if the note is a EURIBOR note or has a specified currency of euros, or is a LIBOR note for which the index currency is euros, is also a TARGET business day.

The term **designated CMT index maturity** means the index maturity for a CMT rate note and will be the original period to maturity of a U.S. treasury security either 1, 2, 3, 5, 7, 10, 20 or 30 years specified in the applicable pricing supplement.

The term **designated CMT Reuters page** means the Reuters page mentioned in the relevant pricing supplement that displays treasury constant maturities as reported in H.15(519). If no Reuters page is so specified, then the applicable page will be Reuters screen FEDCMT page. If Reuters screen FEDCMT page applies but the relevant pricing supplement does not specify whether the weekly or monthly average applies, the weekly average will apply.

The term **euro business day** means any day on which the Trans-European Automated Real-Time Gross Settlement Express Transfer (TARGET) System, or any successor system, is open for business.

The term *euro-zone* means, at any time, the region comprised of the member states of the European Economic and Monetary Union that, as of that time, have adopted a single currency in accordance with the Treaty on European Union of February 1992.

*H.15(519)* means the weekly statistical release entitled Statistical Release H.15 (519) , or any successor publication, published by the Board of Governors of the Federal Reserve System.

*H.15 daily update* means the daily update of H.15(519) available through the worldwide website of the Board of Governors of the Federal Reserve System, at <http://www.federalreserve.gov/releases/h15/update>, or any successor site or publication.

The term ***index currency*** means, with respect to a LIBOR note, the currency specified as such in the relevant pricing supplement. The index currency may be U.S. dollars or any other currency, and will be U.S. dollars unless another currency is specified in the applicable supplement.

The term ***index maturity*** means, with respect to a floating rate note, the period to maturity of the instrument or obligation on which the interest rate formula is based, as specified in the applicable supplement.

***London business day*** means any day on which dealings in the relevant index currency are transacted in the London interbank market.

The term ***money market yield*** means a yield expressed as a percentage and calculated in accordance with the following formula:

$$\text{money market yield} = \frac{D \times 360}{360 (D \times M)} \times 100$$

where

D means the annual rate for commercial paper quoted on a bank discount basis and expressed as a decimal; and

M means the actual number of days in the relevant interest reset period.

The term ***representative amount*** means an amount that, in the calculation agent's judgment, is representative of a single transaction in the relevant market at the relevant time.

***Reuters page*** means the display on the Reuters service, or any successor service, on the page or pages specified in this prospectus or the applicable supplement, or any replacement page or pages on that service.

***Reuters screen FEDFUNDS1 page*** means Reuters screen FEDFUNDS1 page or any replacement page or pages on which U.S. dollar federal funds rates are displayed.

***Reuters screen LIBO page*** means the display on the Reuters service, or any successor service, on the page designated as LIBO or any replacement page or pages on which London interbank rates of major banks for the relevant index currency are displayed.

***Reuters screen LIBOR01 page*** means Reuters screen LIBOR01 page or any replacement page or pages on which London interbank rates of major banks for the relevant index currency are displayed.

***Reuters screen USAUCTION10 or USAUCTION11 page*** means Reuters screen USAUCTION10 page or Reuters screen USAUCTION11 page or any replacement page or pages on which U.S. Treasury auction rates are displayed.

***Reuters screen US PRIME 1 page*** means the display on the US PRIME 1 page on the Reuters service, or any successor service, or any replacement page or pages on that service, for the purpose of displaying prime rates or base lending rates of major U.S. banks.

If, when we use the terms designated CMT Reuters page, H.15(519), H.15 daily update, Reuters screen LIBO page, Reuters screen US PRIME 1 page, Reuters screen LIBOR01 page or Reuters page, we refer to a particular heading or headings on any of those pages, those references include any successor or replacement heading or headings as determined by the calculation agent.

**Withholding**

Wachovia or the applicable paying agent will deduct or withhold from a payment on a note any tax, assessment or other governmental charge that Wachovia determines is legally required to be deducted or

withheld. Payments on a note will not be increased by any amount to offset such deduction or withholding, unless otherwise specified in the applicable supplement.

**Other Provisions; Addenda**

Any provisions relating to the notes, including the determination of the interest rate basis, calculation of the interest rate applicable to a floating rate note, its interest payment dates, any redemption or repayment provisions, or any other term relating thereto, may be modified and/or supplemented by the terms as specified under **Other Provisions** on the face of the applicable notes or in an Addendum relating to the applicable notes, if so specified on the face of the applicable notes, and, in each case, in the applicable supplement.

**Subordination of the Subordinated Notes**

Wachovia's obligations to make any payment of the principal and interest on any subordinated notes will, to the extent the subordinated indenture specifies, be subordinate and junior in right of payment to all of Wachovia's senior indebtedness. Unless otherwise specified in the applicable supplements relating to a specific series of subordinated notes, Wachovia's senior indebtedness is defined in the subordinated indenture to mean the principal of, premium and interest, if any, on:

all Wachovia indebtedness for money borrowed, including indebtedness Wachovia guarantees, other than the subordinated notes, whether outstanding on the date of execution of the indenture or incurred afterward, except

any obligations on account of Existing Subordinated Indebtedness, and

indebtedness as is by its terms expressly stated to be not superior in payment right to the subordinated notes or to rank equal to the subordinated notes; and

any deferrals, renewals or extensions of any such senior indebtedness. (*Section 101* of the subordinated indenture).

The payment of the principal and interest on the subordinated notes will, to the extent described in the subordinated indenture, be subordinated in payment right to the prior payment of all senior indebtedness. Unless otherwise described in the applicable supplements relating to the specific series of subordinated notes, in certain events of insolvency, the payment of the principal and interest on the subordinated notes, other than subordinated notes that are also Existing Subordinated Indebtedness, will, to the extent described in the subordinated indenture, also be effectively subordinated in payment right to the prior payment of all Other Financial Obligations. Upon any payment or distribution of assets to creditors under Wachovia's liquidation, dissolution, winding up, reorganization, assignment for the benefit of creditors, or any bankruptcy, insolvency or similar proceedings, all senior indebtedness holders will be entitled to receive payment in full of all amounts due before the subordinated note holders will be entitled to receive any payment in respect of the principal or interest on their securities. If upon any such payment or asset distribution to creditors, there remains, after giving effect to those subordination provisions in favor of senior indebtedness holders, any amount of cash, property or securities available for payment or distribution in respect of subordinated notes (defined in the subordinated indenture as **Excess Proceeds**) and if, at that time, any Entitled Persons (as defined below) in respect of Other Financial Obligations have not received payment of all amounts due on such Other Financial Obligations, then such Excess Proceeds shall first be applied to pay these Other Financial Obligations before any payment may be applied to the subordinated notes which are not Existing Subordinated Indebtedness. In the event of the acceleration of the maturity of any subordinated notes, all senior indebtedness holders will be entitled to receive payment of all amounts due before the subordinated note holders will be entitled to receive any payment upon the principal of or interest on their subordinated notes. (*Sections 1403, 1404 and 1413* of the subordinated indenture)

By reason of such subordination in favor of senior indebtedness holders, in the event of insolvency, Wachovia's creditors who are not senior indebtedness holders or subordinated note holders may recover less,

ratably, than senior indebtedness holders and may recover more, ratably, than subordinated note holders. By reason of subordinated note holders (other than Existing Subordinated Indebtedness) to pay over any Excess Proceeds to Entitled Persons in respect to Other Financial Obligations, in the event of insolvency, Existing Subordinated Indebtedness holders may recover less, ratably, than Entitled Persons in respect of Other Financial Obligations and may recover more, ratably, than the subordinated note holders (other than Existing Subordinated Indebtedness).

Unless otherwise specified in the applicable supplements relating to the particular subordinated notes series offered by it, Existing Subordinated Indebtedness means subordinated notes issued under the subordinated indenture prior to November 15, 1992. (*Section 101* of the subordinated indenture)

Unless otherwise specified in the applicable supplements relating to the particular subordinated notes series offered by it, Other Financial Obligations means all obligations of Wachovia to make payment under the terms of financial instruments, such as:

securities contracts and foreign currency exchange contracts;

derivative instruments such as

swap agreements (including interest rate and foreign exchange rate swap agreements);

cap agreements;

floor agreements;

collar agreements;

interest rate agreements;

foreign exchange rate agreements;

options;

commodity futures contracts;

commodity option contracts; and

similar financial instruments other than

obligations on account of senior indebtedness; and

obligations on account of indebtedness for money borrowed ranking equal or subordinate to the subordinated notes. (*Section 101* of the subordinated indenture).

Unless otherwise described in the applicable supplements relating to a specific series of subordinated notes, *Entitled Persons* means any person who is entitled to payment under the terms of Other Financial Obligations. (*Section 101* of the subordinated indenture)

Wachovia's obligations under the subordinated notes shall rank equal in right of payment with each other and with the Existing Subordinated Indebtedness, subject, unless otherwise described in the applicable supplements relating to a specific series of subordinated notes, to the obligations of subordinated note holders (other than Existing Subordinated Indebtedness) to pay over any Excess Proceeds to Entitled Persons in respect of Other Financial Obligations as provided in the subordinated indenture. (*Section 1413* of the subordinated indenture)

The applicable supplements may further describe the provisions, if any, applicable to the subordination of the subordinated notes of a particular series.

### **Defaults**

#### ***The Senior Indenture***

The senior indenture defines an event of default as:

default in any principal or premium payment on any senior note of that series at maturity;

default for 30 days in interest payment of any senior note of that series;

failure to deposit any sinking fund payment when due in respect of that series;

Wachovia's failure for 60 days after notice in performing any other covenants or warranties in the senior indenture (other than a covenant or warranty solely for the benefit of other senior notes series);

failure to pay when due any Wachovia indebtedness or Wachovia Bank, National Association indebtedness in excess of \$5,000,000, or maturity acceleration of any indebtedness exceeding that amount if acceleration results from a default under the instrument giving rise to that indebtedness and is not annulled within 30 days after due notice;

Wachovia's or Wachovia Bank, National Association's bankruptcy, insolvency or reorganization; and

any other event of default provided for senior notes of that series. (*Section 501*)

The senior indenture provides that, if any event of default for senior notes of any series outstanding occurs and is continuing, either the senior trustee or the holders of not less than 25% in principal amount of the outstanding senior notes of that series may declare the principal amount (or, if the notes of that series are original issue discount notes, such principal amount portion as the terms of that series specify) of all senior notes of that series to be due and payable immediately. However, no such declaration is required upon certain bankruptcy events. In addition, upon fulfillment of certain conditions, this declaration may be annulled and past defaults waived by the holders of a majority in principal amount of the outstanding senior notes of that series on behalf of all senior note holders of that series. (*Sections 502 and 513*) In the event of Wachovia's bankruptcy, insolvency or reorganization, senior note holders' claims would fall under the broad equity power of a federal bankruptcy court, and to that court's determination of the nature of those holders' rights.

The senior indenture contains a provision entitling the senior trustee, acting under the required standard of care, to be indemnified by the holders of any outstanding senior note series before proceeding to exercise any right or power under the senior indenture at the holders' request. (*Section 603*) The holders of a majority in principal amount of outstanding senior notes of any series may direct the time, method and place of conducting any proceeding for any remedy available to the senior trustee, or exercising any trust or other power conferred on the senior trustee, with respect to the senior notes of such series. The senior trustee, however, may decline to act if that direction is contrary to law or the senior indenture or would involve the senior trustee in personal liability. (*Section 512*)

Wachovia will file annually with the senior trustee a compliance certificate as to all conditions and covenants in the senior indenture. (*Section 1007*)

#### ***The Subordinated Indenture***

Subordinated notes principal payment may be accelerated only upon an event of default. There is no acceleration right in the case of a default in the payment of interest or principal prior to the maturity date or a default in Wachovia performing any covenants in the subordinated indenture, unless a specific series of subordinated notes provide otherwise, which will be described in the applicable supplements.

The subordinated indenture defines an event of default as certain events involving Wachovia's bankruptcy, insolvency or reorganization and any other event of default provided for the subordinated notes of that series. (*Section 501*) The subordinated indenture defines a default to include:

any event of default;

a default in any principal or premium payment of any subordinated debt security of that series at maturity;

default in any interest payment when due and continued for 30 days;

a default in any required designation of funds as available funds; or

default in the performance, or breach, of Wachovia's covenants in the subordinated indenture or in the subordinated notes of that series and continued for 90 days after written notice to

Wachovia by the subordinated trustee; or

Wachovia and the subordinated trustee by the holders of not less than 25% in aggregate principal amount of the outstanding subordinated notes of that series. (*Section 503*)

If an event of default for subordinated notes of any series occurs and is continuing, either the subordinated trustee or the holders of not less than 25% in aggregate principal amount of the outstanding subordinated notes of that series may accelerate the maturity of all outstanding subordinated notes of such series. The holders of a majority in aggregate principal amount of the outstanding subordinated notes of that series may waive an event of default resulting in acceleration of the subordinated notes of such series, but only if all events of default have been remedied and all payments due on the subordinated notes of that series (other than those due as a result of acceleration) have been made and certain other conditions have been met. (*Section 502*) Subject to subordinated indenture provisions relating to the subordinated trustee's duties, in case a default shall occur and be continuing, the subordinated trustee will be under no obligation to exercise any of its rights or powers under the subordinated indenture at the holders' request or direction, unless such holders shall have offered to the subordinated trustee reasonable indemnity. (*Section 603*) Subject to such indemnification provisions, the holders of a majority in aggregate principal amount of the outstanding subordinated notes of that series will have the right to direct the time, method and place of conducting any proceeding for any remedy available to the subordinated trustee or exercising any trust or power conferred on the subordinated trustee. (*Section 512*) The holders of a majority in aggregate principal amount of the outstanding subordinated notes of that series may waive any past default under the subordinated indenture with respect to such series, except a default in principal or interest payment or a default of a subordinated indenture covenant which cannot be modified without the consent of each outstanding subordinated note holder of the series affected. (*Section 513*) In the event of Wachovia's bankruptcy, insolvency or reorganization, subordinated note holders' claims would fall under the broad equity power of a federal bankruptcy court, and to that court's determination of the nature of those holders' rights.

Wachovia will file annually with the subordinated trustee a compliance certificate as to all conditions and covenants in the subordinated indenture. (*Section 1007*)

## **Modification and Waiver**

Each indenture may be modified and amended by Wachovia and the relevant trustee. Certain modifications and amendments require the consent of the holders of at least a majority in aggregate principal amount of the outstanding notes of each series issued under that indenture and affected by the modification or amendment. No such modification or amendment may, without the consent of the holder of each outstanding note issued under such indenture and affected by it:

change the stated maturity of the principal, or any installment of principal or interest, on any outstanding note;

reduce any principal amount, premium or interest, on any outstanding note, including in the case of an original issue discount note the amount payable upon acceleration of the maturity of that note;

change the place of payment where, or the coin or currency or currency unit in which, any principal, premium or interest, on any outstanding note is payable;

impair the right to institute suit for the enforcement of any payment on or after the stated maturity, or in the case of redemption, on or after the redemption date;

reduce the above-stated percentage of outstanding notes necessary to modify or amend the applicable indenture; or

modify the above requirements or reduce the percentage of aggregate principal amount of outstanding notes of any series required to be held by holders seeking to waive compliance with certain provisions of the relevant indenture or seeking to waive certain defaults. (*Section 902*)

The holders of at least a majority in aggregate principal amount of the outstanding notes of any series may on behalf of all outstanding note holders of that series waive, insofar as that series is concerned, Wachovia's compliance with certain restrictive provisions of the relevant indenture. (*Section 1008*) The holders of at least a majority in aggregate principal amount of the outstanding notes of any series may on behalf of all outstanding note holders of that series waive any past default under the relevant indenture with respect to that series, except a default in the payment of the principal, or premium, if any, or interest on any outstanding note of that series or in respect of an indenture covenant which cannot be modified or amended without each outstanding note holder consenting. (*Section 513*)

Certain modifications and amendments of each indenture may be made by Wachovia and the relevant trustee without the outstanding note holders consenting. (*Section 901*)

Each indenture provides that in determining whether the holders of the requisite principal amount of the outstanding notes have given any request, demand, authorization, direction, notice, consent or waiver under that indenture or are present at a meeting of holders of outstanding notes for quorum purposes:

the principal amount of an original issue discount note that shall be deemed to be outstanding shall be the amount of the principal that would be due and payable as of the date of such determination upon acceleration of its maturity; and

the principal amount of outstanding notes denominated in a foreign currency or currency unit shall be the U.S. dollar equivalent, determined on the date of original issuance of that outstanding note, of the principal amount of that outstanding note or, in the case of an original issue discount note, the U.S. dollar equivalent, determined on the date of original issuance of such outstanding note, of the amount determined as provided in the above bullet-point. (*Section 101*)

**Consolidation, Merger and Sale of Assets**

The indentures each provide that Wachovia may not consolidate with or merge into any other corporation or transfer its properties and assets substantially as an entirety to any person unless:

the corporation formed by the consolidation or into which Wachovia is merged, or the person to which Wachovia's properties and assets are so transferred, shall be a corporation organized and existing under the laws of the U.S., any state or Washington, D.C. and shall expressly assume by supplemental indenture the payment of any principal, premium or interest on the notes, and the performance of Wachovia's other covenants under the relevant indenture;

immediately after giving effect to this transaction, no event of default or default, as applicable, and no event which, after notice or lapse of time or both, would become an event of default or default, as applicable, shall have occurred and be continuing; and

certain other conditions are met. (*Section 801*)

### **Limitation on Disposition of Wachovia Bank, National Association Stock**

The indentures each contain Wachovia's covenant that, so long as any of the debt securities issued under that indenture before August 1, 1990 are outstanding, but subject to Wachovia's rights in connection with its consolidation with or merger into another corporation or a sale of Wachovia's assets, it will not sell, assign, transfer, grant a security interest in or otherwise dispose of any shares of, securities convertible into, or options, warrants or rights to subscribe for or purchase shares of, Wachovia Bank, National Association voting stock, nor will it permit Wachovia Bank, National Association to issue any shares of, or securities convertible into, or options, warrants or rights to subscribe for or purchase shares of, Wachovia Bank, National Association voting stock, unless:

any such sale, assignment, transfer, issuance, grant of a security interest or other disposition is made for fair market value, as determined by Wachovia's board; and

Wachovia will own at least 80% of the issued and outstanding Wachovia Bank, National Association voting stock free and clear of any security interest after giving effect to such transaction. (*Section 1006*)

The above covenant is not a covenant for the benefit of any series of notes issued on or after August 1, 1990.

### **Restriction on Sale or Issuance of Voting Stock of Major Subsidiary Bank**

With respect to the senior notes, the senior indenture contains Wachovia's covenant that it will not, and will not permit any subsidiary to, sell, assign, transfer, grant a security interest in, or otherwise dispose of, any shares of voting stock, or any securities convertible into shares of voting stock, of any Major Subsidiary Bank (as defined below) or any subsidiary owning, directly or indirectly, any shares of voting stock of any Major Subsidiary Bank and that it will not permit any Major Subsidiary Bank or any subsidiary owning, directly or indirectly, any shares of voting stock of a Major Subsidiary Bank to issue any shares of its voting stock or any securities convertible into shares of its voting stock, except for sales, assignments, transfers or other dispositions which

are for the purpose of qualifying a person to serve as a director;

are for fair market value, as determined by Wachovia's board, and, after giving effect to such dispositions and to any potential dilution, Wachovia will own not less than 80% of the shares of voting stock of such Major Subsidiary Bank or any such subsidiary owning any shares of voting stock of such Major Subsidiary Bank;

are made

in compliance with court or regulatory authority order; or

in compliance with a condition imposed by any such court or authority permitting Wachovia's acquisition of any other bank or entity; or

in compliance with an undertaking made to such authority in connection with such an acquisition; provided, in the case of the two preceding bullet-points, the assets of the bank or entity being acquired and its consolidated subsidiaries equal or exceed 75% of the assets of such Major Subsidiary Bank or such subsidiary owning, directly or indirectly, any shares of voting stock of a Major Subsidiary Bank and its respective consolidated subsidiaries on the date of acquisition; or

to Wachovia or any wholly-owned subsidiary.

Despite the above requirements, any Major Subsidiary Bank may be merged into or consolidated with another banking institution organized under U.S. or state law, if after giving effect to that merger or

consolidation Wachovia or any wholly-owned subsidiary owns at least 80% of the voting stock of the other banking institution free and clear of any security interest and if, immediately after the merger or consolidation, no event of default, and no event which, after notice or lapse of time or both, would become an event of default, shall have happened and be continuing. (*Section 1007*) A Major Subsidiary Bank is defined in each indenture to mean any subsidiary which is a bank and has total assets equal to 25% or more of Wachovia's consolidated assets determined on the date of the most recent audited financial statements of these entities. At present, the Major Subsidiary Bank is Wachovia Bank, National Association.

The above covenant is not a covenant for the benefit of any series of debt securities issued before August 1, 1990, or, in the case of subordinated debt securities including the subordinated notes, issued after November 15, 1992.

## **Form, Exchange and Transfer**

If the notes cease to be issued in global form, they will be issued

only in fully registered form;

without interest coupons; and

unless we indicate otherwise in the applicable supplements, in denominations of \$1,000 and that are multiples of \$1,000.

Holders may exchange their notes for notes of smaller denominations or combined into fewer notes of larger denominations, as long as the total principal amount is not changed.

Holders may exchange or transfer their notes at the office of the relevant trustee, or in the event definitive notes are issued and so long as the notes are listed on the Luxembourg Stock Exchange, at the offices of the paying agent. We have appointed the respective trustees to act as our agents for registering notes in the names of holders and transferring notes. We may appoint another entity to perform these functions or perform them ourselves.

Holders will not be required to pay a service charge to transfer or exchange their notes, but they may be required to pay for any tax or other governmental charge associated with the exchange or transfer. The transfer or exchange will be made only if our transfer agent is satisfied with the holder's proof of legal ownership.

If we have designated additional transfer agents for your note, they will be named in your pricing supplement. We may appoint additional transfer agents or cancel the appointment of any particular transfer agent. We may also approve a change in the office through which any transfer agent acts.

If any notes are redeemable and we redeem less than all those notes, we may block the transfer or exchange of those notes during the period beginning 15 days before the day we mail the notice of redemption and ending on the day of that mailing, in order to freeze the list of holders to prepare the mailing. We may also refuse to register transfers of or exchange any note selected for redemption, except that we will continue to permit transfers and exchanges of the unredeemed portion of any note being partially redeemed.

If a note is issued as a global note, only the depositary (e.g., DTC, Euroclear and Clearstream) will be entitled to transfer and exchange the note as described in this subsection, since it will be the sole holder of the note.

## **Payment Mechanics**

### ***Who Receives Payment?***

If interest is due on a note on an interest payment date, we will pay the interest to the person or entity in whose name the note is registered at the close of business on the regular record date relating to the interest

payment date. If interest is due at maturity but on a day that is not an interest payment date, we will pay the interest to the person or entity entitled to receive the principal of the note. If principal or another amount besides interest is due on a note at maturity, we will pay the amount to the holder of the note against surrender of the note at a proper place of payment (or, in the case of a global note, in accordance with the applicable policies of the depositary).

### ***How We Will Make Payments Due in U.S. Dollars***

We will follow the practice described in this subsection when paying amounts due in U.S. dollars. Payments of amounts due in other currencies will be made as described in the next subsection.

***Payments on Global Notes.*** We will make payments on a global note in accordance with the applicable policies of the depositary as in effect from time to time. Under those policies, we will pay directly to the depositary, or its nominee, and not to any indirect holders who own beneficial interests in the global note. An indirect holder's right to receive those payments will be governed by the rules and practices of the depositary and its participants, as described under *Global Securities* and *Global Notes*.

***Payments on Non-Global Notes.*** We will make payments on a note in non-global form as follows. We will pay interest that is due on an interest payment date by check mailed on the interest payment date to the holder at his or her address shown on the trustee's records as of the close of business on the regular record date. We will make all other payments by check at the paying agent described below, against surrender of the note. All payments by check will be made in next-day funds i.e., funds that become available on the day after the check is cashed.

Alternatively, if a non-global note has a face amount of at least \$1,000,000 and the holder asks us to do so, we will pay any amount that becomes due on the note by wire transfer of immediately available funds to an account at a bank in New York City, on the due date. To request wire payment, the holder must give the paying agent appropriate wire transfer instructions at least five business days before the requested wire payment is due. In the case of any interest payment due on an interest payment date, the instructions must be given by the person or entity who is the holder on the relevant regular record date. In the case of any other payment, payment will be made only after the note is surrendered to the paying agent. Any wire instructions, once properly given, will remain in effect unless and until new instructions are given in the manner described above.

*Book-entry and other indirect holders should consult their banks or brokers for information on how they will receive payments on their notes.*

### ***How We Will Make Payments Due In Other Currencies***

We will follow the practice described in this subsection when paying amounts that are due in a specified currency other than U.S. dollars.

***Payments on Global Notes.*** We will make payments on a global note in accordance with the applicable policies as in effect from time to time of the depositary, which will be DTC, Euroclear or Clearstream. Unless we specify otherwise in the applicable pricing supplement, DTC will be the depositary for all notes in global form. We understand that DTC's policies, as currently in effect, are as follows.

Unless otherwise indicated in the applicable supplements, if you are an indirect holder of global notes denominated in a specified currency other than U.S. dollars and if you elect to receive payments in that other

currency, you must notify the participant through which your interest in the global note is held of your election:

on or before the applicable regular record date, in the case of a payment of interest, or

on or before the 16th day prior to stated maturity, or any redemption or repayment date, in the case of payment of principal or any premium.

You may elect to receive all or only a portion of any interest, principal or premium payment in a specified currency other than U.S. dollars.

Your participant must, in turn, notify DTC of your election on or before the third DTC business day after that regular record date, in the case of a payment of interest, and on or before the 12th DTC business day prior to stated maturity, or on the redemption or repayment date if your note is redeemed or repaid earlier, in the case of a payment of principal or any premium.

DTC, in turn, will notify the paying agent of your election in accordance with DTC's procedures.

If complete instructions are received by the participant and forwarded by the participant to DTC, and by DTC to the paying agent, on or before the dates noted above, the paying agent, in accordance with DTC's instructions will make the payments to you or your participant by wire transfer of immediately available funds to an account maintained by the payee with a bank located in the country issuing the specified currency or in another jurisdiction acceptable to us and the paying agent.

If the foregoing steps are not properly completed, we expect DTC to inform the paying agent that payment is to be made in U.S. dollars. In that case, we or our agent will convert the payment to U.S. dollars in the manner described below under "Conversion to U.S. Dollars". We expect that we or our agent will then make the payment in U.S. dollars to DTC, and that DTC in turn will pass it along to its participants.

*Indirect holders of a global note denominated in a currency other than U.S. dollars should consult their banks or brokers for information on how to request payment in the specified currency.*

***Payments on Non-Global Notes.*** Except as described in the last paragraph under this heading, we will make payments on notes in non-global form in the applicable specified currency. We will make these payments by wire transfer of immediately available funds to any account that is maintained in the applicable specified currency at a bank designated by the holder and is acceptable to us and the trustee. To designate an account for wire payment, the holder must give the paying agent appropriate wire instructions at least five business days before the requested wire payment is due. In the case of any interest payment due on an interest payment date, the instructions must be given by the person or entity who is the holder on the regular record date. In the case of any other payment, the payment will be made only after the note is surrendered to the paying agent. Any instructions, once properly given, will remain in effect unless and until new instructions are properly given in the manner described above.

If a holder fails to give instructions as described above, we will notify the holder at the address in the trustee's records and will make the payment within five business days after the holder provides appropriate instructions. Any late payment made in these circumstances will be treated under the indenture as if made on the due date, and no interest will accrue on the late payment from the due date to the date paid.

Although a payment on a note in non-global form may be due in a specified currency other than U.S. dollars, we will make the payment in U.S. dollars if the holder asks us to do so. To request U.S. dollar payment, the holder must provide appropriate written notice to the trustee at least five business days before

the next due date for which payment in U.S. dollars is requested. In the case of any interest payment due on an interest payment date, the request must be made by the person or entity who is the holder on the regular record date. Any request, once properly made, will remain in effect unless and until revoked by notice properly given in the manner described above.

*Book-entry and other indirect holders of a note with a specified currency other than U.S. dollars should contact their banks or brokers for information about how to receive payments in the specified currency or in U.S. dollars.*

**Conversion to U.S. Dollars.** When we are asked by a holder to make payments in U.S. dollars of an amount due in another currency, either on a global note or a non-global note as described above, the exchange rate agent described below will calculate the U.S. dollar amount the holder receives in the exchange rate agent's discretion.

A holder that requests payment in U.S. dollars will bear all associated currency exchange costs, which will be deducted from the payment.

**When the Specified Currency is Not Available.** If we are obligated to make any payment in a specified currency other than U.S. dollars, and the specified currency or any successor currency is not available to us due to circumstances beyond our control such as the imposition of exchange controls or a disruption in the currency markets we will be entitled to satisfy our obligation to make the payment in that specified currency by making the payment in U.S. dollars, on the basis of the exchange rate determined by the exchange rate agent described below, in its discretion.

The foregoing will apply to any note, whether in global or non-global form, and to any payment, including a payment at maturity. Any payment made under the circumstances and in a manner described above will not result in a default under any note or the relevant indenture.

**Exchange Rate Agent.** If we issue a note in a specified currency other than U.S. dollars, we will appoint a financial institution to act as the exchange rate agent and will name the institution initially appointed when the note is originally issued in the applicable pricing supplement. We may select Wachovia Bank, National Association, Wachovia Securities or another of our affiliates to perform this role. We may change the exchange rate agent from time to time after the original issue date of the note without your consent and without notifying you of the change.

All determinations made by the exchange rate agent will be at its sole discretion unless we state in the applicable pricing supplement that any determination requires our approval. In the absence of manifest error, those determinations will be conclusive for all purposes and binding on you and us, without any liability on the part of the exchange rate agent.

### ***Payment When Offices Are Closed***

If any payment is due on a note on a day that is not a business day, we will make the payment on the next day that is a business day. Payments postponed to the next business day in this situation will be treated under the relevant indenture as if they were made on the original due date. Postponement of this kind will not result in a default under any note or the indenture, and no interest will accrue on the postponed amount from the original due date to the next day that is a business day. The term business day has a special meaning, which we describe above under **Interest Rates - Special Rate Calculation Terms**.

### ***Paying Agent***

We may appoint one or more financial institutions to act as our paying agents, at whose designated offices notes in non-global entry form may be surrendered for payment at their maturity. We call each of those offices a paying agent. We may add, replace or terminate paying agents from time to time. We may also choose to act as our own paying agent. We have appointed U.S. Bank National Association, at its corporate trust office in New York City as the initial paying agent. We must notify you of changes in the paying agents.

Citibank, N.A., acting through its London office (or such other agent appointed in accordance with the Senior Indenture or the Subordinated Indenture, as the case may be), will act as London paying agent and London issuing agent.

### ***Unclaimed Payments***

Regardless of who acts as paying agent, all money paid by us to a paying agent that remains unclaimed at the end of two years after the amount is due to a holder will be repaid to us. After that two-year period, the holder may look only to us for payment and not to the relevant trustee, any other paying agent or anyone else.

### ***Notices***

Notices to be given to holders of a global note will be given only to the depository, in accordance with its applicable policies as in effect from time to time. Notices to be given to holders of notes not in global form will be sent by mail to the respective addresses of the holders as they appear in the relevant trustee's records, and will be deemed given when mailed.

Neither the failure to give any notice to a particular holder, nor any defect in a notice given to a particular holder, will affect the sufficiency of any notice given to another holder.

Book-entry and other indirect holders should consult their banks or brokers for information on how they will receive notices.

### **Trustees**

Either or both of the trustees may resign or be removed with respect to one or more series of notes and a successor trustee may be appointed to act with respect to that series. (*Section 610*) In the event that two or more persons are acting as trustee with respect to different series of notes, each such trustee shall be a trustee of a trust under the relevant indenture separate and apart from the trust administered by any other such trustee (*Section 611*), and any action to be taken by the trustee may then be taken by each such trustee with respect to, and only with respect to, the one or more series of notes for which it is trustee.

In the normal course of business, Wachovia and its subsidiaries conduct banking transactions with the trustees and their affiliates, and the trustees and their affiliates conduct banking transactions with Wachovia and its subsidiaries.

### **Title**

Wachovia, the trustees and any of their agents may treat the registered owner of any note as the absolute owner of that security, whether or not that note is overdue and despite any notice to the contrary, for any purpose. See *Global Securities* .

### **Governing Law**

The indentures are, and the notes will be, governed by New York law.

**DESCRIPTION OF THE WARRANTS WE MAY OFFER**

*The following information outlines some of the provisions of the warrant indenture, the warrant agreements and the warrants. This information may not be complete in all respects and is qualified entirely by reference to the warrant indenture or the relevant warrant agreement with respect to the warrants of any particular series. The specific terms of any series of warrants will be described in the applicable supplements. If so described in the applicable supplements, the terms of that series of warrants may differ from the general description of terms presented below. Please note that in this section entitled *Description of the Warrants We May Offer*, references to *Wachovia*, *we*, *us* and *our* refer only to Wachovia Corporation and not to its subsidiaries. Also, in this section, references to *warrant holders* mean those who own warrants registered in their own names, on the books that we or the applicable warrant agent maintain for this purpose, and not those who own beneficial interests in warrants registered in street name or in warrants issued in book-entry form through one or more depositories. Owners of beneficial interest in the warrants should read the section below entitled *Global Securities*.*

**General**

We may issue warrants from time to time in such amounts and in as many distinct series as we wish. We will issue each series of warrants under either a warrant indenture or a warrant agreement. This section summarizes terms of the warrant indenture and warrant agreements and terms of the warrants that apply generally to the warrants. We describe most of the financial and other specific terms of your warrant in the applicable supplements accompanying this prospectus. Those terms may vary from the terms described here.

As you read this section, please remember that the specific terms of your warrant as described in the applicable supplements will supplement and, if applicable, may modify or replace the general terms described in this section. If there are differences between the applicable supplements and this prospectus, the applicable supplements will control. Thus, the statements we make in this section may not apply to your warrant.

When we refer to a series of warrants, we mean all warrants issued as part of the same series under the applicable indenture or warrant agreement. When we refer to the applicable supplements, we mean the product supplement or pricing supplement describing the specific terms of the warrant you purchase.

We may issue warrants to purchase our debt securities on terms to be determined at the time of sale. We refer to these warrants as *debt warrants*.

We may also issue warrants to purchase or sell, or whose cash value is determined by reference to the performance, price, level or value of, one or more of the following, on terms to be determined at the time of sale:

securities of one or more issuers, including our common stock or other equity securities, or debt or equity securities of a third party;

one or more currencies;

one or more commodities;

any other financial, economic or other measure or instrument, including the occurrence or non-occurrence of any event or circumstance; or

one or more indices or baskets of the items described above.

We refer to these warrants as *universal warrants*.

We refer to the property in the above clauses as *warrant property*. We may satisfy our obligations, if any, with respect to any warrants by delivering the warrant property or, in the case of warrants to purchase or

sell securities, commodities or other property, the cash value of the securities or commodities, as described in the applicable supplement. Unless otherwise required by contract, both types of warrants shall be referred to as warrants .

### **Legal Ownership**

#### ***Street Name and Other Indirect Holders***

Investors who hold their warrants in accounts at banks or brokers will generally not be recognized by us as legal holders of warrants. This is called holding in street name. Instead, we would recognize only the bank or broker, or the financial institution the bank or broker uses to hold its warrants. These intermediary banks, brokers and other financial institutions pass along warrant property and other payments on the warrants, either because they agree to do so in their customer agreements or because they are legally required to do so. If you hold your warrants in street name, you should check with your own institution to find out:

how it handles warrant payments and notices;

whether it imposes fees or charges;

how it would handle voting if it were ever required;

whether and how you can instruct it to send you warrants registered in your own name so you can be a direct holder as described below; and

how it would pursue rights under the warrants if there were a default or other event triggering the need for holders to act to protect their interests.

#### ***Direct Holders***

Our obligations, as well as the obligations of the trustee or any warrant agent and those of any third parties employed by us or the trustee or any warrant agent, under the warrants, the warrant indenture and any warrant agreement run only to persons who are registered as holders of warrants. As noted above, we do not have obligations to you if you hold in street name or other indirect means, either because you choose to hold your warrants in that manner or because the notes are issued in the form of global securities as described below. For example, once we make payment to the registered holder or the depository we have no further responsibility for the payment even if that holder or depository is legally required to pass the payment along to you as a street name customer but does not do so.

#### ***Global Warrants***

A global warrant is a special type of indirectly held security, as described above under Street Name and Other Indirect Holders . If we choose to issue warrants in the form of global warrants, the ultimate beneficial owners of global warrants can only be indirect holders. We require that the global warrant be registered in the name of a financial institution we select.

We also require that the warrants included in the global warrant not be transferred to the name of any other direct holder except in the special circumstances described in the section Global Securities . The financial institution that acts as the sole direct holder of the global warrant is called the depository. Any person wishing to own a global warrant must do so indirectly by virtue of an account with a broker, bank or other financial institution that in turn has an account with the depository. The applicable supplements indicate whether your series of warrants will be issued only in the form of global warrants.

Further details of legal ownership are discussed in the section Global Securities below.

### **Information in Applicable Supplements**

The applicable supplements relating to a series of warrants will describe whether the warrants or debt warrants or universal warrants, whether the warrants are being issued under a warrant indenture or a warrant agreement, and any other applicable terms, including

the offering price,

the currency or currency unit with which the warrants may be purchased and in which any payments due to or from the warrant holder upon exercise must be made,

the price at which and the currency with which the warrant property may be purchased or sold upon the exercise of each warrant, or the method of determining that price,

whether the warrants are put warrants (entitling the warrant holder to sell the warrant property or receive the cash value of the right to sell the warrant property), call warrants (entitling the warrant holder to buy the warrant property or receive the cash value of the right to buy the warrant property), spread warrants (entitling the warrant holder to receive a cash value determined by reference to the amount, if any, by which a specified reference value of the warrant property at the time of exercise exceeds a specified base value of the warrant property) or another type of warrant, as described in the applicable supplements, and whether you or we will have the right to exercise the warrants and any conditions or restrictions on the exercise of the warrants,

the specific warrant property, including in the case of warrants for the purchase of our debt securities, the designation, aggregate principal amount, currency and terms of the debt securities subject to the warrant, as well as the amount or the method for determining the amount of the warrant property, purchasable or saleable upon exercise of each warrant,

whether the exercise price may be paid in cash, by the exchange of any other security, debt security or property offered with the warrants or both and the method of exercising the warrants,

whether the exercise of the warrants is to be settled in cash or by delivery of the underlying securities, debt securities, commodities, other property or combination thereof,

the dates on which the right to exercise the warrants will commence and expire and, if the warrants are not continuously exercisable, any dates on which the warrants are not exercisable,

whether and under what circumstances the warrants may be cancelled by us prior to their expiration date, in which case the holders will be entitled to receive only the applicable cancellation amount, which may be either a fixed amount or an amount that varies during the term of the warrants in accordance with a schedule or formula,

the minimum number, if any, of warrants that must be exercised at any one time, other than upon automatic exercise,

the maximum number, if any, of warrants that may, subject to election by us, be exercised by all owners (or by any person or entity) on any day,

any provisions for the automatic exercise of the warrants at expiration or otherwise,

if the warrant property is an index or a basket of securities or debt securities, a description of the index or basket of securities or debt securities as the case may be,
