The Restricted Stock Unit is also subject to accelerated vesting upon certain event.

- (5) On March 24, 2017, Reporting Person was granted 7,035 Restricted Stock Units, subject to a 4-year vesting schedule. 1/16 of the total number of shares vesting quarterly on the 15th day of the second month of each calendar quarter following the grant date. The Restricted Stock Units are also subject to accelerated vesting upon certain events.
