Because of the short amount of time that L.L. Bradford has been serving in that capacity, the registrant has not had sufficient time to provide L.L. Bradford with all of the information needed for them to complete their review of the Form 10-QSB prior to the current due date.

The increased net loss experienced in 2005 was primarily a result of an expense of \$800,000 that was incurred in connection with the settlement of a legal action involving the Company.
