Item 3. Source and Amount of Funds or Other Consideration

Item 3 is hereby supplemented as follows:

From October 29, 2007 through November 20, 2007, Master Fund acquired 112,126 shares of Common Stock in open market transactions for an aggregate purchase price of approximately \$1,211,000 using working capital.

Item 5. Interest in Securities of the Issuer

Item 5 is hereby amended and restated in its entirety as follows:

(a) As of November 20, 2007, the Reporting Persons may be deemed to beneficially own 581,343 shares of Common Stock (which represents approximately 6.2% of the outstanding Common Stock based upon information contained in the Issuer s Form 10-Q for the quarter ended September 30, 2007).
