These shares were acquired in routing exempt acquisition pursuant to Rule 16b-3 on a periodic basis between June 1, 2006 and May 31, 2007. The information reported herein is based upon estimates provided by the Plan's recordkeeper as of May 31, 2007.

This represents the average price of shares acquired in the RP's account during the time period June 1, 2006 and May 31, 2007 through the Biomet, Inc. Employee Stock Bonus Plan qualified under Section 401(a) of the Internal Revenue Code, which was merged into the Biomet 401(k) Savings and Retirement Plan.
