373 of 1,867 RSUs granted on October 19, 2015 vested on each of October 19, 2016 and October 19, 2017. 373 RSUs will vest on October 19, 2018 and 374 RSUs will vest on each of October 19, 2019, and October 19, 2020, provided that the Reporting Person remains continuously employed by the Issuer through each applicable vesting date. The vested shares will be delivered to the Reporting Person upon vesting.
