

Item 8.01 Other Events.

On June 25, 2012, Raptor Pharmaceutical Corp., a Delaware corporation (the "Company"), issued a press release announcing that the dosing of a first patient in its Phase 2b juvenile clinical trial evaluating the safety and potential efficacy of RP103 as a potential treatment of non-alcoholic steatohepatitis, an advanced form of non-alcoholic fatty liver disease. RP103 is the Company's proprietary delayed-release microbead formulation of cysteamine bitartrate.
