On October 30, 2014, the following frequently asked questions were posted on Cleco Corporation's intranet and available for all employees.

Will there be a hiring freeze or pay freeze until all sales are final?

Managers will continue to make hiring and pay decisions during the months preceding the transaction closing. The merger agreement provides that the Company can increase compensation, salary and wage benefits of its non-executive employees as it normally would in the ordinary course of business, subject to certain restrictions. The merger agreement also provides for the hiring of employees in the ordinary course of business within certain limits.

It appears there are law firms investigating the Cleco board for not considering other options and undervaluing the company. Are these legitimate claims or are these commonly associated with M&As?

It is not unusual for these types of investigations to be announced after an acquisition of a public company is announced.

Will Cleco be offering any type of advisory assistance on what our options are for our Cleco stock? Not for specific investments, but generally what options might exist to avoid excessive taxes.

Cleco will provide education classes to help you understand certain questions to ask your tax advisor. However, Cleco is unable to offer any type of tax advisory assistance.

What percentage of the total board member count will the Louisiana members hold? Will the total board member count change?

We will provide more details on the board of directors during the coming months as we move toward the transaction's closing. We do know that at least four members will be Louisiana residents including the Chair.

It has been clearly communicated that the new partners plan on leaving the current Cleco structure in place. However, will there be opportunities in the future for movement between Cleco and the other infrastructure companies? For instance - if a Cleco employee was interested in working for Puget Energy would they have the opportunity? Any rotation of employees among the companies planned?

Cleco will continue to operate as a standalone utility with existing local management, with its brand and identity secured. The other utilities owned by MIRA and bcIMC have separate ownership groups and no operational overlap or sharing between these utilities and Cleco is expected.

Transition teams were mentioned during the communication process. What will be the makeup of the teams (Internal Cleco people, external consultants, Macquarie people)?

At this point, the plan for a transition team is under review. We will communicate with employees as appropriate when we learn more.

Has the Company contemplated how the EIP will be structured post-acquisition? In particular, the Company used a ROIC to determine the earnings based portion of the plan. Does the Partners contribution replace the stock based portion of the ROIC?

For 2015, we may need to adjust the metrics of the Pay for Performance Plan as a result of the transaction. As we move toward the transaction's closing, we will have more information regarding the new metrics. The metrics used under the PFP will be reviewed for periods after closing.
