Explanatory Note

Charter Communications, Inc. (the "Company") is filing this amendment (this "Amendment") to its Current Report on Form 8-K dated September 3, 2003, including the exhibits, originally furnished to the Securities and Exchange Commission (the "Commission") on September 3, 2003 solely to correct an error in the purchase agreement included in the Current Report on Form 8-K dated September 3, 2003 filed for the Company's subsidiaries Charter Communications Holdings, LLC and Charter Communications Holdings Capital Corporation.
