**MTS COMPLETES ACQUISITION OF GORIZONT RT**

**Moscow, Russian Federation December 14, 2004 Mobile TeleSystems OJSC ( MTS - NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that it has completed the previously announced transaction to acquire Gorizont RT, a GSM mobile phone operator in the Republic of Sakha (Yakutia) in the Far East of Russia.**

MTS has completed the acquisition of a 76% stake in Gorizont RT after winning a government privatization tender in November 2004 with a bid of approximately \$52.2 million (as was announced on November 19, 2004).

Gorizont RT is the sole mobile services provider in the Republic of Sakha (Yakutia), a region in the Russian Far East with a population of 949.3 thousand. The company provides services to 100 thousand subscribers. Mobile penetration in the region is at 10.5%, substantially lower than Russia's average penetration of 45.2% as of November 30, 2004\*.
