**DEREGISTRATION OF SECURITIES**

On December 21, 1999, Lattice Semiconductor Corporation (the Company ) filed with the Securities and Exchange Commission (the Commission ) a registration statement on Form S-3 (No. 333-93289) (the Registration Statement ) which registered for resale 220,200 shares of its common stock (as adjusted for subsequent stock splits) issuable to Bain & Company, Inc. ( Bain ) upon exercise of a warrant (the Warrant ) granted to Bain in connection with consulting services provided to the Company.

In accordance with the undertaking contained in the Registration Statement pursuant to Item 512(a)(3) of Regulation S-K, the Company respectfully requests that the Commission remove from registration a total of 220,200 shares of its common stock that remain unsold under the Registration Statement. The Company is requesting the removal from registration of these shares because the Warrant expired prior to being exercised.

Accordingly, the Company hereby de-registers 220,200 shares of its common stock registered pursuant to the Registration Statement remaining unsold thereunder.
