On September 11, 2003, Exact Sciences Corporation (the Company) filed a registration statement on Form S-3 (Registration No. 333-108679), as amended to date (the Registration Statement), to register \$100,000,000 in aggregate maximum offering price of the Company's common stock, preferred stock, debt securities and warrants to be offered by the Company from time to time. Pursuant to the Registration Statement, the Company has offered and sold an aggregate of 6,900,000 shares of the Company's common stock having an aggregate offering price of \$46,575,000. The Company is filing this post-effective amendment No. 1 to deregister all of the securities that remain unsold under the Registration Statement.
