<b>Public offering price</b>	\$9.75 per share.
<b>Net proceeds to Pacira</b>	\$54.6 million (or approximately \$62.9 million if the underwriters exercise their option to purchase additional shares from us in full), after deducting underwriting discounts and commissions and estimated offering expenses payable by us.
<b>Dilution</b>	Based on the public offering price of \$9.75 per share and after giving effect to the sale of common stock in this offering, our as adjusted net tangible book value would have been \$97.7 million, or \$3.12 per share, as of December 31, 2011. This represents an immediate increase in net tangible book value to existing stockholders of \$1.42 per share and an immediate dilution in net tangible book value of \$6.63 per share to investors purchasing in this offering at the public offering price.
