### Item 8.01 Other Events.

On February 24, 2015, Kimberly-Clark Corporation (the Corporation ) entered into an Underwriting Agreement (the Underwriting Agreement ) with Citigroup Global Markets Inc., Deutsche Bank Securities Inc., J.P. Morgan Securities LLC and Morgan Stanley & Co. LLC, as representatives for the several underwriters named therein, for the issuance and sale by the Corporation of \$250,000,000 aggregate principal amount of 1.850% Notes due March 1, 2020 (the 2020 Notes ) and \$250,000,000 aggregate principal amount of 2.650% Notes due March 1, 2025 (together with the 2020 Notes, the Notes ). The Notes were registered under the Securities Act of 1933, as amended, pursuant to the Corporation s registration statement on Form S-3 (File No. 333-189633) filed on June 27, 2013.

A copy of the Underwriting Agreement is attached hereto as Exhibit 1.1. Forms of the Notes are attached hereto as Exhibits 4.1 and 4.2.
