Shares of common stock acquired as a result of the elective stock dividend paid on September 17, 2010. Shareholders elected, pursuant to the terms of the Prospectus Supplement filed August 10, 2010 ("Supplement"), to receive the dividend in all or partial stock. If all stock (1) was elected, shareholders received their entire dividend in stock. If partial stock was elected, shareholders received approximately \$0.04798 of the \$0.09 dividend in stock. The value of the shares distributed is \$6.95 per share which were valued at the average closing price on September 7, 8 and 9, 2010 pursuant to the terms of the Supplement.

(2) Shares held by a limited partnership in which the partners are a limited liability company and a charitable lead annuity trust. The LLC members include the reporting person, the reporting person's wife and the reporting person's daughter.
