 - (2) This total includes 1,050.68 units of phantom stock granted under the PG&E Corporation Non-Employee Director Stock Incentive Plan (SIP), and reflects the acquisition of 11.42 units of phantom stock on 1/15/13 and 10.12 units of phantom stock on 4/15/13 pursuant to a

- (4) The option vested in three equal installments of 1,679 shares each on 1/2/2006, 1/2/2007, and 1/2/2008.
