On February 22, 2014, 10,131 of the originally granted restricted stock units vested,

On February 23, 2014, the remaining 6,664 shares of the originally granted restricted stock award vested, of which 2,156 shares were withheld in order to satisfy the Reporting Person's tax withholding obligations.
