On February 18, 2017, 4,086 shares of the originally granted RSAs vested, of which 2,040 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
