# Item 2.03 Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant.

On May 29, 2008, Potash Corporation of Saskatchewan Inc. ( PotashCorp ) entered into a 364-day revolving credit facility (the Credit Facility ) with the lenders named therein and The Bank of Nova Scotia, as agent. The Credit Facility provides for unsecured borrowings by PotashCorp in an aggregate principal amount of up to \$750 million. PotashCorp may, subject to certain conditions, increase its total borrowing capacity under the Credit Facility to up to \$2.0 billion. Interest on borrowings under the Credit Facility will be based on the interest rates specified therein.

The Credit Facility contains customary representations and warranties and covenants. Principal covenants under the Credit Facility require a debt-to-capital ratio of less than or equal to 0.60 to 1, a long-term debt-to-EBITDA (defined in the Credit Facility as earnings before interest, income taxes, provincial mining and other taxes, depreciation, amortization and other non-cash expenses, and unrealized gains and losses in respect of hedging instruments) ratio of less than or equal to 3.5 to 1, tangible net worth greater than or equal to \$1.25 billion and debt of subsidiaries not to exceed \$650.0 million.

The Credit Facility also contains customary events of default, including, but not limited to, the failure to pay amounts due under the Credit Facility, insolvency or bankruptcy, materially incorrect representations or warranties, the failure to perform certain covenants and the non-payment of other debt in excess of Cdn \$40.0 million. If an event of default occurs, then, to the extent permitted in the Credit Facility, the entire principal amount of all borrowings under the Credit Facility and accrued and unpaid interest thereon may be declared to be due and payable.

The foregoing description is qualified in its entirety by reference to the Credit Facility, which is attached hereto as Exhibit 4(a) and incorporated herein by reference.

PotashCorp plans to use the proceeds from the Credit Facility for working capital and other general corporate purposes.

Some of the lenders under the Credit Facility have in the past performed, and may in the future perform, investment banking, financial advisory, lending or commercial banking services, or other services for PotashCorp and its subsidiaries, for which they have received, and may in the future receive, customary fees.
