This report reflects (on Table I) (i) the acquisition of 18,345 shares of Class C Non-Voting Common Stock through two partial exercises of a previously partially exercised employee stock option acquired by the reporting person in June 2000 pursuant to former Rule 16b-3;
(1) (ii) the sale of 18,345 shares of Class C Stock in two separate transactions; and (iii) the transfer to the Issuer of 1,403 shares of Class C Stock as payment of tax liability; and (on Table II) the partial closing of the June 2000 employee stock option.
