- (1) 10,000 of the restricted shares will vest over a four year period beginning May 24, 2010 at the rate of 25% per year. Mr. Glowacki would need to be an employee on the dates of such grants, and through the resulting vesting schedules. The grant vesting schedules would accelerate upon a change of control in the Company.
