(1) High River Limited Partnership ("High River") directly beneficially owns 6,132,398 Shares, Icahn Partners LP ("Icahn Partners") directly beneficially owns 9,071,470 Shares, Icahn Partners Master Fund LP ("Icahn Master") directly beneficially owns 9,905,159 Shares, Icahn Partners Master Fund II LP ("Icahn Master II") directly beneficially owns 3,852,960 Shares, and Icahn Partners Master Fund III LP ("Icahn Master III") directly beneficially owns 1,700,018 Shares.
(2) Barberry Corp. ("Barberry"), is the sole member of Hopper Investments LLC ("Hopper"), which is the general partner of High River. Beckton Corp.
