Thus the reporting person will receive 7,338 shares of common stock of the issuer (or cash equal to the value of the common stock on the settlement dates, in the sole discretion of the issuer) on each of December 11, 2014, 2015 and 2016 as long as the reporting person remains affiliated with the company.
