- (2) The Reporting Person is a trust that has received the shares of Class B Common Stock reported herein as a contribution from another trust. No consideration was paid in connection with the contribution, which represents a "permitted transfer" as defined in the Issuer's Amended and Restated Certificate of Incorporation. The Reporting Person has executed a joinder to and become subject to the provisions of the Amended and Restated Global Hyatt Agreement. Accordingly, immediately following such contribution, the shares remained shares of Class B Common Stock.
