This Schedule 13G is being jointly filed by Citadel Advisors LLC ("Citadel Advisors"), Citadel Advisors Holdings LP ("CAH"), Citadel Investment Group II, L.L.C. Mr. Griffin is the President and Chief Executive Officer of, and owns a controlling interest in, CIG-II.
