(1) Due to his control of and ownership interest in GCOP LLC ("GCOP"), which previously owned 955,895.779 shares of Common Stock of the Issuer, Mr. Golub could have been viewed as having investment power over all of the shares owned by such entity. On February 14, 2017, GCOP sold all of its shares to Golub Capital Employee Grant Program Rabbi Trust at \$18.52 per share for the purpose of awarding incentive compensation to employees of Golub Capital LLC and its affiliates.
