(“Sourcefire” or the “Company”) announced on March 22, 2007 that the underwriters of its recent initial public offering (the “Offering”) have exercised in full their over-allotment option, which closed on March 21, 2007, to purchase an additional 865,500 shares of Sourcefire common stock, bringing the total proceeds received by Sourcefire in the Offering to approximately \$86.3 million.
