Following the immediate report filed by the Company yesterday, June 3, 2012, (reference number 2012-01-144750; hereby incorporated by reference) with respect to advanced negotiations for a transaction between the Company, the Company's controlling Shareholder, Suny Electronics Ltd. ("Suny") and the Hutchison Group from Hong-Kong, the Company hereby clarifies that the negotiations are progressing and the Company estimates that an agreement will be signed in the next few hours. The formulated layout is planned to include tender offers of the Company's and Suny's straight bonds and the sale of Suny's shares in Scailex to the Hutchison Group. These shares secure Suny's debentures.

As mentioned in the report from yesterday, as of this immediate report a binding agreement has not yet been signed and there is no certainty that such an agreement will be signed. By the opening of the trade tomorrow, the Company will report whether an agreement has been signed or not.
