- (1) Mack-Cali Realty Corporation (the "Corporation") common stock, par value \$0.01 per share (the "Common Stock"), or cash equal to the fair market value of a share of Common Stock at the time of the redemption. The Corporation has the option to deliver shares of Common Stock in exchange for all or any portion of the cash requested.
  - (2) On December 13, 2006, the reporting person donated 25,000 Common Units to the David and Sondra Mack Foundation, Inc. (the "Foundation"), a charitable foundation of which the reporting person is a trustee. Pursuant to Rule 13d-4, the reporting person disclaims beneficial ownership of all of the Common Units held by the Foundation.
  - (3) The right to convert Common Units is not subject to expiration.
  - (4) Reported amount excludes the following securities directly beneficially owned by the reporting person: (i) 2,046,808 phantom stock units and (ii) options to purchase 5,000 shares of Common Stock. Also excludes the 175,000 Common Units held by the Foundation. Pursuant
