## Explanation of Responses:

(1) The shares acquired represent the vesting and automatic settlement of 2894 of reporting person's restricted stock units on September 1, 2015.

(2) Represents shares withheld in connection with the payment of withholding taxes due on vesting and settlement of restricted stock units.

(3) The shares acquired represent the vesting and automatic settlement of 2891 of reporting person's restricted stock units on September 1, 2015.

(4) The shares acquired represent the vesting and automatic settlement of 1141 of reporting person's performance restricted stock units on September 1, 2015.

(5) Each restricted stock unit represents a contingent right to receive one share of Boingo Wireless, Inc. common stock.

The restricted stock units will vest in a series of twelve successive equal quarterly installments beginning on March 1, 2014, so that the restricted stock units will become fully vested on March 1, 2017. The restricted stock units will be settled in shares of common stock that will be delivered to the Reporting Person shortly after each vesting date.

(7) The restricted stock units will vest in twelve successive equal quarterly installments beginning on March 1, 2015, so that the restricted stock units will become fully vested on March 1, 2018. The restricted stock units will be settled in shares of common stock that will be delivered to the Reporting Person shortly after each vesting date.

This transaction reflects, with respect to the number of shares reported, achievement of the fiscal year 2014 performance goals applicable to the Reporting Person's fiscal year 2014 performance restricted stock unit award. Of these performance restricted stock units, 1/3 will vest on March 1, 2015 and the balance will vest in a series of eight successive equal quarterly installments thereafter, so that the performance restricted stock units will become fully vested on March 1, 2017. The performance restricted stock units will be settled in shares of common stock that will be delivered to the Reporting Person shortly after each vesting date.
