- (1) As of September 12, 2005, I have 1,199.0904 equivalent shares of stock in Questar's Employee Investment Plan. The number of equivalent shares will fluctuate as Questar's stock price changes; this fluctuation does not reflect any transactions that should be reported.
- (2) Phantom stock units will be converted to cash beginning at retirement; my retirement date is unknown.
- (3) I also receive phantom stock units as a result of my participation in an excess benefit plan. This total includes 12,496.0017 units in such plan, in addition to units held through my account balance in a deferred compensation plan. I also receive dividends.
- (4) The question about dates is irrelevant since I am not reporting any changes in my stock options.
- (5) As previously reported, the options granted in February of 2002 and February of 2003 vest in four equal annual installments beginning six months after grant. My total reported includes installments of my 2002, and 2003 options that vested since the date of the last report.
