- (1) On September 19, 2006, Mr. Kirloskar received a grant of restricted stock units ("RSUs") covering 8,000 shares of KLA-Tencor Corporation common stock. On September 19, 2008, Mr. Kirloskar vested in fifty percent (50%) of such RSUs.
- (2) Pursuant to the terms of the September 19, 2006 RSU grant, 1,430 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding.
