The option was exercised with respect to the 4,073 shares that vested on July 30, 2010.

- (3) The option, representing a right to purchase a total of 3,992 shares (as of the grant date) at an exercise price equal to \$9.92 per share, vested as to 25% of the underlying shares on June 1, 2010, and will vest as to an additional 25% on each of June 1, 2011, June 1, 2012 and June 1, 2013, subject to continuous employment with the Company. The option was exercised with respect to the 998 shares that vested on June 1, 2010.
