(1) Restricted units granted under the Inergy, L.P. Long Term Incentive Plan, as amended. The restricted units vest in four installments as follows: 25% of the restricted units vest on the 2nd anniversary of the grant date, 25% of the restricted units vest on the 3rd anniversary of the grant date, 25% of the restricted units vest on the 4th anniversary of the grant date, and the remaining 25% of the restricted units vest on the 5th anniversary of the grant date.

(2) The option vests in three installments as follows: 25% of the option vests on the 3rd anniversary of the grant date; 25% of the option vests on the 4th anniversary of the grant date; and the remaining 50% of the option vests on the 5th anniversary of the grant date.
