Unilever NV also announces that 19,638 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 89,926,516 Unilever NV ordinary shares in treasury, and has 1,624,801,184 Unilever NV ordinary shares in issue (excluding treasury shares).
