Unilever NV announces that on 12 December 2007 it purchased 746,432 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 23.915 and euro 24.500 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 148,294 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, hold 118,786,921 Unilever NV ordinary shares in treasury and has 1,595,940,779 ordinary NV shares in circulation.
