ENHANCED CAPITAL NOTES - HEARING LISTED FOR DECLARATORY JUDGMENT

Further to the RNS dated 31 March 2015, a declaratory judgment in respect of the interpretation of certain terms of the Enhanced Capital Notes (ECNs) will be handed down today at the Chancery Division of the High Court of Justice.

To ensure that market participants are in possession of the decision (whatever the outcome) before making an investment decision in the respect of the ECNs, the Group believes it is appropriate to request that the Financial Conduct Authority temporarily suspend the ECNs from the Official List (effective immediately) until the outcome of the hearing has been announced to the market.

The Group intends to update the market once the outcome of the Court decision is known.
