**Mitsui Invests in NPF-Harmony Limited Partnership**

Mitsui & Co., Ltd. ( Mitsui ) announces today that it has invested in NPF-Harmony Toshi Jigyuu Yugen Sekinin Kumiai ( NPF Fund ), a limited partnership in which Nomura Principal Finance Co., Ltd. ( NPF ) is a general partner. Mitsui invested 10 billion yen for 1,000 units, or approximately 9.3% of the fund as a limited partner. NPF Fund was established in order to acquire the 63.33% share of SNC Investment Co., Ltd. ( SNC ) held by NPF. SNC, as a result of Tender Offer completed on July 10, 2006, acquired 94.38% of the voting shares of Skylark Co., Ltd. Through this financial investment in NPF Fund, Mitsui expects to realize gains from the sale of SNC shares by NPF Fund in the future.
