On December 3, 2011, SAP AG, a stock corporation organized under the laws of Germany (**SAP**), and SuccessFactors, Inc., a Delaware corporation (**SuccessFactors**), issued a joint press release (the **Press Release**) announcing the entry into a definitive Agreement and Plan of Merger dated as of December 3, 2011 among SuccessFactors, SAP America, Inc. (**SAP America**), a wholly owned subsidiary of SAP, and Saturn Expansion Corporation (**Merger Sub**), a wholly owned subsidiary of SAP America, pursuant to which Merger Sub will make an offer to purchase all outstanding shares of common stock of SuccessFactors for \$40.00 per share in cash. The Press Release is attached as Exhibit 99.1 hereto and incorporated by reference herein.

Any statements contained in this document that are not historical facts are forward-looking statements as defined in the U.S. Private Securities Litigation Reform Act of 1995. Neither SAP nor SuccessFactors is obligated to update these forward-looking statements to reflect events or circumstances after the date of this document. Readers are cautioned not to place undue reliance on these forward-looking statements, which speak only as of their dates.
