## DEREGISTRATION OF SECURITIES

Intermec, Inc. (the Company) is filing this post-effective amendment to deregister certain securities originally registered by the Company pursuant to the Registration Statement on Form S-8 (File No. 333-67610), filed with the Securities and Exchange Commission (the SEC) on August 15, 2001 (the Registration Statement) with respect to 1,000,000 shares of the Registrant's common stock, par value \$0.01 per share (the Company Common Stock), registered for issuance under the Registrant's 2001 Stock Incentive Plan. Such Registration Statement was subsequently amended by Post-Effective Amendment No. 3 to the Registration Statement, filed with the SEC on February 28, 2012 (File No. 333-67610), and Post-Effective Amendment No. 2 to the Registration Statement, filed with the SEC on June 4, 2008 (File No. 333-67610), both of which deregistered certain securities previously registered by the Company pursuant to the Registration Statement, and Post-Effective Amendment No. 1 to the Registration Statement, filed with the SEC on August 17, 2001 (File No. 333-67610).

Effective as of September 17, 2013, as contemplated by the Agreement and Plan of Merger, dated as of December 9, 2012, by and among the Company, Honeywell International Inc. (Honeywell), and Hawkeye Merger Sub Corp. (Merger Sub), a wholly owned subsidiary of Honeywell (the Merger Agreement), Merger Sub merged with and into the Company, with the Company surviving as a wholly owned subsidiary of Honeywell (such transaction, the Merger).

As part of the Merger, the Company has terminated all offerings of Company Common Stock pursuant to existing registration statements, including the Registration Statement, as amended. In accordance with the undertakings made by the Company in the Registration Statement to remove from registration, by means of a post-effective amendment, any shares of Company Common Stock that remain unsold at the termination of the offering, the Company hereby removes from registration, by means of this Post-Effective Amendment No. 4 to the Registration Statement, all shares of Company Common Stock registered under the Registration Statement, as amended, that remain unsold as of the effectiveness of the Merger.
