Item 5.07. Submission of Matters to a Vote of Security Holders.

Sabine Royalty Trust (the Trust) held a special meeting of its unit holders on Thursday, May 22, 2014, at 1:00 p.m. central time at The City Club, 901 Main Street, Suite 6900, Dallas, Texas 75202 (the Special Meeting).

At the Special Meeting, unit holders of the Trust were asked to consider and vote upon (i) the appointment of Southwest Bank as successor trustee of the Trust, (ii) an amendment to the Sabine Royalty Trust Agreement dated December 31, 1982 (the Trust Agreement) that would permit a bank other than a national bank to serve as trustee of the Trust, and (iii) to approve certain other amendments to the Trust Agreement, as more fully described in the definitive proxy statement filed by the Trust with the Securities Exchange Commission on March 31, 2014, as amended.

Of the 14,579,345 units outstanding and entitled to vote as of the record date for the Special Meeting, 8,082,867 units were present at the Special Meeting in person or by proxy. As such, a quorum was established at the Special Meeting.

The proposals voted on by the unit holders at the Special Meeting and the voting results are set forth below.

1. Proposal to approve the appointment of Southwest Bank as successor trustee to serve as trustee of the Trust once the resignation of Bank of America, N.A., the current Trustee of the Trust, takes effect, was approved by the following vote:
