**It is anticipated that the registrant will report a net loss of approximately \$1.71 million for the fiscal year ended December 31, 2014 compared to a net income of approximately \$1.46 million for the prior fiscal year, a decrease of approximately \$3.17 million. The primary reasons for this decrease were due to a \$1.87 million increase in selling, general and administrative expenses and a reduction in other income due to the fact that in 2013 other income included a \$1.36 million gain on the dilutive effect on medical joint venture stock issuance.**
