## Section 1 Registrant's Business and Operations

### Item 1.01. Entry into a Material Definitive Agreement.

On March 3, 2016, Callon Petroleum Company (the Company) entered into an underwriting agreement (the Underwriting Agreement) with Credit Suisse Securities (USA) LLC and J.P. Morgan Securities LLC (collectively, the Underwriters), providing for the offer and sale in a firm commitment offering of 13,265,000 shares of the Company's common stock, par value \$0.01 per share (the Common Stock), at a public offering price of \$6.50 per share of Common Stock. Pursuant to the Underwriting Agreement, the Company granted the Underwriters a 30-day option to purchase up to 1,985,000 additional shares of Common Stock at the same price. The offer and sale of the Common Stock is registered under the Securities Act of 1933, as amended (the Securities Act), pursuant to a Registration Statement on Form S-3 (File No. 333-202038), which was declared effective by the Securities and Exchange Commission on February 23, 2015. The Company expects the transaction to close on or about March 9, 2016.

In the Underwriting Agreement, the Company agreed to indemnify the Underwriters against certain liabilities, including liabilities under the Securities Act, or to contribute to payments the Underwriters may be required to make because of any of those liabilities. The foregoing description of the Underwriting Agreement is qualified by reference to the complete document, which is filed as Exhibit 1.1 to this Form 8-K and is incorporated herein by reference.
